1. Description of the Plan

General

The Precision Service Group Inc 401(k) Savings Plan] (the "Plan") is a defined contribution plan established by Precision Service Group Inc (the "Company") to provide retirement benefits to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

Eligibility

Employees are eligible to participate in the Plan after meeting certain age and service requirements, as defined in the Plan document. Eligible employees may participate in the Plan upon reaching the age of 18.

Contributions

Participants may elect to defer a portion of their compensation into the Plan, subject to limits imposed by the Internal Revenue Service (IRS). The Company may make matching contributions based on participant deferrals and may also make discretionary profit-sharing contributions. Contributions are allocated to participant accounts as follows:

-Participant Contributions: Participants may contribute 100% of eligible compensation on a pre-tax basis, subject to IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings. The benefit to which a participant is entitled is the value of the participant's vested account.

Vesting

Participants are immediately vested in their contributions. Company contributions vest based on years of service. The vesting schedule for Company contributions is as follows:

- 20% after 1 year of service
- 40% after 2 years of service
- 60% after 3 years of service
- 80% after 4 years of service
- 100% after 5 years of service

**Investment Options**

Participants may direct the investment of their account balances among the Plan's available investment options, which include mutual funds, collective trusts, and employer stock. Investment options are chosen by the Plan Administrator and offer a variety of risk and return profiles.

**Payment of Benefits**

Upon termination of service, participants are entitled to receive the vested balance of their accounts in the form of a lump-sum distribution, installment payments, or annuity options. Withdrawals are also available for hardship or after reaching the age of 59½, subject to Plan and IRS guidelines.

**Forfeitures**

Forfeitures of non-vested employer contributions may be used to reduce future employer contributions or pay Plan expenses. At [year-end date], forfeitures available totaled \$[amount].

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, income, and expenses, as well as disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is determined based on quoted market prices, if available. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Changes in the fair value of investments are recognized as net appreciation (depreciation) in the fair value of investments in the accompanying statement of changes in net assets available for benefits.

**Notes Receivable from Participants**

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted loans are reclassified as distributions based on the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

3. Fair Value Measurements

The Plan's assets are measured at fair value, and the fair value hierarchy prioritizes the inputs used in valuations:

- Level 1: Quoted prices in active markets for identical assets or liabilities
- Level 2: Inputs other than quoted prices that are observable for the asset or liability
- Level 3: Unobservable inputs for the asset or liability

As of December 31, 2023, the Plan's investments measured at fair value are categorized as follows:

5. Related-Party and Party-in-Interest Transactions

The Plan invests in shares of mutual funds and employer stock managed by the trustee. Transactions involving these investments qualify as party-in-interest transactions under ERISA. All transactions are made at fair value as of the date of the transaction.

Fees paid by the Plan for investment management services amounted to \$6,558 for the year ended December 31, 2023.

6. Plan Termination

As of December 31, 2023 the Company has terminated the Plan. All participants received a check for the account balance of their accounts.

7. Tax Status

The Plan has received a favorable determination letter from the IRS, stating that the Plan qualifies under Section 401(a) of the Internal Revenue Code and, as such, is exempt from federal income taxes. Management believes the Plan is currently designed and operated in compliance with applicable IRS regulations.
