Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Beacon IMG 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan was established on August 1, 2021 and restated as of May 27, 2022, and is a defined contribution plan covering employees of Beacon IMG, Inc.; Southpark Hotel, LLC; CH Hotel, LLC; Charlotte HP, LLC; Riverside Hotel, LLC and Claremont Partners, LLC (collectively the “Sponsor”, “Company” or “Employer”). The plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Sponsor is responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitors investment performance.

Some administrative functions were performed by employees of the Company. No compensation was remitted to the Company for these services.

Plan assets were held and managed by Reliance Trust Company, who invested contributions and Plan earnings, made investment transactions as directed by Plan management and provided certain recordkeeping services. Automatic Data Processing (“ADP”) acted as the third-party administrator and recordkeeper for the Plan and performed certain plan administration and annual ERISA compliance testing.

Eligibility

Employees who are not a non-resident alien or a resident of Puerto Rico may become a participant of the Plan when they are age eighteen or older. An eligible employee may enter the plan on the first day of the month after all entry requirements have been met.

Contributions

Each year, participants may contribute up to the lesser of 90% of eligible compensation as defined by the Plan or the maximum amount allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The plan provides for an auto enrollment function whereby all eligible employees are auto enrolled in the plan at the conclusion of the notice period unless an election is made to decline participation in the plan. Auto-enrolled participants are enrolled at a 3% eligible compensation deferral rate.

Notes to Financial Statements

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

The Company may also contribute discretionary matching contributions and discretionary non-elective contributions. The Company contributed a discretionary matching contribution equal to 100% of the first 3% of participant salary deferrals for the years ended December 31, 2023 and 2022. No discretionary non-elective contributions have been made since the plan's inception. The Company's discretionary matching contributions for 2023 and 2022 were fully funded prior to the date the financial statements were available to be issued and plan management has determined that no allowance for credit losses on uncollectable amounts were deemed necessary.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, employer contributions and an allocation of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in discretionary employer matching contributions and discretionary non-elective contributions is based on years of continuous service. A participant is 50% vested after one year of continuous service and 100% vested after two years of continuous service. Participants become 100% vested upon death or total and permanent disability and at the attainment of age 65.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined in the plan document. Principal and interest is paid ratable through recurring payroll deductions.

Benefit Payments

Benefit payments may generally be made to a participant upon the participant's retirement, death, disability, termination of employment, attainment of age 59 1/2, or upon incurring a financial hardship. Normal retirement age is 65. Benefits shall be paid to participants in an amount equal to the value of the participant's vested interest in his or her account in a single lump sum.

Notes to Financial Statements

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience severe financial hardship. The participant must meet the condition that they cannot relieve the amount of the need by stopping the elective contributions to the Plan. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Forfeitures

Forfeitures are used to reduce employer contributions and to pay plan expenses. As of December 31, 2022 forfeited non-vested unallocated accounts totaled approximately \$3,900. There were no forfeited non-vested unallocated accounts as of December 31, 2023. Approximately \$4,100 of forfeitures were used to reduce employer contributions during 2023.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments generally are reported at fair value but may also be reported at net asset value (NAV) or contract value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV. The Plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's custodian.

The plan holds an interest in a common collective trust (CCT) which invests primarily in synthetic guaranteed investment contracts and plan management has determined its interest in the CCT is fully benefit-responsive and is reported at contract value. See Note 5 for further information on the contract value of this investment.

Notes to Financial Statements

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses were deemed necessary as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contribution liabilities as of December 31, 2023 or 2022.

Payment of benefits

Distributions to participants are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to participant directed transactions are charged directly to participants' accounts and are included in administrative expenses. During the year ended December 31, 2023, approximately \$4,750 of administrative expenses were charged and allocated to participant accounts.

Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risks associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Plan Merger

Effective December 29, 2023, all of the plan's assets were transferred into and the Plan was merged into the Choice Pooled Employer Plan I. The transfer has been recognized as transfer out to other plan on the statement of changes in net assets available for benefits for the year ended December 31, 2023.

Subsequent events

The Plan has evaluated subsequent events through October 8, 2024, the date the financial statements were available to be issued.

NOTE 3: INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements has been derived from information certified to be complete and accurate by Reliance Trust Company, the qualified institution, under such regulation:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2023 and 2022.
- b) Total investments, at contract value, included in the statements of net assets available for benefits at December 31, 2023 and 2022.
- c) Notes receivable from participants included in the statements of net assets available for benefits at December 31, 2023 and 2022.
- d) Investment income information included in the statement of changes in net assets available for benefits for the year ended December 31, 2023.
- e) Net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2023.
- f) All amounts included in Note 4, Fair Value Measurements (Unaudited).
- g) All amounts included in Note 5, Fully Benefit-Responsive Investment (Unaudited).
- h) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2023.

NOTE 4: FAIR VALUE MEASUREMENTS (UNAUDITED)

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of input that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - Observable; or
 - Can be corroborated by observable market data.

NOTE 4: FAIR VALUE MEASUREMENTS (UNAUDITED) (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. There were no assets held as of December 31, 2023.

NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT (UNAUDITED)

The plan held an interest in a common collective trust fund, the Invesco Stable Value Trust, which invests primarily in synthetic guaranteed investment contracts. The plan held assets totaling \$4,839 in this fund at December 31, 2022. Approximately 95% of the assets held in the underlying trust fund are synthetic guaranteed investment contracts with the remaining held in short term investment funds.

Synthetic guaranteed investment contracts are portfolios of securities with wrap contracts associated with the portfolios. These investment contracts are carried at contract value which is equal to the principal balance plus accrued interest plus deposits and less withdrawals.

Issuances and redemptions of participant units are made on each business day (“Valuation Date”). As permitted under the Trust agreement, participant units are issued and redeemed based upon the net asset value per unit of the Trust at contract value, determined in accordance with the Trust agreement.

Participants may redeem their units in the common collective trust fund daily without a notice period. A participating trust is required to provide a 12 month irrevocable written notice of intent to redeem all or a portion of its participation in the Trust.

The holdings in this common collective trust fund meet the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investments because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

NOTE 6: TAX STATUS

The Plan uses a pre-approved plan document sponsored by ADP which received an opinion letter from the IRS dated October 6, 2020, that the pre-approved Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is “more likely than not” that the tax position would be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the “more likely than not” test, no tax position is recorded. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS:

ADP provides administrative and recordkeeping services to the Plan. Fees paid by the Plan for these administrative services totaled approximately \$4,750 during 2023.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Employer contributions.

NOTE 9: RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain amounts reported on Form 5500 differ from the financial statements as the Form 5500 is reported on a cash basis.
