Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Edward Don & Company Comprehensive Profit Sharing and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (on going), and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note F to the financial statements, the Plan Sponsor was acquired in 2023, and as a result, the Plan's Sponsor made the decision to terminate the Plan effective November 27, 2023. Accordingly, management has determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

NOTE A - DESCRIPTION OF THE PLAN

The following description of The Edward Don & Company Comprehensive Profit Sharing and Savings Plan (the Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution profit sharing and 401(k) plan covering eligible employees of Edward Don & Company, LLC, and participating employers IMCO, Inc., Atlanta Fixture & Sales Company, Inc., Smith & Greene Company, and Myers Restaurant Supply, LLC (collectively hereinafter referred to as the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As a result of the plan freeze and termination on November 27, 2023 (Note F), no new participants will be allowed to enter the Plan after that date.

a. Employee Deferrals and Discretionary Company Matching Contributions

Nonunion and certain union employees, except excluded employees as defined in the plan document, were eligible to make salary deferrals and receive discretionary Company matching contributions on the first of the month following 30 days of employment and completion of one hour of service.

Warehouse employees who are members of the International Brotherhood of Teamsters (IBT) Local 710 were eligible to make salary deferrals and receive discretionary Company matching contributions after completing 90 days of service.

b. Discretionary Company Profit Sharing Contributions

Nonunion and certain union employees, except excluded employees, as defined in the plan document, were eligible to receive discretionary Company profit sharing contributions if they were employed on the last day of the year and had completed one year of service.

c. Nonelective Company Plan Contributions

Driver employees who are members of IBT Local 710 were eligible to receive nonelective Company Plan contributions after completing 120 days of service.

c. Nonelective Company Plan Contributions (Continued)

Warehouse employees who are members of IBT Local 710 were eligible to receive nonelective Company Plan contributions after completing 1 year of service.

Employees who are members of IBT Local 63 were eligible to receive nonelective Company Plan contributions after completing 30 days of service.

2. Contributions

The Plan was funded by voluntary contributions of participants, discretionary matching and profit sharing, and required nonelective Company Plan contributions of the Company. Participants contributed to the Plan, through regular payroll deductions, and participants who attained age 50 before the end of the calendar year were eligible to make catch-up contributions. Participants could also roll over amounts representing distributions from other qualified employee benefit plans. The Company provided nonelective Company Plan contributions of \$513,226 and discretionary matching contributions of \$972,873 to the Plan for the year ended December 31, 2023. No profit sharing contributions were provided by the Company for the year ended December 31, 2023. Contributions were subject to certain IRS limitations. As a result of the plan freeze and termination on November 27, 2023 (Note F), no further contributions will be made to the plan after that date.

The Plan included an auto-enrollment provision whereby all newly eligible non-union employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. A participant could also elect a different deferral percentage. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

3. Investment Options

Participants were permitted to direct their salary deferral contributions and the Company's contributions into a variety of investment options made available and determined by the 401(k) Committee. Participants were able to change their investment options at any time.

4. Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions, and an allocation of plan earnings. The Company's discretionary matching contribution was allocated based on a percentage of the participant's contribution. The Company's discretionary profit sharing contribution was allocated as of the last day of the plan year and was based on a ratio of each participant's compensation to total compensation for all participants. The Company's nonelective Company Plan contribution was allocated as a flat dollar amount for each hour of service which was subject to a maximum number of hours of service. The hour of service, flat dollar amount, and maximum number of hours were determined by the applicable collective bargaining agreement.

Plan earnings are allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

5. Vesting

Participants were immediately fully vested in participant contributions, rollover contributions, and nonelective Company Plan contributions, plus the actual earnings thereon. The portion of the participants' accounts attributable to the Company's discretionary matching and profit sharing contributions became 100% vested after three years of service. In the event of death, disability, or retirement at designated ages, participants became fully vested. As a result of the plan freeze and termination on November 27, 2023 (Note F), participants became fully vested in all contributions.

6. Payment of Benefits

On termination of service, a participant was able to elect to a) receive a single, lump-sum payment equal to the value of his or her vested balance, b) make a partial withdrawal, c) elect substantially equal installments, or d) elect a direct rollover distribution. Hardship withdrawals and in-service withdrawals (once the participant reaches age 59 1/2) were also permitted by the Plan.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants were permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans were collateralized by the borrowers' respective vested account balances and bore interest at rates ranging from 4.25% to 10.50%. Principal and interest were paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence. As a result of the plan freeze and termination on November 27, 2023 (Note F), no new loans will be issued after that date.

8. Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and were excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments.

9. Forfeitures

At December 31, 2023 and 2022, unallocated plan assets resulting from forfeited nonvested accounts totaled \$2,800 and \$12,600, respectively. These accounts will be used to pay the Plan's administrative expenses. Forfeitures of \$70,478 were used during 2023 to reduce Company contributions related to the Plan year ended December 31, 2023.

10. SECURE 2.0 Act

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. No optional provisions have been adopted through the report date.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

As a result of the Plan termination, management determined that the liquidation of the Plan was imminent and the financial statements for December 31, 2023, have been prepared using the liquidation basis of accounting. The 2022 financial statements were prepared as a going concern (ongoing) on the accrual basis of accounting.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include the following:

- * Quoted prices for similar assets or liabilities in active markets;
- * Quoted prices for identical or similar assets or liabilities in inactive markets;
- * Inputs other than quoted prices that are observable for the asset or liability;
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Pooled separate accounts: Valued at net asset value (NAV) per unit as determined by the insurance company or contract administrator. Such NAV is based on the value of the underlying assets and liabilities of the account. Participants may transfer in and out of such trusts on a daily basis without any prohibitive restrictions.

Group annuity contracts: The group annuity contracts are not fully benefit-responsive contracts and are adjusted for possible market value adjustments and stated at estimated fair value as determined by the custodian. The fair values of the group annuity contracts are estimated by discounting the related cash flows based on current yields of similar instruments with comparable durations and credit quality.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee and Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note B-2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

5. Payment of Benefits

Benefits are recorded when paid.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Minnesota Life Insurance Company (the custodian of the Plan).

NOTE D - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a group annuity contract with Minnesota Life Insurance Company in its General Account. The group annuity contract is reported at fair value.

Minnesota Life Insurance Company guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rating is updated annually based upon contract provisions, and it may not be less than 1.00%. Minnesota Life Insurance Company's General Account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses.

The contract does not provide for any conditions or circumstances under which distributions from the contract would be payable at amounts below fair value, and participants may ordinarily direct the withdrawal or transfer all or a portion of their investments at fair value; however, certain transfer provisions in the contract dictate that withdrawal of the full contract amount may not be accessible from the General Account at one time. As a result, the contract is not considered fully benefit-responsive.

As a result of the aforementioned restrictions, settlement and final distribution of the Plans assets held in Minnesota Life Insurance Companys' General Account at December 31, 2023 are not immediately available and instead will be provided to Plan participants over a five year period, in accordance with the terms of the group annuity contract.

NOTE E - TAX STATUS

The Plan adopted a standardized pre-approved plan sponsored by Minnesota Life Insurance Company. The pre-approved plan has received an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PLAN FREEZE AND TERMINATION

During 2023, the Plan Sponsor was acquired by Sysco Corporation, and as a result, the Plan's Sponsor made the decision to freeze and terminate the Plan effective November 27, 2023. In December 2023, eligible Edward Don & Company, LLC employees were allowed to begin participating in the Sysco Corporation Employees' 401(k) Plan. Participants with balances in the Plan subsequently had the option to make direct rollover distributions to the Sysco Corporation Employees' 401(k) Plan, a qualifying individual IRA account, or other qualified rollover institution, or to receive cash out distribution. As described in Note D, the Plan's assets held in Minnesota Life Insurance Company's General Account through a group annuity contract have certain settlement and distribution restrictions, and as such, will be distributed to participants in installments through 2028.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Minnesota Life Insurance Company and The Standard, (formerly Securian Trust Company). Minnesota Life Insurance Company is the custodian and The Standard is the trustee and recordkeeper, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issued loans to participants, which are secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest. Employees of the Company provide administrative services to the Plan for which no fees are charged.

During 2023, the Plan Sponsor failed to deposit certain participant contributions and loan repayments within the required timeframe as stated by the DOL. The DOL considers late deposits to be prohibited transactions as disclosed in the accompanying supplemental information. The Plan Sponsor has self-corrected these deficiencies outside of the DOL's Voluntary Fiduciary Correction Program (VFCP).
