Independent Auditor's Report

Plan Administrator and Participants
Cardiovascular Provider Resources 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of the Cardiovascular Provider Resources 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the years then ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Cardiovascular Provider Resources 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by Cardiovascular Provider Resources, Inc. (the “Company”) under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company.

Substantially all employees of the Company, and its participating subsidiaries and affiliates, who have completed thirty days of service, as defined, are eligible to participate, provided they are at least 21 years of age. Employees must complete 30 days of service to receive employer matching contributions, provided they are at least 21 years of age. Employees must complete one year of service to receive employer profit sharing contributions, provided they are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Effective January 1, 2020, the Plan was amended to incorporate the “force-out” provision pursuant to an Internal Revenue Service rule. Upon retirement or termination of service, a participant will receive a lump-sum payment equal to the participant’s vested balance. The participant may elect to receive this payment directly or to be rolled into another plan or individual retirement account (“IRA”). The Plan has a force out for balances less than \$5,000 with two options for the distribution. Balances up to \$1,000 are a direct payment and balances of \$1,000 to \$5,000 are rolled into another plan or IRA unless otherwise elected for a lump-sum payment.

The Plan is administered by the 401(k) Savings Plan Committee (the “Plan Administrator”) which is appointed by the Company’s Chairman of the Board of Directors. The duties of the Plan Administrator are to oversee the operations and administration of the Plan in accordance with the specific terms of the Plan. The Plan’s trustee, Charles Schwab Bank (the “Trustee”), is responsible for the custody and management of the Plan’s assets. Milliman USA, Inc. is the Plan’s record keeper.

Contributions

Each year, participants may contribute up to 75% of annual compensation, as defined in the Plan. At the Participant’s election, these may be either “traditional” before-tax deferrals or “Roth” after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. New employees are automatically enrolled in the plan on the first day of the month coinciding with or next following the completion of 30 days of service and reaching age 21. Employees hired or rehired by the Company on or after July 1, 2019, are automatically enrolled upon meeting eligibility requirements with an automatic enrollment deferral percentage of 3% of pre-tax compensation. The Plan also includes an automatic escalation of the participant’s compensation deferral election by 1% on the anniversary of the participant’s hire date, up to 6% of compensation. This automatic escalation does not apply to physicians or to participants who have a salary reduction agreement in effect to defer at least 6% of compensation. The employee may change the deferral rate or elect not to contribute. Participants may also contribute amounts representing distributions from other eligible retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan also provides that the Company make matching contributions to each eligible Participant who voluntarily contributed to the Plan. Under this provision, the Company matched 25% of the Participant’s contribution up to 6.82% and 6.72% of the Participant’s eligible compensation in 2023 and 2022, respectively. Contributions are subject to certain limitations.

The Plan is a “Safe Harbor” Plan. The Company will make safe harbor profit sharing contributions to the Plan on behalf of all eligible, non-highly compensated employees equal to 3% of compensation. Compensation earned prior to eligibility for the profit sharing contribution is excluded. Non-highly compensated employees receive the 3% safe harbor profit sharing contribution once they satisfy the profit sharing eligibility requirements (one year of service and reaching age 21), even if they do not make 401(k) deferral contributions.

Contributions (Continued)

The Company may elect to make a discretionary (non-safe harbor) profit sharing contribution to the Plan in such amounts as its Board of Directors may determine. In order to receive a discretionary profit sharing contribution, the Participant must first meet the profit sharing eligibility requirements (one year of service and reaching age 21). The discretionary profit sharing contribution will be allocated based on a formula that takes into consideration compensation, age, and job classification. Participants must be actively employed on the last day of the Plan year to receive the discretionary profit sharing contribution. An exception applies if the Participant retires, becomes disabled, or dies during the Plan year. Forfeitures from a terminated Participant's profit sharing contribution account may be used to reduce employer contributions or may be used to pay Plan expenses in the Plan year such forfeitures occur.

Notes Receivable from Participants

The Plan does not allow loans to Participants.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching and profit sharing contributions, as well as the participant's share of investment income, appreciation (depreciation), and any related administrative expenses and distributions. The participant determines both the amount to be invested and the allocation of the investment to one or more of the investment alternatives. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant is automatically fully vested in their elective contributions, safe harbor profit sharing contributions, and rollover contributions plus actual earnings thereon. Participant vest in the employer matching and discretionary (non-safe harbor) profit sharing contributions in 20% annual increments beginning in year two and are 100% vested after six years of service. Additionally, full vesting occurs upon a participant's death, permanent disability, normal retirement date (age 65), or termination of the Plan. Participants who leave the Company before they are fully vested in the Company's contributions forfeit their non-vested portion.

Investment Options

Upon enrollment in the Plan, a participant will be invested in the Plan's default investment (an age-based risk portfolio) or may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds maintained by the Trustee, determined at the discretion of the participant and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution or a direct transfer to another qualified retirement plan subject to certain conditions, equal to the participant's vested account balance. In addition, hardship and in-service distributions are permitted if certain criteria are met. Hardship distributions are subject to meeting guidelines established by the Internal Revenue Service. If a participant's account balance does not exceed \$1,000, the Plan requires a mandatory distribution in the form of a lump-sum cash payment. If a participant's account balance exceeds \$1,000, but not more than \$5,000, the Plan requires a mandatory rollover to another Plan unless a participant elects to have this amount paid as a lump-sum distribution. Benefits are recorded when paid.

Forfeited Accounts

Forfeitures can be used to offset any future employer contributions, either profit sharing or matching, regardless of the source of the forfeiture, or may be used to pay Plan administrative expenses. At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$5,502 and \$107,127 respectively. For the years ended December 31, 2023 and 2022, forfeited non-vested accounts used to offset employer matching contributions and plan expenses totaled \$146,502 and \$105,699, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Adoption of New Accounting Pronouncement

Effective January 1, 2023, the Plan adopted the provisions of Financial Accounting Standards Board (“FASB”) Accounting Standards Update (“ASU”) 2016-13, *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*. Under the new guidance, the Plan is required to assess financial assets, or a group of financial assets measured at amortized cost, including participant and employer contribution receivables, to be presented at the net amount expected to be collected, less an allowance for credit loss expected to occur over the remaining life of the asset. The Plan adopted the new standard using a modified retrospective method. The adoption of the new standard did not have a material effect on the Plan’s financial statements.

Basis of Accounting and Use of Estimates

The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan’s management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Administrative Expenses

Administrative fees related directly to the net asset balance of the Plan’s investments are paid by the Plan. Fees related to benefits paid to participants are charged directly to the participant’s account and are included in administrative expenses. The remaining administrative expenses are paid by the Company. The Plan is under no obligation to reimburse the Company for these expenses. Plan expenses paid by the Company are not included in these financial statements. Management fees and operating expenses charged to the Plan for investments in the various mutual funds and common/collective trusts are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair values of such investments.

Investment Valuation and Income Recognition

Investments are stated at fair value. Changes in fair value are reflected in operations. Mutual funds and common/collective trusts represent investments with various investment managers. Mutual funds are valued at the net asset value of units held by the Plan at year-end. The net asset value is based on the market value of the underlying investments, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value at year-end. Purchases and sales of investments are recorded on the trade-date basis. Interest and other income are recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The net appreciation (depreciation) of investments includes realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year-end.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Risks and Uncertainties

The Plan provides for various investment securities with different investment strategies, which, in general, are exposed to various risks, such as interest rate, credit, foreign investment, active management, and overall market volatility risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. The Plan attempts to limit these risks by authorizing and offering participants a broad range of investment options that are invested in high quality securities or are offered and administered by reputable and known investment companies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Market conditions have resulted in an unusually high degree of volatility and increased the risks and may affect the short-term liquidity associated with certain investments held by the Plan which could impact the value of investments after the date of these financial statements. Because the values of individual investments fluctuate with market conditions, the amount of gains or losses that will be recognized in subsequent periods, if any, cannot be determined.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE (UNAUDITED)

The Plan Administrator has elected the method of compliance permitted by Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified to the completeness and accuracy of the following data reflected on the accompanying statements of net assets available for benefits, the supplemental Schedule of Assets (Held at End of Year), and the related investment activity reflected in the statements of changes in net assets available for benefits as of and for the years ended December 31:

4. PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions of the Plan are performed by an officer or employees of the Company. No such officer or employee receives compensation from the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

5. REPORTABLE TRANSACTIONS

During the years ended December 31, 2023 and 2022, there were no reportable transactions, investment assets acquired and disposed of within the Plan year, or non-exempt transactions with parties-in-interest which would require supplemental presentation under United States Department of Labor Rules and Regulations.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the IRC. The Plan provides for full and immediate vesting of all participant rights upon termination of the Plan.

7. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated September 20, 2023, stating that the Plan and related trust are designed in accordance with Section 401(a) of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

8. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the years ended December 31, 2023 and 2022, there were no significant transfers in or out of levels 1, 2, or 3.

8. FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022:

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end.

Common / collective trusts: Valued based on the NAV of units of the common collective trust held by the Plan at year-end. The NAV, as provided by the Custodian, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities, divided by the total number of units. The practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily at NAV. Each collective trust provides for redemptions by the Plan at reported net asset values per share, with little to no advance notice requirement. Plan management believes that no events are probable of occurring that might limit the ability of the Plan to transact at NAV with the common/collective trusts or that also limit the ability of the Plan to transact at NAV with the participants. The NAV is not a publicly quoted price in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. CHANGES IN PLAN OPERATIONS

Effective January 1, 2020, certain administrative defaults for the Plan were updated to be in accordance with final regulations of the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act of 2019. These changes included altering the age at which required minimum distributions must begin for participants. If a participant reached the age of 70 ½ prior to 2020, then the prior rule of age 70 ½ applies. If a participant reaches the age of 70 ½ during 2020 or later, that participant must now take his or her first required minimum distribution after reaching the age of 72. Formal amendments to the Plan document to reflect these operational changes will be executed prior to the deadline set forth by the SECURE Act, which is December 31, 2022 for calendar year-end plans. On August 3, 2022, the IRS announced in Notice 2022-33 that it is extending the deadline for amending a retirement plan to reflect the provisions of the SECURE Act. The extended deadline under this notice is December 31, 2025.
