Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the ArcaTech Systems Profit Sharing and Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTE 1: DESCRIPTION OF PLAN

The following description of the ArcaTech Systems Profit Sharing and Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

General

ArcaTech Systems, LLC (the “Company” or “Plan Sponsor”) established the Plan effective as of January 1, 2006. The Plan is a defined contribution plan covering substantially all employees of the Company. Employees are eligible to participate in the Plan for purposes of elective deferrals and matching contributions once they have completed two months of eligible service, provided the employee is 21 years of age or older. Employees are eligible to participate in discretionary nonelective employer contributions once they have completed one year of service, which is defined by the Plan as at least 1,000 hours of service in the plan year and employed with the Plan Sponsor on the last day of the plan year. Eligible participants may enter the Plan on the first day of the Plan quarter, coinciding with, or next following, the date they satisfy the eligibility requirements.

A member of management serves as the Plan’s trustee. As of December 31, 2023 and 2022, Mid Atlantic Trust Company (“MATC”) served as the custodian (“Custodian”), and American Trust Company served as the Plan’s recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

As of August 23, 2022 (the “Transaction Date”), Sesami Cash Management Technologies Corporation entered into an agreement to purchase the Plan Sponsor. As of the Transaction Date, a decision was made to maintain the Plan, and there have been no subsequent decisions made or actions taken related to Plan operations as of the financial statement issuance date.

Contributions

Employees who have satisfied the service and eligibility requirements for Plan participation may elect to contribute an amount up to the statutory limit defined by the Internal Revenue Code (“IRC”). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Rollover contributions from other qualified plans are allowed.

NOTE 1: DESCRIPTION OF PLAN (continued)

In addition, the Company has a safe harbor employer matching contribution equal to 100% of deferrals up to 3% of compensation, plus 50% of compensation deferred from 3% to 5%. The Company may also make an additional discretionary employer matching contribution. If the Company elects to make an additional discretionary employer matching contribution, the additional amount will not apply to deferrals exceeding 6% of compensation. No additional discretionary employer matching contributions were made to the Plan in 2023.

The Company may also make a discretionary nonelective employer contribution. No discretionary nonelective employer contributions were made to the Plan in 2023.

Participants' Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor employer matching contributions, the Company's discretionary employer matching contributions, allocations of the Company's discretionary nonelective employer contributions, and Plan earnings. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor employer matching contributions plus actual earnings thereon.

Vesting in the Company's discretionary employer matching and discretionary nonelective employer contributions occurs according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months or 50% of their vested account balance. Loan terms range from one to five years, bear interest at the Prime rate, and are secured by the balance in the participant's account. Principal and interest are paid ratably on a bimonthly basis through payroll deductions.

Forfeited Accounts

Forfeitures represent nonvested discretionary employer matching or discretionary nonelective employer contributions of participants who have terminated their employment with the Company. Forfeited accounts are used to reduce administrative expenses and then any discretionary nonelective employer contributions or any employer matching contributions as permitted by the Plan's provisions. As of December 31, 2023 and 2022, there were no forfeited nonvested accounts. No forfeitures were used during 2023.

Payment of Benefits

Upon death, disability, or termination of service, a participant generally may elect to receive a lump-sum payment equal to the value of the vested portion of his or her account. In addition, upon retirement, installment payments are available.

A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or due to financial hardships, as defined by the plan document.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. The investment in the collective trust fund is valued using net asset value (“NAV”) as a practical expedient. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of the Plan are allocated to participants’ accounts and are included in administrative expenses. Fees related to the administration of notes receivable and the administration of distributions to participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in the net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3: INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

All investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held as of December 31, 2023 and 2022, net appreciation in fair value of investments, and interest and dividends for 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Custodian.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used as of December 31, 2023 and 2022.

Money market and mutual funds - Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

Investments in Entities That Use NAV as a Practical Expedient

As of December 31, 2023 and 2022, the fair value of the collective trust fund, valued at NAV, totaled \$140,616 and \$297,134. The value of this fund is measured using NAV as a practical expedient and has been excluded from the fair value hierarchy. The collective trust fund has a daily redemption frequency and a redemption notice period no longer than 12 months. There are no unfunded commitments. If the Plan were to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly, business manner.

NOTE 5: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in certain funds managed by the Custodian and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to third-party administrators totaling \$37,666 for recordkeeping and contract administration services during 2023, which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

The difference between the contributions per the Plan's financial statements and the contributions per the Form 5500 is due to the financials being prepared on the accrual basis of accounting and the Form 5500 being prepared on the cash basis of accounting.

NOTE 7: INCOME TAX STATUS

The Plan Sponsor adopted the CCH Incorporated OBA FTWILUAM Volume Submitter Profit Sharing Plan with cash or deferred arrangement (the "Prototype Plan"). The Prototype Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Prototype Plan, as then designed, was qualified under Section 401(a) of the IRC and that any employer adopting this form of the plan would be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state tax authorities.

NOTE 8: DELINQUENT PARTICIPANT CONTRIBUTION

Title I of ERISA requires that all employee contributions be submitted to the Plan as soon as administratively possible, but no later than the 15th business day of the month following the month of being withheld from compensation. During 2022, participants' contributions and loan repayments totaling \$17,426 were not remitted timely. These contributions were reported as late remittances on Schedule 2. Lost earnings on the 2022 contributions were remitted to the Plan in October 2023.
