Basis for Opinion

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of Assets Held at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the D & S Dental Laboratory, Inc. 401(k) Savings Plan (“Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is intended to meet the requirements of Section 401(a) of the Internal Revenue Code (IRC) and qualify as a defined contribution plan and was established to provide retirement benefits to eligible employees of D & S Dental Laboratories, Inc. (“Company”).

The assets of the Plan are held for the exclusive benefit of the participating employees. An employee is eligible to participate in the elective deferral and employer matching after completing six consecutive months of service with the Company and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan allows participants to make pre-tax contributions of up to 100 percent of their base salary, subject to certain IRC limitations (\$22,500 for 2023) in each calendar year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2023. Employee contributions are fully vested.

The Company may make a matching contribution on behalf of a participant. Matching contributions for the years ended December 31, 2023 and 2022 equaled 33.33 percent of the participant’s contribution up to six percent of the participant’s eligible compensation each period.

The Plan also accepts rollovers from other tax-qualified plans.

Participant Accounts

Participants are allowed to direct their account balance, their contributions and employer contributions into any of the investment options available.

Each participant’s account is credited or charged with the participant’s contribution and the employer’s matching contribution and an allocation of Plan investment income or loss. Participants share pro rata in any investment income or loss of the funds, based upon individual participant account balances in the respective funds as of the end of each day. Each participant’s account may also be charged with an allocation of the Plan’s administrative expenses.

Participant Accounts (Continued)

Except for fees attributable to particular participants, administrative expenses are allocated pro rata based on individual participant account balances.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

Vesting

A participant is always fully vested in participant and rollover contributions. Employer matching contributions plus actual earnings thereon become vested based on a participant's years of service, vesting at a rate of 20 percent per year upon completing two years of service so that a participant becomes fully vested after six years of service.

Payment of Benefits

In the event of normal retirement, death, or permanent disability, a participant is entitled to receive the entire amount credited to the participant's account. If employment is terminated for any other reason, a participant is entitled to the vested portion of the account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 not to exceed the lesser of \$50,000 or 50 percent of their vested balance. The notes are secured by the balance in the participant's account and bear interest at one percent above the prime rate. Notes are repaid by payroll deductions. The interest rate on the note receivable from participant was 4.5 percent at December 31, 2023.

Upon participant termination or retirement, the outstanding loan balance is treated as a distribution to the participant if repayment is not made by the participant, or if an on-going repayment arrangement has not been made with the Plan. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Forfeited Accounts

The Plan provides that upon a participant's termination for reasons other than retirement, death or disability, the participant's non-vested funds are forfeited. Forfeited amounts from employer matching contributions are used to pay plan expenses or reduce Company matching contributions. During the year ended December 31, 2023, forfeitures totaling \$21,723 were used to reduce Plan expenses. At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$1,255 and \$15,943, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP"). The financial statements and supplemental schedules have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Benefits Paid to Participants

Benefits are recorded when paid to participants.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Plan related expenses, consisting primarily of record keeping, administrative fees, custodian fees, and other professional fees are paid for by the Plan and have been recorded as administrative expenses on the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are also included in administrative expenses. Expenses related to investments are included in net appreciation (depreciation) of fair value of investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

Level 1 - which refers to securities valued using unadjusted quoted prices from active markets for identical assets;

Level 2 - which refers to securities not traded on an active market but for which observable market inputs are readily available; or

Level 3 - which refers to securities valued based on significant unobservable inputs. There are no Level 2 or Level 3 investments in this plan.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds - share value based on the underlying closing price reported on the active market which the funds are traded.

Common/collective trust - valued at the net asset value (NAV) as reported by the manager of the collective trust fund and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the year-end date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Common/Collective Trust

The Reliance MetLife Stable Value Fund Series 25053 - Class 0 as of December 31, 2023, and Reliance MetLife Stable Value Fund Series 25157 - Class 0 as of December 31, 2022, (“Reliance Stable Value Fund”) hold investment contracts that are deemed to be fully benefit-responsive investment contracts. However, this is considered to be an indirect fully benefit-responsive investment contract investment and is reflected at NAV as a practical expedient which is considered fair value. The NAV is equal to contract value of the underlying investment and is equal to the accumulated cash contributions and interest credited to the Plan’s contracts, less any withdrawals or transfers. The Reliance Stable Value Fund is not available for sale or transfer on any securities exchange.

The existence of certain conditions can limit the Reliance Stable Value Fund’s ability to execute transactions at contract value. Specifically, any event outside the normal operation of the Reliance Stable Value Fund that causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, partial or complete legal termination of the Reliance Stable Value Fund or a unitholder, tax disqualification of the Reliance Stable Value Fund or a unitholder, and certain Reliance Stable Value Fund amendments if issuers' consent is not obtained.

As of December 31, 2023, the occurrence of an event outside the normal operation of the Reliance Stable Value Fund that would cause a withdrawal from an investment contract is not considered to be probable. To the extent a unitholder suffers a tax disqualification or legal termination event, under normal circumstances it is anticipated that liquid assets would be available to satisfy the redemption of such unitholder 's interest in the Reliance Stable Value Fund without the need to access investment contracts.

Note 6 - Administration of Plan Assets

The Plan assets were held and managed by Matrix as of December 31, 2023 and 2022 and for the year ended December 31, 2023. Matrix invests cash, interest and dividend income as directed by the participants of the Plan.

Note 7 - Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, transactions conducted by Matrix qualify as party-in-interest transactions.

The Plan paid for expenses related to its investment activity and plan operations. Those transactions qualified as party-in-interest (see Note 2 - administrative expenses).

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Note 9 - Tax Status

The Plan adopted the Fidelity Volume Submitter Profit Sharing Plan with CODA which has a favorable advisory letter from the Internal Revenue Service (IRS) dated March 31, 2014. This advisory letter states that the form of the volume submitter plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.
