Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion



NOTE A - SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The accounting records of the Gillette Air Conditioning Profit Sharing Plan (the "Plan") are maintained on the accrual basis in accordance with U.S. generally accepted accounting principles.

Recognition of Income: The basis of investments held by the Plan are adjusted annually to the closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using adjusted basis (beginning of year market value) on the first-in, first-out method. Security transaction expenses are considered in computing realized gains and losses on investments.

Investments: Investments in mutual funds (registered investment companies) are carried at fair market value (net asset value), as determined by quoted prices in an active market. Dividends are considered in the fair market value determination. The guaranteed investment contract is stated at contract value. Gains and losses (realized and unrealized) included in changes in net assets are reported in net appreciation (depreciation) in fair value in the statement of changes in net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

New Accounting Pronouncements: Management is not aware of any new accounting pronouncements that have been released, and are not yet effective, which will have a significant impact to its financial position or results of operations in future periods.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B - DESCRIPTION OF PLAN

The following description of the Gillette Air Conditioning Profit Sharing Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: Gillette Air Conditioning Profit Sharing Plan (the "Plan") is a defined contribution plan, covering virtually all employees of Gillette Air Conditioning (the Plan Sponsor) who have one year of service and have attained age 21. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Restatement and Amendment: The Plan was restated and amended effective January 1, 2022, to conform with required regulatory changes, including the most recent hardship distribution provisions and the SECURE, CARES, and CAA provisions.

SECURE 2.0 Act: The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly.

Basis of Presentation: The financial statements of the Plan are prepared following the accrual method of accounting.

Contributions: Each year participants may elect to contribute up to 100% of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor may elect to contribute a matching contribution, the amount of which is determined by the Board of Directors and allocated based on each participant's contributions. Participants also direct the investment of any matching contribution received.

Employer Prevailing Wage Contributions: Employer prevailing wage contributions are at an hourly rate prescribed for fringe benefits pursuant to each federal, state, county, or publicly funded contract entered into by the Plan Sponsor.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions, (b) Employer Prevailing Wage Contributions and (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and employer prevailing wage contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts, plus actual earnings thereon is based on years of service following the Department of Labor guidelines.

Payment of Benefits: On termination of service a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of time detailed in the Plan.

NOTE B - DESCRIPTION OF PLAN – continued

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Forfeitures: Forfeitures are retained in the Plan and may be used to pay for administrative expenses, allocated to the remaining participants or considered as employer contributions. Forfeited non-vested accounts totaled \$33,904 at December 31, 2023 and \$41,405 at December 31, 2022.

NOTE C - INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103-8, investments at December 31, 2023 and 2022, and the related investment earnings for the years then ended, were certified and held by Nationwide Financial Services, Inc., the Custodian, and were not audited by the independent auditor.

NOTE D – GUARANTEED INVESTMENT CONTRACT

The Plan has a guaranteed investment contract with Nationwide Financial Services, Inc. (Nationwide) with a contract value of \$2,698 at December 31, 2023 and \$132,030 at December 31, 2022. Nationwide maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive. Accordingly, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. For example, premature termination of the contracts by the Plan, Plan termination, bankruptcy, mergers, and failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any event which would limit the Plan's ability to transact at contract value with participants is probable of occurring.

NOTE E - INCOME TAX STATUS

The Plan is a pre-approved non-standardized pre-approved profit sharing plan. Effective January 1, 2022, the Plan was amended and restated for changes required by ERISA. This amended and restated Plan received a favorable determination letter from the Internal Revenue Service on June 30, 2020. The Plan is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

NOTE F - FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used for investments measured at fair value, nor transfer between levels. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued based on quoted prices (net asset value) in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G - TRANSACTIONS WITH PARTIES IN INTEREST

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE H – NONEXEMPT TRANSACTIONS

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. The Plan Sponsor did not timely make several participant contribution remittances in 2023 and 2022 totaling \$110,571 and \$90,949, respectively. These contributions are considered prohibited transactions by the DOL. The Plan Sponsor will calculate lost investment earnings and expects to compensate the Plan for the 2023 lost earnings in 2024. The Plan Sponsor computed the lost earnings calculation for the 2022 late remittances and made the correction in 2023.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – SUBSEQUENT EVENTS

Effective in February 2024, the Plan Sponsor transitioned to Empower Retirement as the new Custodian. This change is not anticipated to have a material impact on the Plan's financial position or operational results.
