Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the H&H Drug Stores, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of H&H Drug Stores, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a qualified defined-contribution plan established July 1, 2019 by H&H Drug Stores, Inc. (the “Employer”), under the provisions of Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), and provides for a qualified cash or deferred arrangement, as described in Section 401(k) of the Internal Revenue Code (IRC), for the benefit of eligible employees of the Employer.

Administration

The Plan is administered by the Employer. Reliance Trust Company (the “Trustee”) is responsible for the management of the Plan’s assets. ADP Retirement Services (the “Custodian” or “ADP”) is responsible for the management of the Plan’s assets and is also the recordkeeper.

Eligibility

An employee is eligible for participation in the Plan upon completion of six (6) months of employment and 500 hours of service. Enrollment can occur on the first day of the next calendar month after meeting the service requirement.

Participant Contributions

Participants may elect to contribute on a pretax basis, up to ninety percent (90%) of their eligible compensation, in an amount not in excess of the maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age fifty (50) before the end of the Plan year are eligible to contribute additional catch-up contributions. Participants may also make contributions to the Plan on an after-tax basis, as Roth deferrals, as defined in the Plan agreement and subject to the limitations under the IRC as listed above. Participants may also rollover amounts representing distributions from other qualified benefit or contribution plans.

Employer Contributions

The Employer makes non-elective safe harbor contributions of 100% of a participant’s elective deferral not to exceed 3% of the participants eligible compensation plus 50% of the amount of the participants elective deferrals that exceed 3% but do not exceed 5% of the participants’ compensation. The Plan allows for additional discretionary contributions, however, no additional discretionary contributions were made for the Plan year ended December 31, 2023.

Participant Accounts

Each participant’s account is credited with the participants’ contributions and allocations of the Employer’s contribution and Plan earnings, and charged with an allocation of administrative expenses to the extent that were not paid by the Employer. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Investment Options

Participants may direct participant and Employer contributions, as desired, in any of several investment options offered by the Plan. Participants may change their investment options any time throughout the year, via the Internet website, or by using the automated telephone system offered by the trustee.

Vesting

Participants are immediately vested in their contributions, non-elective safe harbor Employer contributions, and any discretionary Employer contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or fifty percent (50%) of their account balance, whichever is less. Note terms range from one (1) to five (5) years, except for notes related to the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate that a bank or other professional lender would charge for a note in a similar circumstance.

The outstanding notes bear interest at a rate that ranges from 4.25% to 9.50% as of December 31, 2023 and 2022, and mature through December 2028. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Upon normal retirement, retirement due to permanent disability, death, termination, or hardship, the participant or the participants' beneficiaries are eligible to receive their vested interest in funds either in the form of payments beginning at age 65 or in a lump sum payment. The Plan can distribute all participant balances under \$5,000 without the request of the participant.

Financial Hardship Distributions

The Plan allows for hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Forfeitures

Participants' accounts are forfeited if any Employer contribution portion has not fully vested at the time of withdrawal. Forfeited non-vested accounts may be utilized to pay Plan expenses or reduce Employer contributions. For the year ended December 31, 2023, the Plan used \$267 used to reduce Employer contributions. As of December 31, 2023 and 2022, all forfeitures were fully allocated.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Certain management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income is recognized when earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions, based upon the terms of the Plan document. No allowance for credit losses have been recorded as of December 31, 2023 and 2022.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan pays substantially all administrative expenses. Expenses that are paid by the Employer are excluded from these financial statements.

NOTE 3 – CERTIFIED INFORMATION

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified the completeness and accuracy of assets and notes receivable from participants, reflected on the accompanying statements of net assets available for plan benefits and the supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), as of December 31, 2023 and 2022, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2023.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability, and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered investment companies

Valued at the daily closing price, as reported by the shares. Registered investment companies held by the Plan are open-ended shares that are registered with the Securities and Exchange Commission (SEC). These shares are required to publish the daily net asset value (NAV) and to transact at that price. The registered investment company shares held by the Plan are deemed to be actively traded.

Common collective trust:

Units held in a common collective trust (CCT) are valued using the net collective asset value practical expedient (NAV practical expedient) of the CCT as reported by the CCT managers. The NAV practical expedient is based on fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CCT is calculated based on a compilation of primarily observable market information. The CCT have a daily redemption frequency, no redemption period or restrictions and have no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value, or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Reliance Trust Company; therefore, these transactions qualify as exempt party-in-interest transactions permitted by the United States Department of Labor Rules and Regulations. The Employer and Plan administrator are also parties-in-interest with respect to the Plan. Fees paid by the Plan to the Trustee amounted to \$2,705 for the year ended December 31, 2023. Notes from participants and the related interest income of \$1,943 are also considered related party transactions.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, including registered investment companies and common collective trusts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

NOTE 7 – FEDERAL INCOME TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by ADP, LLC. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan, is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan's management will make any changes deemed necessary to ensure the Plan maintains tax-exempt status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PLAN TERMINATION

Although it has not expressed such intent, and no termination events have occurred, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease. Net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

NOTE 9 – OPERATIONAL DEFECT

During the year ended December 31, 2023 and 2022, it was discovered that the Plan's provisions were not properly applied in the daily operation of the Plan. The definition of compensation for participant contributions as defined per the Plan document was not properly applied when calculating contribution amounts. The Plan Administrator determined the affected participants and will deposit \$25,862 and \$9,074, respectively, into the Plan as qualified nonelective Employer contributions (QNEC) to make the affected participants and the Plan whole, including interest.

NOTE 10 – SUBSEQUENT EVENTS

On September 26, 2024, the Plan was amended to revise the definition of compensation to exclude bonuses for eligible wages effective January 1, 2025.

The Plan Administrator has evaluated all activity through October 9, 2024, the date the financial statements were available to be issued.
