Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Vestis Wellness Plan (formerly known as Aramark Uniform Services, Inc. Wellness Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan

The following description of the Vestis Wellness Plan (formerly known as Aramark Uniform Services, Inc. Wellness Plan) (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General and Subsequent Events

The Plan is a welfare benefit plan for eligible participants and their dependents who are in a sponsored health coverage plan of Aramark Uniform Services, Inc. (the Company). The Plan provides wellness programs for eligible employees of the Company. The Company collects premiums from covered participants and their dependents who have elected smoker status to fund wellness programs provided by the Plan. These premiums are considered contributions to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 1, 2014, the Company established a trust to facilitate the collection of the premiums of the Plan.

On October 1, 2024, the Plan's Trust was amended effective August 15, 2024 to change the Company name from Aramark Uniform Services, Inc to Vestis Uniforms and Workplace Supplies, Inc. Further, the Plan name was changed effective September 26, 2023, to the Vestis Wellness Plan. The amendment also provided for the discontinuance of funding of the Plan's effective December 31, 2024, and the exhaustion of the Trust's assets through providing wellness benefits under the Plan.

Participant Premiums/Contributions

Participants and qualifying covered spouses are required to pay the smoker's election premium, if applicable. These premiums are contributed to the Plan's trust account. Premium rates for participants are determined annually by the Company, in accordance with the plan document.

Wellness Benefits

The Plan was established to promote wellness for participants through the funding of wellness programs. These wellness programs provide the participant with benefits such as smoking cessation assistance, behavioral and employee assistance help, as well as subsidized health screens and other participant wellness expenses. These expenses are reflected in the Statement of Changes in Net Assets Available for Benefits.

Wellness benefits covered by the Plan for participants are determined annually by the Company, in accordance with the plan document.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from these estimates.

Cash and Cash Equivalents and Income Recognition

Cash and cash equivalents consist of a highly liquid short-term investment with original maturities of three months or less.

Interest income is recorded on the accrual basis.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits.

Subsequent Events

The Plan evaluated subsequent events for recognition or disclosure through October 10, 2024, the date the financial statements were available to be issued.

3. Information Certified by Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, PNC Bank, N.A., the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2023 and 2022 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2023, the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits and the information reported in the supplemental Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2023.

4. Related-Party and Party in Interest Transactions and Administration of Plan Assets

PNC Bank, N.A., the trustee, invests funds received from contributions and interest income and makes payments for wellness benefits. Certain administrative functions of the Plan are performed by employees of the Company. No such employee receives compensation from the Plan.

5. Plan Termination

Although it has not expressed any intention to do so, under certain conditions, the Plan may be terminated. Upon termination, the assets then remaining should be subject to the applicable provisions of the Plan then in effect and should be used until exhausted to pay benefits to employees in the order of their entitlement.

6. Tax Status

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Trust's interest income is exempt from income taxes. The Plan's Trust has obtained a favorable tax ruling from the Internal Revenue Service (IRS), and the plan administrator believes that the Plan, as amended, is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in a highly liquid cash equivalent investment with a value of \$1,613,036 and \$1,422,282 as of December 31, 2023 and 2022, respectively. At December 31, 2023 and 2022, the Company maintained cash and cash equivalents at a certain financial institution in excess of federally insured limits. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
