Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TForce Freight 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TForce Freight 401(k) Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

The supplemental schedule of delinquent participant contributions as of and for the year ended December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 PLAN DESCRIPTION

The following is a brief description of the TForce Freight 401(k) Savings Plan (the Plan) and is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan established May 2, 2021. The Plan covers all employees of TForce Holdings USA, Inc. (the Employer) and TForce Freight, Inc. (a participating employer). The Plan excludes employees covered under a collective bargaining agreement, leased employees, nonresident aliens, residents of Puerto Rico, employees eligible to participate in another 401(k) Plan maintained by the Employer and participating employer, employees not employed by TForce Freight, Inc., consultants, contractors and offshore employees. Prior to September 1, 2022, there was no age or service requirements for employees to become eligible to participate. Effective September 1, 2022, employees are eligible following the attainment of age 21 and completion of 3 months of consecutive service. Eligible employees enter immediately upon meeting the eligibility requirements. The Plan is subject to the provisions of ERISA, as amended.

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 401k of the Internal Revenue Code (IRC). Eligible participants may contribute up to 50% of their eligible compensation to the Plan as pre-tax or after-tax Roth contributions. The Plan allows after-tax voluntary contributions. Prior to September 1, 2022, each participant shall be deemed to have made an election to have the Employer automatically withhold pre-tax elective deferral contributions in an amount equal to 6% of eligible compensation, unless an affirmative election is made otherwise. Each participant who is deemed to have made an elective deferral contribution election (pursuant to 6% above), shall also be automatically increased by 1% increments each May 1st up to a maximum deferral rate of 10% of eligible compensation. Effective September 1, 2022, the automatic-enrollment provision was removed. The Plan also allows participants age 50 and over to make catch up contributions.

The Employer may, at its discretion, elect to make a matching contribution or nonelective contributions to the Plan. For the year ended December 31, 2023, employer discretionary contributions were as follows:

- Participants hired after 1/1/2022 received an Employer matching contribution of 50% of deferrals up to a maximum of 6% of eligible compensation deferred.
- Participants hired prior to 1/1/2022 received a discretionary nonelective contribution under a tiered formula based on years of service and eligible compensation. Years of service were frozen as of December 31, 2021. Effective September 1, 2022, participants must be employed on the last day of the Plan year to be eligible for an employer nonelective contribution.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE 1 PLAN DESCRIPTION (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, the Employer's contributions, and an allocation of Plan earnings and losses. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The participants are always 100% vested in their contribution and related earnings. Participants hired prior to September 1, 2022, are always 100% vested in the Employer matching contribution and related earnings. Participants hired after September 1, 2022, are fully vested upon completion of four years of qualifying service, as defined, on a graded-vesting schedule. A participant will become fully vested in the Employer nonelective contributions upon completion of three years of service under a cliff vesting schedule. Notwithstanding the above, upon death, attainment of normal retirement age of 62, or permanent disability, a participant will be 100% vested in their accounts.

Notes Receivable from Participants

Participants are entitled to borrow up to 50% of their vested account balances, subject to a \$1,000 minimum and \$50,000 maximum note for specified purposes. Notes are repayable over periods of not more than five years (or longer period for purchase of a principal residence) and bear interest at the prime rate plus 1% at the time of borrowing. Principal and interest are repaid ratably through payroll deductions or ACH payment.

Benefit Payments

Upon termination of service, death, disability, or retirement, the participant may receive the value of vested interest in their account in the form of a lump sum distribution, partial withdrawals or installment payment. If a participant terminates employment and the participant's account balance was never greater than \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan also allows for in-service withdrawals at age 59½ and financial hardship, subject to Plan provisions.

Forfeited Accounts

Forfeited nonvested accounts are used to pay Plan administrative expenses or used to reduce future Employer contributions. Forfeited nonvested accounts as of December 31, 2023 and 2022 totaled \$-0- and \$123,718, respectively. There were no forfeitures used to pay plan administrative expenses for the year ended December 31, 2023. There were no forfeitures used to reduce employer contributions for the year ended December 31, 2023. The balance as of December 31, 2023 in the forfeiture account was transferred to an affiliated plan (see Note 9).

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance will be deemed taxable to the participant. The note balance will be reduced and a benefit payment will be recorded at the time the participant incurs a distributable event.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain fees related to the administration of investment management, investment advisory, benefits paid, notes receivable from participants, and other administration of accounts are charged directly to the participant accounts and are included in the administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2024, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Voya Institutional Trust Company, the trustee of the Plan and qualified institution, has certified to the completeness and accuracy of the notes receivable from participants and all the investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, the related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2023.

NOTE 4 FAIR VALUE OF INVESTMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the valuation methodologies as of December 31, 2023 and 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Collective Funds: Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participants may transact (purchases and sales) on a daily basis.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022:

NOTE 5 TAX STATUS

The Plan is placing reliance on an opinion letter, indicating that the prototype plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under present income tax law. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes

could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Voya Institutional Trust Company, the trustee of the Plan, provides investment management and recordkeeping services for the Plan. Therefore, the investment transactions qualify as party-in-interest transactions.

NOTE 9 PLAN MERGER

Effective December 28, 2023, the Plan sponsor resolved to merge the assets of the Plan into the TForce Holdings USA, Inc. 401(k) Plan. On December 31, 2023, all assets, receivables and notes receivables from participants in the amount of \$142,361,136 transferred to the TForce Holdings USA, Inc. 401(k) Plan.

NOTE 10 NONEXEMPT TRANSACTIONS

During 2023, the Company failed to remit employee 401(k) deferral contributions and loan repayments for certain payroll periods within the timeframe prescribed by the Department of Labor. These are deemed prohibited transactions in accordance with ERISA and the IRC. The Company is correcting the prohibited transactions in 2024 by depositing lost earnings.
