Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SAGE Centers 401(k) Profit Sharing Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation) and 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Principal Trust Company, the custodian and trustee of the Plan, which is a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger

As discussed in Note 8 to the financial statements, on June 3, 2022, SAGE Centers for Veterinary Specialty and Emergency Care ("SAGE") was acquired by National Veterinary Associates, Inc ("NVA"). As a result, a decision to merge the Plan into NVA's plan was made and the liquidation date of the Plan was determined to be December 29, 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued. The liquidation of the Plan assets was considered complete on January 6, 2024, upon the transfer of all assets into NVA's Plan.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of plan

General

Effective January 1, 1997, SAGE Centers for Veterinary Specialty and Emergency Care ("SAGE", "Plan Administrator", and "Plan Sponsor") adopted a defined contribution 401(k) profit sharing plan (the "Plan") covering all eligible employees who have completed one year of service and are age 18 or older.

The Plan was amended and restated in June 2022, with an effective date of January 1, 2022. This amendment added Adobe Veterinary Centers, LP and Animal Dental Clinic, Inc. as adopting employers in the Plan. \$23,301,962 of Plan assets were transferred into the Plan from these adopting employers in January 2022.

On June 3, 2022, the Plan Sponsor was acquired by National Veterinary Associates, Inc. ("NVA"). As a result, the Plan Sponsor merged the Plan into NVA's 401(k) Plan as of January 2, 2024 with a liquidation date of December 29, 2023. Refer to Note 8 for additional information on the plan merger. Plan assets of \$72,108,525 were transferred out of the Plan upon this merger.

The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions and the adopting employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration

SAGE appointed an Administrative Committee (the "Committee") to manage the operations and administration of the Plan. SAGE contracted with Principal Trust Company ("Principal") to act as the trustee, custodian and third-party administrator to process Plan transactions, maintain the records of participant data, and monitor compliance with governmental regulatory requirements.

Contributions

Participants could elect to defer up to 80% of their annual gross compensation as defined in the Plan Document. Participants who had attained age 50 before the end of the year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered investments in mutual funds, pooled separate accounts, common/collective trust funds, and a guaranteed investment contract to its participants. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically entered in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 5% of eligible compensation with annual increases of 1%, subject to a maximum automatic deferral of 10%. Their contributions were invested in a designated balanced fund until changed by the participant. The Plan utilized a "safe harbor" design under the IRS 401(k) plan regulations in which employee pre-tax and employer matching contributions were not subject to discrimination testing. The Plan Sponsor made a qualified non-elective contribution of 100% of the first 3% of compensation and 50% of the next 2% of compensation contributed by participants. Additional profit-sharing amounts could be contributed at the discretion of the Plan Sponsor. Employer contributions for the years ended December 31, 2023 and 2022 were \$3,134,578 and \$2,907,333, respectively. Contributions were subject to certain IRS limitations.

Participant accounts

Each participant's account was credited with the participant's contributions, Plan Sponsor matching and discretionary contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions, the employer safe harbor contributions, plus actual earnings thereon. Vesting in the employer discretionary contribution portion of their accounts was based on years of continuous service. Participants were 25% vested for each year of qualified service beginning with the second year of qualified service and became fully vested upon the completion of five years of qualified service. Employees became 100% vested in the employer portion of their accounts upon retirement, death or disability, as defined in the Plan Document.

Notes receivable from participants

Participants could borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. For loans qualifying under the Disaster Tax Relief and Airport and Airway Extension Act of 2017 ("Disaster Relief Act"), Tax Cuts and Jobs Act of 2017 ("TCJA"), and the Bipartisan Budget Act of 2018 ("BBA"), the dollar limit could be increased to \$100,000 or 100% of the participant's account balance. The loans were secured by the balance in the participant's account with an interest rate commensurate with the rates available for similar loans from commercial lending institutions, which remained fixed during the entire period of the note. The interest rate for loans outstanding as of December 31, 2023 ranged from 4.25% to 9.50%. Loan terms ranged up to five years or could exceed five years for the purchase of a primary residence, or for participants grandfathered into the Plan through Plan mergers. A participant could have up to three outstanding loans at any time. Principal and interest were paid ratably through payroll deductions.

Payment of benefits

Upon reaching the age of 59½ and at the discretion of the participant or upon termination of service due to death, disability, or retirement, a participant or the designated beneficiary could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Upon termination, if the participant's or beneficiary's vested account balance was \$5,000 or less, the Plan allowed the trustee to distribute the vested account balance to an Individual Retirement Account ("IRA") for the participant's benefit. Vested balances of \$1,000 or less would be distributed as a lump-sum amount without the participant's consent.

Forfeited accounts

Forfeited non-vested employer discretionary contribution accounts could first be used to pay Plan expenses. Any remaining amounts could be used to reduce employer contributions. During 2023 and 2022, forfeitures totaling \$10,032 and \$95,188, respectively, were used to reduce employer contributions. There was no balance in the forfeiture account as of December 31, 2023 and 2022.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The Plan changed its basis of accounting from the ongoing plan basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements, subsequent to the decision to liquidate plan assets on December 29, 2023 and transfer all Plan assets into the NVA plan upon the acquisition of SAGE by NVA.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Document.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, issuance of distributions, and investment-related expenses are charged directly to the participant's account and are reflected in administrative expenses of approximately \$106,000 and \$93,000 for the years ended December 31, 2023 or 2022, respectively. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each investment fund and charged to participant accounts.

For the years ended December 31, 2023 and 2022, the Plan's investment advisor received a fixed annual fee of \$19,000, paid in quarterly installments, which is paid through revenue sharing.

Subsequent events

In preparing its financial statements, the Plan has evaluated subsequent events through October 10, 2024, which is the date the financial statements were available to be issued.

Note 3 - Certified investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants at December 31, 2023 or 2022, and net appreciation and depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2023 or 2022, were obtained by management, and agreed to or derived from information certified as complete and accurate by Principal, the custodian and trustee of the Plan.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's investments in mutual funds are valued at quoted prices in active exchanges. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

No assets were valued at Levels 1, 2, and 3 for the year ended December 31, 2023. No assets were valued at Levels 2 and 3 for the year ended December 31, 2022. There have been no significant changes in the methodologies used at December 31, 2023 and 2022.

The Plan's investments in pooled separate accounts and common/collective trust funds are valued at the Net Asset Value ("NAV") of units held. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The underlying securities are comprised of stocks, mutual funds, and a variety of separate accounts, several of which have observable Level 1 inputs.

Note 5 - Guaranteed investment contract

During 2013, the Plan entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with Principal. Principal maintains the contributions in a general account. Since the GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Fair value is the amount Plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. Most participant transactions are executed using contract value without adjustment.

The Plan’s investment in the GIC is valued at contract value by the custodian by discounting the related cash flows based on current yields of similar instruments with comparable durations, considering the creditworthiness of the issuer. The interest crediting rate is reset on a semiannual basis.

Events that may limit the ability of the Plan to transact at contract value with the issuer are premature termination of the contract by the Plan, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives. This contract has surrender charges if it is terminated by the contract holder or a plan terminated its interest in such contract within certain time periods.

Surrender charges are applicable when less than 12 months’ notice of the intent to terminate the Plan’s interest in the contract is given. The Plan Sponsor notified Principal of the Plan termination and merger on August 16, 2023, and the remaining balance of the GIC was initially transferred to the successor plan (See Note 8) on January 2, 2024 and then liquidated on August 16, 2024, and as such, no surrender charges were applied. Contract value remains as an appropriate basis for the fair value measurement of the GIC as of December 31, 2023 and 2022.

Note 6 - Rollover contributions

During 2023, rollover contributions of \$787,125 came from other plans and related to 14 participants. During 2022, rollover contributions of \$948,306 came from other plans and related to 29 participants.

Note 7 - Related party transactions and party-in-interest transactions

Certain plan investments in pooled separate accounts, common/collective trust funds, guaranteed investment contracts, and shares of mutual funds were managed by Principal. Principal was the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Refer to **Note 2 - Expenses** for expenses of the Plan paid by the Plan Sponsor and the Plan participants to the party-in-interest. Amounts received by the Plan Sponsor from Principal under a revenue sharing arrangement are discussed at **Note 2 - Expenses**. All these transactions are considered party-in-interest transactions under ERISA regulations, but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 8 - Plan merger

SAGE was acquired by NVA on June 3, 2022. Effective January 2, 2024, the Plan merged into the National Veterinary Associates, Inc.'s 401(k) Plan (the "NVA Plan"). Plan assets were transferred to the NVA Plan with a liquidation date of December 29, 2023 and a wire transfer date of January 2, 2024. A majority of the Plan investment balances were transferred on December 29, 2023, and the participant notes receivable were transferred on January 6, 2024. The guaranteed investment contract investments were considered assets of the NVA Plan as of January 2, 2024, the date the legal title to the assets transferred to the NVA Plan. As a result of the imminent liquidation, financial statements for the year ended December 31, 2023 have been presented on the liquidation basis of accounting. This had no impact on the values of the assets reported in the financial statements.

Note 9 - Tax status

The Internal Revenue Service has determined and informed Principal by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter, however the Plan's third party administrator and the Plan's tax counsel believe that through the date of termination, the Plan was designed and operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date and through the date of liquidation of Plan assets.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position not likely to be sustained upon examination by taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 10 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
