INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor
Hospice of Tuscarawas County Retirement Plan
New Philadelphia, Ohio

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Hospice of Tuscarawas County Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing) and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by Fidelity Management Trust Company, the Custodian of the Plan, an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Terminating Plan

As further discussed in Note 1 to the financial statements, the trustees of the plan voted to terminate the plan effective December 31, 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing Plan basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1 – DESCRIPTION OF PLAN

Plan Description

The following description of the Hospice of Tuscarawas County Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for more complete information.

Effective February 1, 2022, the Plan changed custodians from Nationwide Trust Company to Fidelity Investments.

General

The Plan is a defined contribution plan covering all full-time employees of Hospice of Tuscarawas County, Inc. (the “Organization”) who have one year of service and are age twenty-one or older. It is subject to the Employee Retirement Income Security Act (ERISA) of 1974.

Plan Termination

On December 20, 2023, the Board of Directors of Hospice of Tuscarawas County, Inc announced the signing of an affiliation agreement with Ohio’s Hospice, Inc. to be effective on January 1, 2024. As a result of this affiliation, the Plan Trustees of the Hospice of Tuscarawas County Retirement Plan voted to terminate the plan, effective December 31, 2023. Existing employees of the Organization will be eligible to participate in Ohio's Hospice, Inc.'s 401(k) Retirement Savings Plan on January 1, 2024.

No employee contribution or matching contribution of any kind will be made to the Plan with respect to compensation paid after December 31, 2023. Effective with the Plan's termination all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of the status or years of vested service.

In connection, with the Plan's termination, participants could direct a distribution of their account balances or, if they remain an employee of Ohio's Hospice, have their remaining account balance transferred into the Ohio's Hospice, Inc.'s 401(k) Retirement Savings Plan. As of March 2024, all assets of the plan were transferred out.

Contributions

Each year, participants may contribute up to 100% of pre-tax or after tax annual compensation, as defined in the Plan. Participants who have attained age 55 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization matches 100% of the first 3% of contributed employee funds and 50% of the next 2% of contributed employee funds for a maximum total match of 4%. Contributions are subject to certain limitations.

Participant accounts

Each participant account is credited with the participant's contributions and the Organization's matching contributions and allocations of Plan earnings, less an allocation of any administrative expenses, as defined by the Plan. Allocations are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Organization's matching contribution portion of their accounts plus actual earnings thereon as follows:

Less than three years	0%
Three or more years	100%

Any participant who attains normal retirement age, becomes disabled, or dies, becomes fully vested regardless of length of service.

Notes Receivable

The Plan does not allow for participant loans.

Distribution of Participant's Accounts

The entire vested balance of a participant's account may be distributed at the date of the participant's retirement from the Organization, death, or permanent and total disability. Participants still employed may elect to received either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of time.

Forfeited Accounts

At December 31, 2023 and 2022, there were no forfeited non-vested accounts. Any forfeited non-vested accounts would be used to reduce future employer contributions or administrative expenses.

Plan Administration Costs

The Organization absorbs significant costs of Plan administration related to legal, accounting, record keeping and general administration. Any expenses not paid by the Organization are paid by the Plan.

2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan’s investments are stated at fair value except for the fully benefit-responsive investment, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

The Plan records benefit payments to withdrawing participants when paid.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions among investment choices in varying increments. Participants may change their investment options on any normal business day.

The Plan has evaluated subsequent events through the date of the auditor's report, the date the financial statements were available to be issued.

3 – UNAUDITED INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company and Nationwide Trust Company, the Custodian, has certified to the completeness and accuracy of all investments reflected in the statements of net assets available for benefits at December 31, 2023 and 2022, respectively, the supplement schedule at December 31, 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2023, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has ability to access.

Level 2: Inputs to valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Money market fund and mutual funds: The investments are held and managed by Fidelity Management Trust Company. The fair value of investments held in these accounts is based on their reported net asset value (“NAV”). The NAV is based primarily on observable inputs and the market value of the underlying investments and is classified as Level 2.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

6 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds, money market funds, and common collective trusts managed by Fidelity Management Trust Company during 2023 and 2022. Fidelity Management Company is also the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The fees paid by the Plan for investment management fees and services for the years ended December 31, 2023 and 2022, were \$25,527 and \$17,548, respectively.

7 – TAX STATUS

The Organization adopted a Prototype Plan offered by Fidelity Management Trust Company. The Internal Revenue Service determined and informed, in a letter dated June 30, 2020, that the Prototype Plan and related trust were designed and qualified under the applicable provisions of the Internal Revenue Code (IRC) and were, therefore, exempt from Federal income taxes. The Plan has been amended since receiving the determination letter. In the opinion of the Plan administrator, the Plan continues to meet the IRC requirements and is currently operating such that its exempt status has been maintained.

Accordingly, no provision for income taxes has been included in the accompanying financial statements.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

8 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through the date of the auditor's report, which is the date the financial statements were available to be issued.
