Independent Auditors' Report

To the Participants and Trustees of
PFXCA LLC Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of PFXCA LLC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of PFXCA LLC Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of PFXCA LLC Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As described in Note 1 to the financial statements, effective January 1, 2023, the PFXCA LLC Retirement Plan approved a termination of the Plan and to have of its assets transferred to Pet Food Experts, Inc. 401(k) and Profit Sharing Plan.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about PFXCA LLC Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

1. Description of Plan

Transfer of Plan Assets

Effective January 1, 2023, the PFXCA LLC Retirement Plan (formerly United Pacific Pet LLC 401(K) Retirement Savings Plan) (Plan) approved a termination of the Plan. As of December 31, 2023 all of the assets of the Plan were transferred to the Pet Food Experts, LLC 401(k) and Profit Sharing Plan, an existing plan held by the same Plan Sponsor.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan, established December 15, 1997, is a participant-directed defined contribution plan. The Plan covers all union and non-union employees of PFXCA, LLC (the Company or Employer) who are at least 19 years old and have completed 3 months of service. Employees represented by the Local No. 848 of the International Brotherhood of Teamsters (the Union) are exempt from the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employer Contributions

The Employer may make discretionary matching contributions to non-union employees. For the year ended December 31, 2022, the Company made discretionary matching contributions of 50% of non-union participant's elective deferrals up to 6% of eligible compensation. There were no discretionary nonelective contributions made during the year ended December 31, 2023.

The Employer will also make a nonelective employer contribution to all union employees, who have completed one calendar quarter of service. The nonelective employer contribution is equal to a uniform rate per hour worked, which increases periodically as outlined in the collective bargaining agreement. The collective bargaining agreement expired on November 30, 2023.

The Employer may also elect to make discretionary nonelective contributions to union employees. To be eligible for the Employer's discretionary nonelective contribution, union participants must complete at least 1,000 hours of service in the Plan year. These contributions will be allocated to eligible participants in the ratio that each eligible participant's compensation bears to the total compensation paid to all eligible participants for the contribution period. There were no discretionary nonelective contributions made during the years ended December 31, 2023 and 2022.

Employee Contributions

Participants may contribute up to 75% of pretax annual compensation, not to exceed \$22,500 and \$20,500 in 2023 and 2022, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution is \$7,500 and \$6,500 in 2023 and 2022, respectively. Participants may designate some or all their elective deferrals as Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other eligible retirement plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also includes an automatic escalation for participants with a deferral rate greater than zero, who are not suspended from making deferral contributions. Eligible participants' deferral rates increase annually by 1%, not to exceed 6% of eligible compensation.

1. **Description of Plan** (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings less expenses. The allocation of earnings and losses is performed based on individual participant account balances. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and all employer contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may only have four loans outstanding at a time. Note terms range from 1 to 5 years, or up to 30 years for the purchase of a primary residence. Loans are secured by the participant's vested interest in his account, not to exceed 50%. Loans outstanding bear interest at 1% above the prime interest rate. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) may receive the value of his or her vested account in a lump-sum distribution or substantially equal installments. Alternatively, the participant may elect to defer the distribution.

If a participant's vested balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000, the amount will be rolled over to an individual retirement account designated by the Employer, unless otherwise directed by the participant.

Hardship withdrawals from the Plan are permitted, subject to the limitations imposed by the Internal Revenue Code (IRC).

Plan Administration

The Company is also the Plan Administrator. As Plan Administrator, the Company has exclusive authority and responsibility for all matters in conjunction with the operations and administration of the Plan. Two employees of the Employer serve as the trustees to the Plan. Charles Schwab & Co., Inc. (Schwab) is the broker for the self-directed brokerage accounts offered by the Plan. Empower Retirement is the recordkeeper of the Plan.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. **Summary of Significant Accounting Policies** (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the insurance company general account investment which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements. Contract value represents investments at cost plus accrued interest income less amounts withdrawn to pay benefits. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company, unless the Company directs that such expenses shall be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net of appreciation or depreciation) from the related investment fund.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single custodian. The Plan's exposure to credit risk is associated with the custodian's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2024, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Great-West Life & Annuity Insurance Company (Great-West) and Empower Annuity Insurance Company of America (trustees of the Plan). On December 31, 2020, Empower Retirement, LLC (Empower) acquired the retirement business of Massachusetts Mutual Life Insurance Company (MassMutual). The transition for the Plan from MassMutual to Empower occurred in April 2022. Consequently, the trustee certifying changed. Great-West certified January 2022 through April of 2022 while Empower certified May 2022 through December of 2023. This information has not been audited by the Plan's independent auditors. The certified information at December 31, 2023 and for the year then ended includes:

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Self-directed Brokerage Account

Valued at the daily closing price reported on the active market on which the individual securities are traded. This account consists of a combination of cash and stocks.

4. Fair Value Measurements (continued)

Pooled Separate Accounts

Pooled separate accounts are invested primarily in mutual funds. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

As of December 31, 2023, the Plan did not have any assets due to the transfer of plan assets described in Note 1. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

5. Related-Party Transactions and Party in Interest Transactions

Plan investments are held and managed by Empower, the custodian of the Plan, and Schwab is the broker for the self-directed brokerage account. Therefore, these transactions qualify as party in interest transactions. The Plan made direct payments to the custodian for administrative services of \$0 and \$13,995 for years ending December 31, 2023 and 2022, respectively. Participant notes receivable also qualify as party-in-interest transactions.

6. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.
