DECEMBER 31, 2023 AND 2022

NOTE A: DESCRIPTION OF THE PLAN

The following description of Rynone Manufacturing Corporation 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Rynone Manufacturing Corporation, Sayre Corporation, Rynone Waverly, Inc., and Cayuga Realty Associates, LTD DBA Rynone Factory Outlet, (collectively "the Companies"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

As of May 1, 2022, newly hired and eligible rehired employees, if not classified as temporary, are automatically enrolled in the Plan after one year of service at 2% before-tax contribution rate, unless they file an election form with the Plan Administrator indicating a different rate of contribution. Previously, newly hired and rehired eligible employees, if not classified as temporary, were automatically enrolled in the Plan at 2% before-tax contribution rate as of their first day of employment, unless they filed an election form with the Plan Administrator indicating a different rate of contribution.

For 2023, the Companies made a non-discretionary safe harbor matching contribution equal to 100% of the participant's salary deferral not to exceed 3% of the participant's compensation plus 50% of the participant's salary deferral to the extent such salary deferrals exceed 3% but do not exceed 5% of the participant's compensation.

For 2022, the Companies may make a discretionary matching contribution as determined by the Board of Directors on an annual basis for participating employees after the employee has one year of service and are age 21 or older. For the year ended December 31, 2022, the Companies matched up to 50% of the first 2% of the employee's contribution.

Participant accounts

Each participant's account is credited with the participant's contribution, the Companies' matching contribution, an allocation of Plan earnings and special discretionary contributions, if any. Allocations of earnings are based upon account balances. The benefit to which a participant is entitled is the benefit that can be provided for the participant's vested account. Participants may direct employee and employer contributions in several different investment models.

Vesting

Participants are immediately vested in their voluntary contributions and 2023 safe harbor matching contributions. Vesting in the remainder of their account is based on years of service. Plan participants become fully vested in employer contributions after six years of service.

Payment of benefits

Upon termination of service for any reason, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or installment payments.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net investment gain (loss) is recorded monthly based on the change in the fair value of the accounts. See Note C for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date and capital gain distributions are included in dividend income.

Payment of benefits

Benefits are recorded when paid.

Plan expenses

The Plan's expenses are paid either by the Plan or the Companies, as provided by the plan document. Expenses that are paid by the Companies are excluded from these financial statements. Administrative expenses incurred by the Plan are paid by the employers up to \$2,000 per plan quarter. Administrative expenses in excess of \$2,000 for any plan quarter are allocated to the participants on a pro-rata basis and are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Beginning January 1, 2023, all Plan expenses are allocated to the participants on a pro-rata basis and are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Reclassifications

Certain prior year amounts have been reclassified to conform with the current year presentation.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through October 10, 2024 which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE C: FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes the methodologies used at December 31, 2023 and 2022.

Cash: Fair value equals cost.

Mutual funds and exchange traded funds: Valued at the quoted net asset value of shares held by the Plan at year end. The net asset value is determined using the quoted market prices of the investments in which the portfolio has invested.

Collective investment fund: Valued using the net asset value (NAV) per share practical expedient as determined by the issuer based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

NOTE C: FAIR VALUE MEASUREMENTS, Cont'd

The preceding methods as described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to amounts presented in the statements of net assets available for benefits.

NOTE D: TAX STATUS

The Plan operates under a standardized adoption agreement in connection with a prototype cash or deferred profit-sharing plan and trust/custodial document sponsored by Citizens & Northern Bank. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles general accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2020.

NOTE E: PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

NOTE F: FORFEITURES

If a participant terminates employment, the unvested value of their account is forfeited. The forfeited amounts may be used by the Companies to restore participant's forfeitures or to reduce future contributions to the Plan. At December 31, 2023, there were no forfeited non-vested amounts. At December 31, 2022, forfeited non-vested amounts totaled \$3,107.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I: TRANSACTIONS WITH PARTIES-IN-INTEREST

As described in Noted B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA.

NOTE J: PROHIBITED TRANSACTIONS – DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2023 and 2022, the Company failed to deposit \$25,710 and \$34,758, respectively, of participant deferrals within the required time frame as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. Plan management is in the process of completing all proposed corrections of this non-exempt transaction outside of the Voluntary Fiduciary Correction Program.
