We have performed audits of the financial statements of Fori Automation, Inc. Profit Sharing Trust & 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

The following description of the Fori Automation, Inc. Profit Sharing Trust & 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective October 1, 1985, by Fori Automation, LLC (the Company or Plan Sponsor). Fori Automation, LLC is the sponsor of the Plan. In December 2022, Lincoln Electric Holdings, Inc. completed its purchase of Fori Automation, LLC. The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (Fidelity or Trustee). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan was amended and restated effective November 18, 2021, to reflect remedial amendments associated with Fidelity Management & Research Company's requirement to restate pre-approved plan documents every six years.

Effective December 19, 2022, the Plan was amended to remove Global Engineering, Inc. as a participating employer of the Plan. The net assets in the Plan related to Global Engineering, Inc. totaling \$3,102,331 were transferred out, which included \$2,240 of outstanding loans.

Effective December 31, 2023, the Plan merged into the Lincoln Electric Company Employee Savings Plan. The net assets of the Plan totaling \$34,189,708 were transferred, which included \$380,319 of outstanding loans.

Eligibility

Participants must be 21 years of age to enter the Plan.

Additionally, the participant must complete three months of service to participate in the Plan. Temporary employees and interns must complete a minimum of 1,000 hours of service within a 12-month period to participate in the Plan.

All employees are eligible to participate unless they are covered by a collective-bargaining agreement or are leased employees.

An eligible participant can enter the Plan immediately upon meeting the eligibility requirements. Upon entry to the Plan, employees may immediately make elective deferrals and are eligible for non-elective discretionary employer contributions (profit-sharing). Participants become eligible for the discretionary employer matching contributions once they complete one year of employment with a minimum of 1,000 hours of service.

Notes to Financial Statements

Contributions

Each year, participants may contribute up to 60% of pre-tax annual compensation, as defined in the Plan document. Salary deferral agreements shall be made, terminated, or changed according to procedures and limitations set up by the Plan administrator and the Plan document. The Plan also allows for Roth contributions.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution based on a percentage, to be determined annually by the Company's Board of Directors, of the employees' deferral contributions to the Plan. Discretionary employer matching contributions were 20% of eligible participant contributions in 2023 and 2022. Employer discretionary matching contributions for the years ended December 31, 2023 and 2022 were approximately \$412,000 and \$459,000, respectively.

The Company may also make a non-elective discretionary employer contribution (profit-sharing contribution) to the Plan in an amount to be determined by taking the appropriate legal action for each Plan year. No non-elective discretionary employer contribution was made for the years ended December 31, 2023 and 2022.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are 100% vested in their individual deferral, Roth, and rollover contributions and the allocated earnings thereon.

A participant's vested interest in the discretionary employer matching contributions and non-elective discretionary employer contributions is based on the participant's years of continuous service and in accordance with the following vesting schedule:

Participants become fully vested in the event of retirement, death, total disability, or Plan termination.

Payment of Benefits

A participant's vested interest in the Plan is payable upon death; attainment of normal retirement age; becoming disabled, as defined in the Plan document; or termination of service. A participant may elect to receive a lump-sum amount or installment payments equal to the vested portion of the participant's account. A participant may elect to leave the account in the Plan or to roll over the vested balance to another qualified retirement plan or Individual Retirement Account (IRA).

For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance will be rolled into an IRA with Fidelity unless otherwise elected.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Participants may also withdraw an amount at age 59½ if certain criteria are met.

Forfeited Accounts

At December 31, 2023 and 2022, forfeited non-vested accounts totaled approximately \$130 and \$2,600, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. In 2023 and 2022, respectively, approximately \$27,000 and \$28,000 of the forfeited funds were used to fund employer contributions.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate at local prevailing rates as determined by the Plan administrator, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Internal Revenue Code (IRC). Each participant may not have more than two loans outstanding at any time.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses consist of loan initiation and maintenance fees, short-term redemption fees applicable to certain funds, audit fees, and certain fees related to the overall operation of the Plan. Fees are either charged to the specific accounts of the participants who incurred these charges or deducted from the Plan's forfeiture account. All other expenses of the Plan for the years ended December 31, 2023 and 2022 were paid by the Company and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 11, 2024, the date the financial statements were available to be issued.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements, related to investments and notes receivable from participants held as of December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Money Market Fund - The money market fund invests in high-quality short-term securities. In accordance with Rule 2a-7 of the Investment Company Act of 1940, the money market fund is valued at amortized cost, which approximates fair value. This method of valuation is designed to enable the money market fund to price its shares at \$1.00 per share, although each money market fund's share price may deviate from \$1.00 per share. The objective of this money market fund is to preserve capital, liquidity, and achieve the highest possible current income.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company, Trustee and recordkeeper of the Plan. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested in their accounts.

7. Tax Status

The Plan uses a pre-approved defined contribution plan document sponsored by Fidelity Management & Research Company, which received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan, as then-designed, satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the determination letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. No provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.
