We have performed audits of the financial statements of the Sunset Transportation, LLC 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements (financial statements).

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan was merged into the Armada Retirement Savings Plan effective January 1, 2024. Our opinion is not modified with respect to this matter.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Sunset Transportation, LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions, which is available from the Plan administrator.

General - The Plan was established on January 1, 1998, and is a defined contribution plan covering all full-time employees of Sunset Transportation, LLC (Company) who are age 21 or older. The Plan is a salary reduction plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees of the Plan is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. During November 2023, the board of directors of Armada Partners, LP (Armada), as ultimate parent company of the Company, approved a merger of the Plan into the Armada Retirement Savings Plan (Armada Plan) effective as of January 1, 2024. (See Note 10.)

Contributions - Each year, participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan, not to exceed certain dollar limits established by the Internal Revenue Code (IRC). Roth deferrals are also permitted. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investments offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect to not participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. Additionally, the Plan has an auto-deferral feature that increases pretax contributions by 1% each January up to a maximum 8% deferral rate unless a participant has elected otherwise.

After the completion of one year of service, participants become eligible, the first day of the following month, to receive the Company's match which, for the year ended December 31, 2023, was 100% of the first 5% of the employee's compensation. Participants are also eligible for profit-sharing contributions after the completion of one year of service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may contribute additional profit-sharing amounts at the discretion of the Company's board of members. The Company made no discretionary contributions during the year ended December 31, 2023.

Participant Accounts - Each participant's account is credited with the participant's deferral contributions, rollover contributions, and allocations of (a) the Company's matching and discretionary contributions, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participant's accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The participant's account is debited with any distributions or withdrawals made to the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants vest immediately in their voluntary contributions plus actual earnings thereon. The participant vests in the Company's contributions plus related earnings based on years of continuous service.

Forfeited Accounts - Upon termination of employment, participants forfeit their nonvested balances as determined by the vesting schedule above. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. The years of service prior to the participant's departure will be credited to them provided that the participant returns to the Company within five years and the participant repays the full amount distributed.

At December 31, 2023 and 2022, respectively, the unallocated forfeiture balance was \$8,501 and \$23,488. The forfeiture account can be used to reduce future Company contributions or to pay administrative expenses. The Company used \$58,729 of forfeitures to offset employer contributions during the year ended December 31, 2023.

Payment of Benefits - The Plan provides that a participant's vested interest in the Plan will be distributed to the participant upon retirement, total disability or death. Employees terminating employment with the Company for other reasons are entitled to their vested interest in the Plan. Certain participants with elective deferral contributions in excess of \$5,000 may elect to defer distribution to a future date as more fully described in the Plan. Participants may elect to (a) receive a single lump sum amount equal to their vested account balance, or (b) have all of his or her distributions paid in the form of a direct trustee-to-trustee transfer to another eligible retirement plan designated by the participant.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates. Loan terms range from 1 to 5 years, or longer for the purchase of a primary residence. Loans are repaid through payroll withholdings, including principal and interest.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment management fees charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected as expenses in the accompanying financial statements. Consequently, management fees and operating expenses are reflected in the net appreciation in the fair market value of such investments.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits - Benefit payments are recorded upon distribution.

Administrative Expenses - Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Expenses that are paid by the Company are excluded from these financial statements.

NOTE 3 - CERTIFICATION OF FINANCIAL INFORMATION (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, custodian of the Plan, Charles Schwab Trust Bank (Charles Schwab), has certified that the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

NOTE 4 - FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

The three levels of inputs that may be used to measure fair value are as follows:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than quoted prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are entitled to the entire amount of their unvested employer contributions.

NOTE 6 - TAX STATUS

The Plan uses a volume submitter plan document sponsored by EPIC Retirement Plan Services LLC. The Internal Revenue Service (IRS) has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the advisory opinion, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a tax liability and related interest and penalties or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2020.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Additionally, certain administrative expenses are paid directly by the Company.

The Plan has notes receivable from participants subject to specific guidelines as defined in the Plan document. These transactions are not deemed prohibited party-in-interest transactions because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

Some investments are managed by Charles Schwab. Charles Schwab is the custodian, therefore these transactions qualify as party-in-interest transactions.

The net assets available for benefits in the financial statements differ from the net assets available for benefits in the Form 5500 due to the transfer of assets from the Plan in connection with the merger of the Plan with the Armada Plan effective January 1, 2024. (See Note 1.) The accompanying financial statements reflect net assets available for benefits just prior to the merger, whereas the Form 5500 reflects the net assets available for benefits just subsequent to the merger.

NOTE 10 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 11, 2024, the date on which the financial statements were available to be issued.

On January 1, 2024, assets of \$12,874,000 were transferred to the Armada Plan as a result of the merger of the Plan into the Armada Plan.
