We have performed audits of the accompanying financial statements of Fortinet, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Fortinet, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established in 2003 by Fortinet, Inc. (the “Company”) to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Eligibility

The Plan specifically excludes leased employees, interns, employees covered by a collective bargaining agreement and nonresident aliens with no U.S. source income. All other employees of the Company of age 21 or older are eligible to enter the Plan on their date of hire. There is no minimum service requirement.

C. Participant Contributions

Participants may elect to contribute their pre-tax compensation to the Plan and/or elect to make Roth after-tax contributions. Each participant’s pre-tax deferrals and Roth contributions are limited to a maximum of 75% of regular pay. Participants may make a special election to defer up to 100% of bonus pay. Elective deferrals are subject to applicable Code limits. Participants of age 50 or older may make up to \$7,500 in additional catch-up contributions in 2023. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation.

Effective July 1, 2022, participants may elect to make after-tax contributions to the Plan.

Effective January 1, 2022, newly hired eligible employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan at a pre-tax deferral rate of 6% of compensation. The deferral percentage for auto-enrolled participants will automatically increase 1% annually in successive years to an annual maximum of 15% of eligible compensation.

Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified employer sponsored retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with participant directions.

D. Company Contributions

The Company is allowed to make discretionary matching contributions, as defined in the Plan and as approved by the Board of Directors. In 2023, the Company matched 50% of the first 4% of compensation contributed by participants.

E. Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Company contributions and an allocation of Plan earnings or losses and expenses. Participants may direct their investments among a diversified menu of core investment funds offered under the Plan, or a participant may elect to establish a self-directed brokerage account in which he or she may invest in any financial instrument approved by the Plan Administrative Committee. Assets of the Plan are invested based solely on participant directions.

The contributions of participants who decline to make an investment election are invested in the Vanguard Target Retirement Fund appropriate for the individual's age and projected date of retirement.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their elective contributions, rollovers and related earnings. Participants vest at the rate of 25% per year of service and attain full vesting in their accounts attributable to Company matching contributions after 4 years of service. Forfeitures of terminated participants' non-vested accounts may be used to reduce Company contributions or to pay Plan administrative expenses. Approximately \$596,506 of forfeitures were used to reduce Company matching contributions during 2023. The balances of unapplied forfeitures were immaterial at December 31, 2023 and 2022.

G. Expenses

Plan expenses may be paid by the Plan or the Company as provided in the Plan document. Terminated participants who elect to maintain their accounts in the Plan are charged a quarterly administrative fee. Participant loan fees and self-directed brokerage account fees are charged directly to participant accounts. Certain investment related expenses are charged directly by the funds and are thereby factored into each fund as a reduction in investment return. The Company pays substantially all other Plan administrative costs.

H. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon attainment of age 59½, termination of service, death, disability or retirement, a participant or beneficiary may maintain his or her account in the Plan or elect to receive benefits payable in a lump sum amount equal to the value of the participant's vested account balance. Under limited circumstances, the plan administrator may approve hardship withdrawals. Benefits are recorded when paid.

I. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at a fixed rate based on available market financing rates at loan inception and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence. Principal and interest are paid ratably through payroll deductions. Participant loans outstanding at December 31, 2023 carry interest rates ranging from 4.25% to 9.50% with maturities through December 2037.

I. Notes Receivable from Participants (Continued)

Participant notes receivable are measured at the unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on terms of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

D. Risks and Uncertainties

Investments include a variety of securities that are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in value of investment securities will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments offered under the Plan are issued by Fidelity. Purchases and sales of these investments and payment of expenses to Plan service providers from Plan assets are considered party-in-interest transactions under ERISA. Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - INCOME TAX STATUS

The Company adopted a volume submitter prototype plan that received an advisory letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2023 and 2022, and net appreciation of investments, interest and dividends for the year ended December 31, 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

NOTE 6 - FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value as follows: Level 1 refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2 refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3 refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement.

Mutual funds are valued at the daily closing price reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded. Self-directed brokerage accounts consist primarily of securities that are valued on the basis of readily determinable market prices. The following tables summarize Plan investments at December 31 based on the inputs used to value them:

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 8, 2024, the date on which the financial statements were available to be issued. There are no material subsequent events that require recognition or additional disclosure in the Plan's financial statements.
