Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of Dianne's Fine Dessert 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023, and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023, and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

The following description of Dianne's Fine Desserts 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Dianne's Fine Desserts, Inc. (the Plan Sponsor or the Company).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan assets are currently invested in pooled separate accounts and a guaranteed interest account offered by the Minnesota Life Insurance Company, the Trustee of the Plan.

In the absence of an affirmative election, the amount to be automatically withheld from each payroll period upon meeting eligibility requirements will be equal to the percentage of compensation set forth in the table below based on the Plan year in which automatic deferrals first apply to the participant.

Accordingly, the Company will make Qualified Automatic Contribution Arrangements (QACA) basic matching contributions on behalf of each participant in an amount equal to the sum of 100% of the participant's elective deferrals that do not exceed 1% of the participant's compensation, plus 50% of the participant's elective deferrals between 1% and 6% of eligible compensation. Employer QACA basic matching contributions will vest based on the participant's years of service (0 to 1 year—0%, 2 years—100%).

Eligibility: All employees, with the exception of leased employees, are eligible to enter the Plan and begin making elective deferrals upon meeting three months of consecutive service during which at least 250 hours of service are completed. If the employee does not complete the hour requirement in the given time frame, they will be eligible after one year of service.

Participant contributions: An active participant may elect to make two types of contributions to the Plan as follows:

Compensation deferral contributions: Each active participant may elect to contribute to the Plan a percentage of their eligible compensation, as defined, on a pre-tax basis or after-tax basis up to the applicable amount allowable under federal regulations. In the absence of an affirmative election, 4% of compensation will be deferred on each eligible employee's behalf, unless an employee opts not to participate. The automatic deferral will be increased based on years of service. Compensation deferral contributions are remitted to the Plan by the Company on the participants' behalf.

Note 1. Description of the Plan (Continued)

Rollover contributions: All eligible employees may, at the discretion of the Plan Administrator, contribute to the Plan from other qualified plans or individual retirement accounts, if the contributions satisfy the tax law requirements for a qualified rollover.

Employer contributions: The Company may elect to make two types of contributions to the Plan as follows:

Matching contributions: The Company makes QACA basic matching contributions on behalf of each participant in an amount equal to the sum of 100% of the participant's elective deferrals that do not exceed 1% of the participant's eligible compensation, plus 50% of the participant's elective deferrals between 1% and 6% of eligible compensation.

Discretionary profit sharing contributions: The Company may decide each Plan year whether to make a discretionary profit sharing contribution on behalf of eligible active participants to be allocated to participants based on compensation levels, as defined. The Company did not make a profit sharing contribution in 2023.

Participant accounts: Each participant's account is credited with the participant's contributions and the employer's matching contributions, as well as allocations of discretionary profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant directed transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: A participant will have a fully vested interest in that portion of their account attributable to compensation deferral contributions, rollover contributions and related investment earnings. Employer matching contributions vest 100% after the participant reaches two years of service. Employer discretionary profit sharing contributions vest 100% after the participant reaches three years of service.

Service is credited from the date of employment. If a participant terminates employment with the Company, they will be entitled to receive the vested value of their account. However, if they terminate service at normal retirement age, as defined in the Plan agreement, or if they should become disabled or die before reaching normal retirement age, they will be entitled to receive the total value of their account.

Forfeitures: Upon a participant's termination, any nonvested portion of the employer's matching or discretionary profit-sharing contributions is forfeited. Forfeitures are retained in the Plan and will first be used to pay administrative expenses under the Plan, as directed by the Company. Any remaining amounts will be used to reduce future employer contributions under the Plan. Forfeitures generated during the year ended December 31, 2023, were \$34,926. The Company used \$21,964 from forfeitures during the plan year ended December 31, 2023; with \$7,993 used to reduce 2023 employer matching contributions and \$13,972 used to pay plan administrative expenses. As of December 31, 2023, and 2022, the available forfeiture balance was \$21,208 and \$3,039, respectively.

Investments: The Plan offers a number of investment options which vary by investment objective. Participants elect in which investment or investments they wish their accounts invested. Participants may change their investment options daily.

Note 1. Description of the Plan (Continued)

Notes receivable from participants: Loans may be made to participants when directed by the Plan Administrator upon request by the participants. Each loan shall bear a reasonable rate of interest determined at the time the loan is made. Interest and principal are repaid and credited to the participant's account based on their current investment choices.

The maximum loan amount is one half of the participant's vested account balance, not to exceed \$50,000. The minimum loan amount is \$1,000. Loans are repayable over a period of up to five years, unless such loan is used to acquire a principal residence of the participant in which case a longer repayment period is allowed. A participant is not allowed to have more than one loan outstanding at any time.

Distributions:

Retirement, disability or death: Participants who retire or become disabled will be entitled to 100% of their account balance. Upon death, a participant's beneficiary will be entitled to 100% of the vested account balance, payable in accordance with the Plan document.

In-service: Participants who have reached certain age or service requirements, as defined in the Plan agreement, are entitled to withdraw 100% of their vested account balance.

Hardship: A participant may also request a withdrawal upon demonstration by the participant to the Plan Administrator that the participant is suffering from hardship, as defined in applicable regulations of the Internal Revenue Code (IRC).

Other termination of employment: Upon termination of employment for any reason other than retirement, disability, or death, participants shall be entitled to receive the vested amount of their account balance.

Note 2. Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results may differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Significant Accounting Policies (Continued)

Contributions: Contributions from Plan participants and the Plan Sponsor are recorded in the year in which the participant contributions are withheld.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Benefit payments: Benefit payments are recorded when paid.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 10, 2024, the date the financial statements were issued. Effective January 1, 2024, non-union participants of Dianne's Fine Desserts 401(k) Retirement Savings Plan were merged into the Dessert Holdings 401(k) Savings Plan. On March 14, 2024, the Dianne's Fine Desserts 401(k) Retirement Savings Plan transitioned from Securian to Fidelity Investments and became the Dessert Holdings 401(k) Savings Plan – NBT Union, now exclusively for union participants.

Note 3. Financial Information Certified by Minnesota Life Insurance Company, the Plan Trustee

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Trustee, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained a certification from the Trustee for 2023 and 2022 that such information is complete and accurate.

Note 4. Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Pooled separate accounts: Investments in pooled separate accounts are valued at net asset value (NAV) per unit based on the quoted market prices of the underlying investments. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The underlying investments are in mutual funds and corporate bonds that are valued at the closing price reported in the active market in which the individual securities are traded. The Plan had no specific intentions to sell investments at amounts other than NAV. These investments can be redeemed on a daily basis and have no lockup or funding commitments.

Note 5. Guaranteed Return Account

The Plan has entered into a fully benefit-responsive investment contract with Minnesota Life Insurance Company. Minnesota Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Minnesota Life Insurance Company.

Contract value is the relevant measurement for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Since the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value, as reported to the Plan by Minnesota Life Insurance Company, represents contributions made under the contract, plus credited interest, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. As of December 31, 2023 and 2022, the interest rate was 2.08% and 1.52%, respectively.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs.

The guaranteed return account does not permit the issuer to terminate the agreements. There is no stated maturity date for the investment contract.

Note 6. Party-in-Interest Transactions

Certain plan investments are pooled separate accounts and the guaranteed return account managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company is the Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Furthermore, Minnesota Life Insurance Company is providing plan administration services to the Plan. Participants pay fees for certain participant driven transactions. Total fees paid to Minnesota Life Insurance Company amounted to \$24,858 in 2023. Fees paid for investment management services are included as a reduction of the return earned on these investments. Notes receivable from participants also qualify as party-in-interest transactions. All other fees are paid by the Company on behalf of the Plan and are also excluded from these financial statements. Certain employees of the Company provide administration services to the Plan. These employees are not compensated for such services.

Note 7. Risks and Uncertainties

The Plan invests in a variety of investment securities. Investments are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risk factors in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

Note 9. Income Tax Status

Effective June 30, 2020, the Plan adopted a non-standardized form of a profit-sharing plan sponsored by Minnesota Life Insurance Company. The non-standardized plan provider has received a favorable opinion letter from the Internal Revenue Service (IRS) as to the non-standardized plan's qualified status. The pre-approval opinion letter has been relied upon by the Plan. The Plan has been amended since the non-standardized plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
