Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cycling Sports Group, Inc. and Pacific Cycle Inc. Associates 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of January 01, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the one-day period ended January 01, 2023, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following brief description of Cycling Sports Group, Inc. and Pacific Cycle Inc. Associates 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the summary plan description for more complete information.

General

The Plan is a qualified salary reduction 401(k) plan sponsored by Cycling Sports Group, Inc. and Pacific Cycle Inc. (collectively, the "Company" or the "Employer") primarily for the benefit of its hourly employees. The Plan was effective January 1, 2022. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger

In August 2022, the Company elected to merge the Plan with a related company's plan, effective January 1, 2023. Certain plan assets were transferred on December 30, 2022 with the remaining assets transferred in 2023. This transfer is reflected as "Payable to related company's plan" in the accompanying Statement of Net Assets Available for Benefits and as "Fund transfers to related company's plan" in the accompanying Statement of Changes in Net Assets Available for Benefits.

Contributions

The Plan permits eligible employees to contribute, through a salary reduction election, an amount representing a specific percentage of their salaries. This salary reduction election is eligible for a discretionary matching Company contribution which is 50 percent of the first 8 percent of the participant's compensation. Rollover contributions from other qualified plans are permitted.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching and discretionary contributions. Investment earnings, losses, and administrative expenses are allocated based on participants' account balances on a daily basis. Participants are fully vested in all employee and Employer matching contributions plus actual earnings thereon at all times.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. The loans are secured by the balance in the participant's account. There were no outstanding notes receivable from participants as of January 1, 2023 or December 31, 2022, due to the Plan merger discussed above.

Benefit Payments

Upon reaching the age of 59½, the participant is entitled to receive a lump-sum payment equal to the value of the participant's account. A participant that retires, becomes disabled, terminates employment or passes away is entitled to receive a lump-sum payment or installment payments, as described in the Plan agreement, equal to the value of the participant's account. A participant may make a hardship withdrawal, as defined in the Plan agreement, prior to age 59 ½.

Administrative Expenses

The Company pays significant administrative expenses of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on an accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded when earned. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future financial statements.

Benefit Payments

Benefits are recorded when paid.

Tax Status

The Plan uses a preapproved plan document sponsored by Great-West Trust Company, LLC who has received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the plan is designed to qualify as being exempt from federal income taxes. The plan administrator has not separately applied for an opinion letter from the IRS. However, the plan administrator believes that the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no income taxes have been provided.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has concluded that as of January 1, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 9, 2024.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, the custodians ("Empower") have certified to the completeness and accuracy of all investments reflected in the accompanying statement of net assets available for benefits as of January 1, 2023 and December 31, 2022.

4. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Professional fees and the majority of other administrative expenses of the Plan were paid by the Company.

Certain plan investments are managed by an affiliate of Empower. Empower is the recordkeeper and custodian for the Plan; therefore, transactions in these investments qualify as exempt party-in-interest transactions under ERISA. Empower also receives fees directly from Plan assets. SageView Advisory Group, LLC and Fiducient are investment advisors for the Plan and receive payment from the Plan and the Plan Sponsor. Blue & Co., LLC is the independent auditor of the Plan and receives payment from the Plan and the Plan Sponsor.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a group annuity contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of this traditional investment contract was \$304,631 at January 1, 2023 and December 31, 2022.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination), (2) changes to a plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

6. RECONCILIATION TO FORM 5500

Due to the plan merger described in Note 1, there is a difference in presentation between the amounts reported in the financial statements and the amounts reported in the Form 5500. The financial statements reflect the transfer on the effective merger date of January 1, 2023, with the investments held at such date fully offset by a payable for amount to be transferred. The Form 5500 reflects all assets being transferred as of January 1, 2023.
