Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

General

The following description of YPO, Inc. 401(k) Plan & Trust (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established by Young Presidents' Organization, Inc. (Organization) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Organization.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Plan was adopted January 1, 1997 to enable eligible employees to defer compensation and share in employer contributions, if any, and to save and invest funds for retirement.

The trustee and recordkeeper of the Plan is Bank of America, N.A.

Plan Administration

The Plan is administered by the Organization. The Organization has an investment committee made up of eligible participants elected by the employees. The duties of the committee are to review investment performance annually and provide for prudent investment of Plan assets.

Eligibility

All U.S. employees, with the exception of interns, are eligible to participate in the Plan, subject to a required minimum age of 21 and the completion of three months of service. Leased employees are eligible to participate in the Plan after the completion of one year of service. Eligible employees may become participants on the first day of the month following the date they meet the eligibility requirements.

Contributions

Upon eligibility, employees are auto-enrolled in the Plan at 1% of their eligible compensation. Participants may elect to defer a portion of their compensation into the Plan not to exceed twenty-five percent (25%), subject to the maximum contribution allowed by Section 402(g) of the IRC. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, subject to Internal Revenue Service (IRS) limitations. Changes in elective deferral percentages may be made daily during the plan year. Participants may also rollover amounts representing distributions from other qualified benefit plans into the Plan. The Organization matches contributions at a rate of 100% of each participant's first 2% of compensation contributed as elective deferrals and 50% of the next 4% of each participant's compensation contributed as elective deferrals, not to exceed a total match of 4% of compensation.

The Organization may make additional profit-sharing contributions to the Plan each year at the sole discretion of the Organization, within the limits of the IRC. Profit sharing contributions, if applicable, are made based on a flat percentage of each participant's eligible compensation. Any eligible participant employed on the last day of the Plan year is eligible to receive an employer profit-sharing contribution. The plan sponsor made no profit-sharing contributions for the years ended 2023 and 2022.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's contribution, and an allocation of Plan earnings and losses. Allocations are based on account balances. The participant determines both the amount to be invested and the allocation of the investment to one or more of the investment funds. The benefit to which a participant is entitled is limited to the amount of the participant's vested account balance.

Vesting

Participants are immediately vested in their elective contributions and the earnings received on those contributions. Full and immediate vesting will also occur upon attainment of normal retirement age, death, or disability. Participants who leave the Organization before they are fully vested in the Organization's contributions forfeit their non-vested portion. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 33% vested after one year of continuous service, 66% vested after 2 years of continuous service, and 100% vested after three years of continuous service.

Notes Receivable from Participants

Participants may borrow from their account the lesser of \$50,000 or 50% of their vested account balance, but not less than \$1,000. All loans are secured by the remaining balance of the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Any loan must be repaid within five years, unless such loan is for the purchase of a Participant's primary residence, in which case the repayment period may be up to thirty years. Participants may have up to five loans outstanding. Principal and interest are paid ratably through monthly payroll deductions. At December 31, 2023 and 2022 the participant loans had interest rates ranging from 4.25% - 9.5%.

Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance. Unvested amounts are forfeited to the Plan.

A participant has the right to receive all or any portion of their vested account balance upon termination of service or attaining normal retirement age. Participants are allowed in-service and hardship withdrawals under certain conditions as specified by the Plan.

Forfeited Accounts

Forfeitures are first used to reduce employer contributions. Any remaining forfeitures are used to offset Plan administrative expenses. There were no unallocated forfeitures available to offset future employer contributions at December 31, 2023 and 2022. During the years ended December 31, 2023 and 2022, \$45,656 and \$75,376 in forfeitures were used to offset employer contributions and expenses, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at estimated fair value as provided by Bank of America, N.A. The Plan's interest in investments held in the common collective trust are valued at NAV using the practical expedient at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Organization or the Plan at the Organization's discretion.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A., a qualified institution and the trustee of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate to the best of their knowledge and belief:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment income (loss) and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan has notes receivable from participants, which qualify as parties-in-interest to the Plan. The Organization provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset-pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan held no Level 2 or Level 3 investments for the years ended December 31, 2023 and 2022.

Note 6. Plan Termination

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Merrill Lynch. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 9. Subsequent Events

The Plan was amended effective February 1, 2024, which increased the elective deferral limit to 100% of compensation and to allow rollovers from additional qualified plans and annuities, excluding after-tax contributions.

Effective July 15, 2024, Aon Consulting, Inc. became the Plan's trustee and Voya International Trust Company became the Plan's recordkeeper.

Subsequent events have been evaluated through October 3, 2024, which is the date the financial statements were available to be issued.
