Report of Independent Auditors

To the Administrator of Intalco Aluminum Supplemental Unemployment Benefit Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Intalco Aluminum Supplemental Unemployment Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and December 31, 2023 and 2022 and for the period from January 1, 2024 to June 30, 2024, and the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

As discussed in Note 2 to the financial statements, the Benefits Management Committee of Alcoa Corporation approved a plan of liquidation on April 10, 2024, and the Company determined liquidation is imminent. As a result, the Company changed its basis of accounting on April 10, 2024 from the going concern basis to a liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. 1. Description of the Plan

The following description of the Intalco Aluminum Supplemental Unemployment Benefit Plan (the "Plan") provides only general information.

Reference should be made to the Summary Plan Description of the Plan for a summarization of the important features, including eligibility, benefits provisions and compliance with the Employee Retirement Income Security Act of 1974 ("ERISA").

General

The Plan is a trustee welfare benefit plan which was established for the purpose of supplementing state unemployment benefits for qualified hourly employees who are on layoff or short week status. Certain benefits of the Plan are paid through the Alcoa Supplemental Unemployment Benefits Trust for Intalco Union Employees (the "Trust") created and maintained pursuant to a trust agreement between Intalco Aluminum LLC (the "Sponsor") and The Bank of New York Mellon (the "Trustee"). The Alcoa Benefits Management Committee has fiduciary responsibility for the Plan. The Sponsor is responsible for the general administration of the Plan and for carrying out the Plan's provisions.

Benefits and Eligibility

The Plan covers certain employees of Intalco Aluminum LLC. The weekly benefit provided by the Plan is equal to 28 times an employee's hourly earnings, which is based on a 40-hour week, less the amount of state unemployment benefits an employee receives. Additionally, employees may receive \$1.50 for each of not more than four dependents. The Plan participants must apply for the benefit payments on a weekly basis. The maximum number of weeks that an employee can receive benefits is 52.

Termination of the Plan

The Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan or if the operation of the Sponsor in which there are employees covered by the Plan shall be permanently shut down, the assets then remaining in the Trust and the contingent liability shall be subject to all the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement. The provisions with respect to the reduction of weekly and short week benefits which are set forth in Article VIII, Section 5, of the Plan document, shall not thereafter be effective.

The Sponsor and the International Association of Machinist and Aerospace Workers Union (the "Union") agreed to terminate the Plan effective April 10, 2024. As a result of the amendment, the \$650,000 in assets that remained in the Trust (after considering expected payments of outstanding Plan expenses) were distributed to tax-exempt charitable organizations selected by the Union. The distribution occurred on June 14, 2024. The related Trust is expected to be dissolved by December 31, 2024, following payment of outstanding Plan expenses. No current or former employees will be eligible for benefits under the Plan on or after April 10, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") under the accrual method of accounting.

Management determined that the liquidation of the Plan was imminent due to the decision to terminate the Plan and therefore has applied the liquidation basis of accounting to the Plan for the period April 10, 2024 to June 30, 2024. As the Plan's assets were previously reported at fair value, the application of the liquidation basis of accounting did not have a material impact on the Plan's financial statements.

Upon adoption of the liquidation basis of accounting, the Plan recorded the following cumulative effect adjustments to the Statements of Net Assets Available for Benefits in Liquidation as of April 10, 2024:

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of contributions, interest income and benefit payments during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan records investments at fair value pursuant to the provisions of the Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements and Disclosures*. ASC 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan investments consist solely of investments in a bank-administered common/collective trust fund and are valued at the closing net asset value ("NAV") of the fund by the Trustee. Interest income is recorded when earned.

Employer Contributions

The Sponsor is required to make cash contributions to the Trust resulting from calculations based on contributory hours and plan assets specified in Article IV of the Plan document. Reference should be made to the Plan document for more information. No contributions were required in 2023 or 2024 based on this calculation.

Benefit Obligations

Plan obligations at June 30, 2024, December 31, 2023 and 2022 for accumulated eligibility of participants are estimated by the Sponsor based on participants' maximum remaining eligible weeks, and the probability of payment of such benefits.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Trustee, audit, and other administrative expenses are paid by the Plan.

3. Fair Value Measurements

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2023 and 2022.

Common/Collective Trust Funds

The Common/Collective Trust Funds are valued at the NAV of shares held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. The NAV is determined based on the fair value of the underlying assets held by the fund, less its liabilities.

The method described above may produce a fair value not indicative of net realizable value or reflective of future fair values. Furthermore, while the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no unfunded commitments with respect to the Common/Collective Trust Funds held by the Plan. The Plan can transact daily with this fund; however, significant withdrawals from the Common/Collective Trust Funds may be subject to redemption restrictions, at the Trustee's discretion, to the extent that it is determined such actions would disrupt management of the Common/Collective Trust Funds.

4. Benefit Obligations

The Plan did not have a benefit obligation as of June 30, 2024, December 31, 2023 and 2022. There was no activity within the Plan's benefit obligations for the period ended June 30, 2024 and year ended December 31, 2023.

5. Tax Status

The Internal Revenue Service ("IRS") determined and informed the Company by an exemption letter dated February 9, 1970 that the Plan is qualified and the Trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code ("IRC"). The Trust has been amended since receiving the exemption letter; however, the Plan administrator and the Sponsor's tax advisor believe that the Trust is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, they believe the Plan is qualified and the related Trust is tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that would not be sustained upon examination by the IRS. The Plan administrator and the Sponsor's tax advisor analyzed the tax positions taken by the Plan and concluded that as of June 30, 2024, December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. As such, no reserve is required under U.S. GAAP. The Plan is subject to audit by the IRS; however, there are no current IRS audits in progress for any tax periods.

6. Information Certified by Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Bank of New York Mellon, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying Statement of Net Assets Available for Benefits in Liquidation as of June 30, 2024, the Supplemental Schedule H, line 4(j) - Schedule of Reportable Transactions as of June 30, 2024, and the related investment income reflected in the Statement of Changes in Net Assts in Liquidation for the period ended June 30, 2024, the Statement of Net Assets Available for Benefits On-going as of December 31, 2023 and 2022, Note 3, the Supplemental Schedule H, line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2023, and the related investment income reflected in the Statement of Changes in Net Assets Available for Benefits On-going for the year ended December 31, 2023.

7. Related-Party and Party-in-Interest Transactions

At June 30, 2024, December 31, 2023 and 2022, the Plan is invested in funds managed by an affiliate of the Trustee; therefore, these transactions are considered party-in-interest transactions. The Sponsor may pay certain administrative expenses or perform administrative functions on behalf of the Plan; therefore, these transactions are considered party-in-interest transactions. The Plan invests in funds managed by The Bank of New York Mellon. The Bank of New York Mellon is the trustee as defined by the Plan, and therefore these transactions, and expenses paid to The Bank of New York Mellon, qualify as party-in-interest transactions.

8. Risks and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in these financial statements.

9. Subsequent Events

Management has evaluated the events and transactions that have occurred through July 24, 2024, the date the financial statements were available to be issued, and noted no items requiring adjustment of the financial statements or additional disclosures.
