INDEPENDENT AUDITORS' REPORT

To the Plan Sponsor of
RJR Maintenance 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of RJR Maintenance 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of the RJR Maintenance 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement and the Summary Plan Description for a more complete description of the Plan’s provisions.

General: The Plan, which was established October 1, 2022, is a defined contribution profit sharing plan covering eligible employees of RJR Maintenance Group, Inc. (the “Employer”) as defined by the Plan. Eligible employees are described as all employees, that are not union employees or certain non-resident aliens, of the employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration: The administration of the Plan is the responsibility of the Employer. Professional Capital Services, as record keeper, maintains participants’ accounts. Charles Schwab is the custodian of the Plan’s investments.

Contributions: Generally, participants may elect to defer a portion of their compensation to the Plan on a pretax basis pursuant to Internal Revenue Code (IRC) section 401(k) rules and limitations. Eligible participants may also contribute a rollover contribution representing distributions from other qualified plans as defined in the Plan. The Employer makes a matching contribution as per the amount elected in the adoption agreement for eligible participants who are currently employed.

Investment Options: Participants direct the investments of contributions into various investment options, consisting primarily of interests in registered investment companies (mutual funds), offered by the Plan.

Participant Accounts: For all purposes of the Plan, the value of any account established under the plan on behalf of a participant shall be its fair market value as determined on the valuation date coinciding with or immediately preceding the date of benefit payment, withdrawal, or furnishing of statements, whichever is applicable, plus any contributions or other amounts credited to such account subsequent to such valuation dates, less any distribution, expense or other amounts charged to such account subsequent to such valuation date.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in Employer contributions for each Plan year as follows: less than two years – 0%; year two – 20%; year three – 40%; year four – 60%; year five – 80%; and year six – 100%.

Payment of Benefits: Participants are entitled to withdraw their vested balance upon attaining age 59 ½. A participant who becomes disabled as defined in the plan document is eligible for disability retirement.

Termination: The Plan Sponsor has the right under the Plan to modify benefits provided to participants. The Plan may be terminated by the vote of the Board, subject to the provisions set forth in the Agreement and Declaration of Trust and ERISA.

The Plan was terminated effective September 30, 2023 and its net assets transferred to ADP TotalSource Retirement Savings Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Basis of Accounting: The financial statements were prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year. Unrealized gains or losses are the differences between the fair value of the investments held at year-end and those held at the beginning of the year. Realized gains or losses on the sale of investments are based on the historical costs of the individual investments sold for financial reporting purposes, whereas the revalued cost (fair value at the beginning of the year) is used for determining the realized gain or loss for Form 5500 purposes.

Payment of Benefits: Benefit payments to participants are recorded upon distribution.

NOTE 3 – TAX STATUS

The Plan received a letter from the Internal Revenue Service dated June 30, 2020 indicating that this Plan is qualified under Internal Revenue Code section 401.

NOTE 4 – CONCENTRATION OF CREDIT RISK

Financial instruments that subject the Plan to concentration of credit risk include cash and short-term investments. While the Plan attempts to limit any financial exposure, its cash deposit balances may, at times, exceed federally insured limits. Short-term investments are not covered by the Federal Deposit Insurance Corporation.

NOTE 5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 6 – EVALUATION OF SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 9, 2024 the date the financial statements were available to be issued.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's sponsor, RJR Maintenance Group, Inc. pays substantially all the administrative expenses of the Plan.
