Our firm has been engaged to complete an ERISA Section 103(a)(3)(C) audit of the financial statements of Trendwood, Inc. Employee Stock Ownership Plan as of and for the year ended December 31, 2023. This letter is being provided as an “Other attachment” to explain why the Independent Qualified Public Accountant’s Report (IPQA) has not been included with the 2023 Form 5500 filing and Schedule H, Part III, has been left blank.

As of October 9, 2024, the Plan Sponsor is still waiting on a plan amendment from legal counsel, completed compliance testing, and participant allocation reports. While the Plan has been frozen since August 31, 2019, certain plan contributions to fund diversification requests would result in failure of 410(b) testing without a plan amendment to exclude highly-compensated employees or unfreezing the plan to admit additional participants. This amendment has not yet been completed, resulting in a draft census, incomplete compliance testing, and incomplete participant allocation reports. Due to the issues noted above, we have been unable to complete necessary audit procedures in accordance with generally accepted auditing standards.

We have advised the Plan Sponsor that failure to attach the IQPA report will result in the EFAST2 system indicating that there is an error with the filing because, as noted above, submitting the annual return/report without a required IQPA report is an incomplete filing, and may be subject to further review, correspondence, rejection, and assessment of civil penalties.

We have advised the Plan Sponsor that upon receipt and review of the above items and completion of audit procedures in accordance with generally accepted auditing standards, we will issue our IPQA related to the audit of the financial statements of Trendwood, Inc. Employee Stock Ownership Plan as of and for the year ended December 31, 2023. We have recommended to the Plan Sponsor that filing an amended Form 5500 should be considered in conjunction with the Internal Revenue Service’s Delinquent Filer Voluntary Correction Program to minimize penalties and ensure complete correction.
