Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ferrara Candy Company 401(k) Plan for Collective Bargaining Unit Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 18, 2023 and December 31, 2022, and the related statement of changes in net assets in liquidation available for benefits for the short year ended December 18, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ferrara Candy Company 401(k) Plan for Collective Bargaining Unit Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 18, 2023 and December 31, 2022, and for the short year ended December 18, 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of Ferrara Candy Company 401(k) Plan for Collective Bargaining Unit Employees and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

The accompanying December 31, 2022 financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Notes A and C to the financial statements, the trustees of the Plan authorized the termination of the Plan in 2023. The December 31, 2022 financial statements do not include any adjustments that might be necessary upon termination. The Plan has changed its basis of accounting from going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ferrara Candy Company 401(k) Plan for Collective Bargaining Unit Employees' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of the Ferrara Candy Company 401(k) Plan for Collective Bargaining Unit Employees (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all eligible employees of Ferrara Candy Company, Inc., Ferrara Confections, LLC and Ferrara Snacks, LLC (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On March 30, 2018, the Company, along with the Ferrero Group ("Ferrero"), a related party, completed the acquisition of Nestlé USA's confectionary business in which Ferrara purchased Nestlé USA's non-chocolate confectionary brand portfolio and Ferrero purchased Nestlé USA's chocolate confectionary brand portfolio. As a part of this acquisition, certain former Nestle USA employees transferred into the Plan and became eligible to participate in the Plan following the Company's asset acquisition of certain Nestle plants and the transfer of its employees. These employees transferred in as new hires but preserved their original date of hire for vesting purposes and were given the option to rollover existing qualified plan account balances they held in Nestle plans.

On July 28, 2019, the Company, along with Ferrero, completed the acquisition of Kellogg's cookies, fruit snacks, pie crusts and ice cream cones businesses in which Ferrara purchased the fruit snacks portfolio and Ferrero purchased the cookies, pie crusts and ice cream cones portfolio. This resulted in approximately 663 legacy Kellogg Co. employees being transferred into the Plan who became eligible following the Company's asset acquisition of Kellogg Co. plants and the transfer of its employees. These employees transferred in as new hires and were given the option to rollover any existing balances they held in other plans. Rollovers from other plans are 100% vested when brought into the Plan.

During 2022, certain employees were transferred over to the Ferrero Group and related subsidiaries and were no longer eligible for the Plan. A partial plan termination occurred due to a reduction in workforce by more than 20%. Affected account balances became fully vested and employees were given the option to rollover or withdraw any existing balances they held in the Ferrara plans.

PLAN TERMINATION

During 2023, due to having no remaining active employees in the Plan, the trustees of the Plan decided to terminate the Plan. The Plan was terminated effective March 16, 2023. All assets were liquidated and paid to participants during the short year ended December 18, 2023.

CONTRIBUTIONS

Participants may elect to contribute pre-tax earnings and/or Roth contributions up to current Internal Revenue Service ("IRS") regulations. Effective April 1, 2018, former Nestlé Employees and New Legacy Nestlé Confectionary Employees shall not be permitted to make Roth deferrals under the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All employees who are members of a collective bargaining agreement, except non-resident aliens, are eligible to enter the Plan after completing 30 days of service with the Company. Effective July 28, 2019, former Nestle employees, former Kellogg employees, and former Ferrero employees who shall be eligible for the Plan as soon as administratively feasible upon their employment commencement date. Eligible employees can enter the Plan immediately following the date the eligibility requirements are met. Participants may also contribute amounts representing

distributions from other qualified retirement plans. The Plan has auto-enrollment at an initial rate of 3%, with automatic deferral percentage increase up to 6% of compensation. Participants have 90 days to withdraw from the first auto deferral.

The Plan was amended effective December 1, 2018, to revise the definition of eligible compensation, and to provide for a one-time Company discretionary and non-elective contribution to former Nestle employees and new legacy Nestle Confectionary employees.

The Plan was also amended effective July 28, 2019, to provide for a one-time Company discretionary and non-elective contribution to former Kellogg employees and new legacy Kellogg employees. These discretionary, non-elective contributions are referred to as "employer special contributions".

The Company makes a safe harbor employer matching contribution equal to 100% of a participant's elective deferral not exceeding 1% of the participant's compensation, plus 50% of each participant's elective deferrals in excess of 1% but not in excess of 6% of the participant's compensation. Additional amounts may be contributed at the option of the Company's board of directors.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary non-elective contributions and Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is what can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. The vesting schedule for Company contributions beginning on January 1, 2015, was changed to 100% vesting after completing two years of service for the employer safe harbor matching contributions.

Vesting of non-elective contributions varies depending on the group of employees and their affiliated former employer prior to joining the Company as an employee. Vesting ranges from vesting after five years of service to being immediately 100% vested as defined in the Plan document.

Effective December 1, 2018, the Plan was amended for the discretionary and non-elective contributions given to former Nestle employees and new legacy Nestle Confectionary employees. These contributions become 100% vested after three years of service with the Company or an affiliated company. Therefore, these participants are vested at 0% until they complete 3 years of service at which point, they are 100% vested in the discretionary and non-elective contributions made.

VESTING (Continued)

Effective July 28, 2019, the Plan was amended for the discretionary and non-elective contributions given to former Kellogg employees and new legacy Kellogg employees. These contributions become 100% vested after three years of service with the Company or an affiliated company. Therefore, these participants are vested at 0% until they complete 3 years of service at which point, they are 100% vested in the discretionary and non-elective contributions made.

Upon Plan termination, effective March 16, 2023, participants became 100% vested in their accounts.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their account a minimum loan of \$1,000 and up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. The participants may have one loan outstanding at any time.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant or his beneficiary may elect to receive a single lump-sum payment equal to the value of the participant's vested interest. For termination of services for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum payment.

FORFEITED ACCOUNTS

At December 18, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$76,191, respectively. Forfeitures may be used to reduce future employer contributions or pay plan expenses. In 2023, \$39,808 of forfeitures plus lost earnings were reinstated to participant accounts due to the partial plan termination that occurred in 2022. In 2023, approximately \$8,000 of forfeitures were allocated to participant accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, which is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

BASIS OF ACCOUNTING

The financial statements of the Plan as of and for the short year ended December 18, 2023 are prepared using the liquidation basis of accounting in conformity with generally accepted accounting principles. The financial statements of the Plan as of December 31, 2022 are prepared using the accrual basis of accounting in conformity with generally accepted accounting principles.

BASIS OF ACCOUNTING (Continued)

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 18, 2023 and December 31, 2022, no allowance for credit losses has been recorded.

PAYMENT OF BENEFITS

Benefit obligations are recorded when paid.

EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2024, the date which the financial statements were available to be issued.

NOTE C - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan was terminated effective March 16, 2023. Upon Plan termination, participants became 100% vested in their accounts. All assets were liquidated and paid to participants during the short year ended December 18, 2023.

NOTE D - TAX STATUS

The Plan is a non-standardized prototype plan sponsored by Great-West Trust Company, LLC that has been adopted by the Company. The prototype plan obtained its latest opinion letter dated June 30, 2020, by which the Internal Revenue Service has determined and informed the Company that the Plan and related trust, as then designed, were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and there, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal or Illinois taxing jurisdictions. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 18, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 18, 2023 and December 31, 2022, and net appreciation or depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the short year ended December 18, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC (the custodian of the Plan).

NOTE F - FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 18, 2023 and December 31, 2022.

Registered investment companies: Valued at the net asset value (NAV) of shares, which are based on quoted market prices, held by the Plan as of the end of the year.

Common collective trusts: Valued using the practical expedient at the net asset value (NAV) of units held by the Plan as of the end of the year. There were no unfunded commitments, liquidity, or redemption restrictions on these investments.

Stable value fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G – ACCOUNTING CHANGE

MEASUREMENT OF CREDIT LOSSES ON FINANCIAL INSTRUMENTS

As of January 1, 2023, the Plan adopted ASU 2016-13, Financial Instruments- Credit Losses (Topic 326) that replaced the incurred loss model for measuring the allowance for credit losses with a new model that reflects current expected credit losses (CECL) that are expected to occur over the lifetime of the underlying accounts. The CECL methodology is applicable to certain financial assets that are measured at amortized costs. The Plan adopted the changes in accounting for credit losses using a modified retrospective method. Under the modified retrospective approach, the Plan had no change to the opening balances that included the date of initial application.
