Report of Independent Auditors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Global Views Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 26, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to December 26, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Global Views Profit Sharing Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained a certification from a qualified institution as of December 26, 2023 and December 31, 2022, and for the period from January 1, 2023 to December 26, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Global Views Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Global Views Profit Sharing Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

General

The following description of the Global Views Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. The Plan was a profit sharing plan covering all eligible employees of Global Views, LP (the “Company” or “Plan Sponsor”). The Plan was intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Restatement

Effective May 1, 2022, the Plan was restated to bring the Plan into compliance with the requirements of the Cumulative List (Notice 2017-37).

SECURE 2.0 Act

On December 29, 2022, the SECURE 2.0 Act was signed into law to enhance the retirement savings system. Principle areas of the act addressed automatic enrollment, required minimum distributions (“RMD”), and catch-up contributions. Effective January 1, 2023, the age requirement for minimum distributions was raised to 73 from 72 for any participant who turns 72 on or after January 1, 2023.

Plan Termination

As of December 26, 2023, all assets were liquidated from the Plan. Refer to Note 7 for information about the Plan termination.

Eligibility

An employee had to complete two years of service and attain age 21 to be eligible to participate in the Plan. Employees who were classified as commission-only by the employer were excluded from participating in the Plan. Employees had to be credited with at least 1,000 hours of service at the end of their first 12 consecutive months of employment to complete the service requirement. Employees could begin participating at the earlier of the first day of the plan year or the first day of the seventh month of the plan year coinciding with or following the date they satisfied the Plan’s eligibility requirements.

Contributions

Participants could rollover amounts representing distributions from other qualified defined contribution plans. The Company could make an annual discretionary profit sharing contribution to each eligible participant in an amount determined and allocated at the discretion of the Company. For the period from January 1, 2023 to December 26, 2023, the Company made no profit sharing contributions.

The Plan did not permit participant salary deferral contributions.

Vesting

Participants were immediately vested in the Company’s profit sharing contributions.

Participant Accounts

Each participant's account was credited with their portion of the Company profit-sharing contributions and actual earnings thereon. Earnings were allocated to each participant's individual fund account based on the earnings of the individual investment options chosen by the participant. Participants could make changes to their investment allocation at any time.

Notes Receivable from Participants

The Plan did not permit participants to take out a loan from their account balance.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant could elect to receive an amount equal to the value of the participant's vested interest in their account, in the form of a lump sum, periodic installments, or partial withdrawal, subject to Plan provisions. For termination of service due to other reasons, a participant could receive the value of the vested interest in their account in a lump-sum distribution or via periodic installment payments, subject to minimum balance distribution requirements. A participant could withdraw part of the balance of their salary deferrals from their account upon attainment of age 65, subject to Plan provisions. Hardship withdrawals were not permitted. Participant consent was not required for distributions to separated participants with account balances less than \$1,000.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting in accordance with auditing principles generally accepted in the United States ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in pooled separate accounts were reported at fair value. The Plan's fair value was the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. Refer to Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Investments held by a defined contribution plan were required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value was the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recognized on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to distributions from participants were charged directly to the participants' accounts and were included in administrative expenses. Investment-related expenses were included in net appreciation (depreciation) of the fair value of investments.

Recently Adopted and New Accounting Principles

In June 2016, the FASB issued ASU No. 2016-13, *Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, and subsequent amendments to the initial guidance, ASU 2019-10. This accounting standard changes the methodology for measuring credit losses on financial instruments and the timing of when such losses are recorded. ASU No. 2016-13 is effective for fiscal years, and interim periods within those years, beginning after December 15, 2022. The Plan adopted the provisions of ASU 2016-13 for the period from January 1, 2023 to October 5, 2023. The adoption of this standard did not have a material impact on the Plan's financial statements.

Subsequent Events

Subsequent events have been evaluated through the date of the report of independent auditors, which is the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

3. Information Prepared and Certified by Custodian (unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 26, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, dividend, and interest income, for the period from January 1, 2023 to December 26, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Minnesota Life Insurance Company, the custodian of the Plan.

As permitted under such election, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

4. Fair Value Measurements

The fair value hierarchy prioritizes the inputs used to measure fair value, giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that were observable for the asset or liability;
- Inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input could be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 26, 2023, and December 31, 2022.

Pooled separate accounts: Valued at the net asset value (“NAV”) of the units held by the Plan at year-end based on information reported by the custodian. NAV was used as a practical expedient for fair value. The NAV of each of the separate accounts was calculated in a manner consistent with the U.S. GAAP for investment companies and was determinative of their fair value and represented the price at which the Plan would have been able to initiate a transaction. Several of the separate accounts invested in publicly quoted mutual funds or actively managed stocks. Some of the separate accounts also invested in fixed income securities. The fair value of the underlying mutual funds or stocks and of the underlying securities, which was based on quoted prices of similar assets, was used to determine the NAV of the separate account which was not publicly traded

The methods described above might have produced a fair value calculation that might not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

The following table summarized investments for which fair value was measured using the net asset value per share practical expedient. There were no participant redemption restraints for these investments; the redemption nature was applicable only to the Plan.

5. Guaranteed Investment Contract

The Plan offered a guaranteed investment contract, the Minnesota Life Return Account, with Minnesota Life Insurance Company. The contract was considered fully benefit responsive. The custodian maintained the contributions in a general account, which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract was included in the financial statements at contract value as reported to the Plan by the custodian. Contract value was equal to contributions received plus interest credited, less payments, withdrawals, or transfers. The interest rate credited on the unallocated annuity contract varied based on a formula determined by the Plan's custodian, but was not less than a guaranteed floor interest rate determined annually, which was 1.50% for the period from January 1, 2023 to December 26, 2023. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The custodian could not terminate the contract at any amount less than contract value. The following represented the disaggregation of contract value between types of investment contracts held by the Plan. In a traditional investment contract, the Plan owned only the contract itself, not the underlying assets.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that caused a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Plan management believed that the occurrence of events that would cause the Plan to transact at less than contract value was not probable. Refer to Note 7 for information about the Plan termination.

6. Related Party and Party-In-Interest Transactions

Certain Plan investments were shares of pooled separate accounts managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company was the custodian of the Plan. Therefore, these transactions qualified as party-in-interest transactions.

Fees incurred by the Plan for investment management services were included in net appreciation (depreciation) in fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. For the period from January 1, 2023 to December 26, 2023, the Plan made payments to the custodian and third-party administrator totaling \$8,317. The Plan Sponsor paid directly any other fees related to the Plan's operations.

7. Plan Termination

On May 22, 2023, Plan management resolved to terminate the Plan. Upon termination, all participants with an account balance as of the date of termination became 100% vested. Participants with account balances were provided with notification of the termination and were provided instructions for processing distribution of their account balance. Plan management believes that the use of the liquidation basis of accounting would not result in a material difference to the Plan's financial statements. As of December 26, 2023, all Plan assets were distributed to the affected participants.

8. Tax Status

The Plan used a prototype plan document sponsored by Minnesota Life Insurance Company. Minnesota Life Insurance Company received an opinion letter from the IRS dated June 30, 2020, which stated that the prototype document satisfied the applicable provisions of the IRC. The Plan itself had not received a determination letter from the IRS. However, the Plan's management believed that the Plan was currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax was included in the Plan's financial statements.

U.S. GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress. The plan administrator believed it was no longer subject to income tax examinations for years prior to 2020.

9. Risks and Uncertainties

The Plan offered a number of investment options to participants that were exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it was at least reasonably possible that changes in the values of investment securities in the near term could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits.
