Emphasis of Matter - Basis of Accounting

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the CAMC Health System, Inc. Master Health and Welfare Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

GENERAL - Effective January 1, 1996, Camcare, Inc. (Camcare) adopted the Camcare, Inc. Master Health and Welfare Plan (the Plan). The Plan sponsor's name was changed during 2001 to CAMC Health System, Inc. The Plan has been renamed the CAMC Health System, Inc. Master Health and Welfare Plan. The Plan represents a merger of several individual health and welfare plans, including:

- Health Care Plan
- Health Care Assistance Plan
- Dependent Care Assistance Plan
- Income Protection Plan

The Plan is a health and welfare benefit plan, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), in which all full-time employees, permanent part-time employees, their spouses and certain dependents of CAMC Health System, Inc. and affiliated entities, including Charleston Area Medical Center, Inc. (CAMC), collectively referred to as the Sponsor or the Company, are eligible to participate.

The Sponsor funds all of the Plan benefits outside of the Plan trust except for postretirement benefits. The trust held the plan assets specifically related to employee deferrals for postretirement benefits, but was closed in January 2003.

BENEFITS - The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short- and long-term disability benefits, accident insurance, critical illness insurance, hospital indemnity insurance, and accidental death and dismemberment benefits. The Plan also provides supplemental medical and dependent care benefits. Certain retired employees are entitled to similar health benefits (in excess of Medicare coverage). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

HEALTH CARE PLAN - The Plan provides medical, dental and pharmacy benefits, all of which are self-insured. The Plan also provides for vision benefits, which are insured benefits. All Plan participants' health insurance is provided by CAMC. Highmark Blue Cross and Blue Shield, a preferred provider organization (PPO) acts as the third-party administrator for the medical benefits and Navitus Health Solutions, LLC acts as the pharmacy benefit manager for the pharmacy benefits. The Plan also offers a High Deductible Health Plan (HDHP), with the option to contribute to a Health Savings Account (HSA) and Limited FSA. The dental and vision plans are administered by Delta Dental (Delta) and VSP vision, respectively. For the self-insured benefits, the PPOs pay claims directly to or on behalf of participants and are then reimbursed from the general assets of the Plan Sponsor. CAMC, related affiliated entities, and all participants contribute amounts toward the cost of the Plan as necessary to pay for the benefits provided. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The medical benefits provided by the Plan include costs related to inpatient services, outpatient services, and mental and nervous disorders subject to certain deductibles as described in the Plan document. Participating employee coverage begins on the first day of the month following 30 days of employment.

Employees who enroll in the HDHP will be offered the option to contribute to a HSA and a Limited FSA. CAMC contributes \$200 to an individual HSA and \$400 to a Family HSA.

The Plan provides dental benefits, which include costs related to routine, major, and orthodontic treatment. The provisions of the Plan limit dental benefits to \$1,500 per Plan year for routine and major treatment and a separate \$1,500 lifetime maximum for orthodontic treatment.

Retired employees are eligible, as defined in the Plan, for health care coverage. Health insurance is provided by CAMC. During 1998, the Camcare Board of Directors approved a change in the Plan provisions whereby CAMC will no longer participate in the premium payment for those employees who did not make their election to participate in the post-retirement health plan by December 31, 1998 (see Note 2).

Effective January 1, 2006, the health care plan was amended to eliminate most retiree medical and drug benefits.

STOP-LOSS COVERAGE - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

INSURED BENEFITS - The Plan provides basic life insurance benefits and long-term disability coverage, the premiums for which are paid fully by the Sponsor. Supplemental and dependent life insurance, vision coverage, accident insurance, critical illness insurance, hospital indemnity insurance, accidental death and disbursements benefits (basic, supplemental, and spousal), and disability benefits are also provided by the Plan. Annual insurance contracts are purchased for these insured benefits. Premiums for basic life insurance programs and long-term disability coverage for participants are paid to the insurance company from the general assets of the Company. Premiums for all other insured benefits are paid by the participants.

HEALTH CARE ASSISTANCE AND DEPENDENT CARE ASSISTANCE - The Plan provides supplemental medical and dependent care benefits to all eligible employees. The Plan allows eligible employees to elect to be reimbursed tax free for qualified medical expenses and dependent care costs subject to a specified ceiling. Eligible employees must elect these coverages prior to January 1 of each Plan year.

The Sponsor funds the health care assistance and dependent care assistance benefits on an as-needed basis. Total combined employee and employer annual contributions per participant for Health Care Assistance and Dependent Care Assistance are limited to \$2,850 and \$5,000, respectively.

INCOME PROTECTION COVERAGES - The Sponsor has purchased insurance to provide long-term disability benefits to Plan participants and the Sponsor funds sick leave, defined by the paid-time-off (PTO) policy, and short-term disability on an as-needed basis.

The benefits provided by the Plan, which were designed to cover an employee's disability resulting from a non-occupational injury or disease, consist of three integral parts: sick leave per the PTO policy, short-term disability, and long-term disability. All full-time and certain part-time employees, as defined, are eligible for long-term disability on the first day of the month following 30 days of employment in a benefit eligible position. All new hires and certain recently eligible employees, as defined, are eligible for short-term disability on the first day of the month following 30 days of employment in a benefit eligible position.

The obligation related to a grandfathered group of participants receiving long-term disability benefits prior to the Income Protection Plan is included within the benefits payable and benefits incurred but not reported on the accompanying statements of plan benefit obligations - modified cash basis. The participants within the grandfathered group were receiving long-term disability benefits prior to December 31, 1996, or were totally disabled but not receiving benefits at that time due to a required 90-day waiting period before benefits could be received. This group is not covered under the insurance purchased by the Sponsor. The actuarial present value of the benefit obligation was determined by an actuary for the year 2012, and progressed by the Company for 2020. It is the amount that results from applying actuarial assumptions to long-term disability benefits data to estimate future annual incurred claims per participant, and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment between the valuation date and the expected date of payment. For 2021, the Company used a different method to estimate the liability. Due to the amount of minimal participants remaining, the Company was able to calculate the total remaining liability based on when each participants' final payment would be. The benefit obligation as of December 31, 2023 and 2022 was \$0 and \$34,046, respectively.

CONTRIBUTIONS - In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and of accidental death and dismemberment insurance programs based on the current group rate premium cost. The Company pays the full cost of basic life insurance, long-term disability insurance, and stop-loss insurance. The Plan Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefits is funded by the Plan Sponsor on a pay-as-you-go basis.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING - The accompanying financial statements are prepared on the modified cash basis of accounting. Such method includes the recording of employee contributions receivable and excludes the recording of employer contributions receivable, stop-loss refunds receivables, pharmacy rebate receivables, prepaid expenses, accounts payable, and other accrued expenses. The accompanying financial statements are not intended to be presented in accordance with accounting principles in the United States of America.

USE OF ESTIMATES - The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, the disclosure of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

PAYMENT OF BENEFITS - Premiums paid are recorded as benefit insurance premiums in the accompanying statements of changes in net assets available for benefits - modified cash basis. Claim payments are recorded when funds are remitted to the third-party claims processors. These payments are recorded as benefits paid to or on behalf of participants in the accompanying statements of changes in net assets available for benefits - modified cash basis.

CONTRIBUTIONS - Employer contributions are recognized as revenues by the Plan when contributions are made, and employee contributions are recognized when they become a receivable to the Plan.

STOP LOSS - Premiums for stop-loss insurance are included in benefit insurance premiums in the accompanying statements of changes in net assets available for benefits - modified cash basis for the years ended December 31, 2023 and 2022. Stop-loss refunds totaling \$0 and \$47,965 have been netted with claims paid in the accompanying statements of changes in net assets - modified cash basis for the years ended December 31, 2023 and 2022, respectively.

REBATES - Pharmacy rebates are recorded when received and are netted against claims paid. Effective January 1, 2020 Navitus Health Solutions (Navitus) replaced Highmark Blue Cross and Blue Shield as the pharmacy benefit manager. Navitus calculates pharmacy rebates in proportion to the Plan's pharmacy utilization of Covered Products as compared to all other Navitus clients with similar Plans, and as specified by the criteria established by the pharmaceutical manufacturer. Navitus pays pharmacy rebates received from manufacturers directly to the Plan on a pass-through basis. Pharmacy rebates of \$5,754,726 and \$2,058,003 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits - modified cash basis for the years ended December 31, 2023 and 2022, respectively.

HEALTH CARE ASSISTANCE AND DEPENDENT CARE ASSISTANCE - Included in the accompanying statements of net assets available for benefits - modified cash basis are amounts available to reimburse participants for qualifying medical and dependent care expenses as of December 31, 2023 and 2022, totaling \$181,298 and \$280,639, respectively. Claims incurred before plan year-end that were submitted after year-end (but before the date defined by the plan agreement) totaled \$110,192 and \$155,990 relating to 2023 and 2022, respectively. Forfeited amounts were used by the Company to offset Company contributions in the year forfeited.

BENEFITS PAYABLE AND INCURRED BUT NOT REPORTED - Plan obligations at December 31, 2023 and 2022 for health claims payable and estimated health claims incurred by active participants but not reported at those dates are estimated by the Plan's management based on the Plan's historical claim experience. Because these claims are typically paid within one year of the date incurred, such estimated amounts reported in the accompanying statements of plan benefit obligations - modified cash basis are not discounted. Total estimated health claims incurred by active participants but not reported are \$2,715,906 and \$1,952,173 as of December 31, 2023 and 2022, respectively, and health claims prepaid and payable are (\$51,088) and \$22,212 as of December 31, 2023 and 2022, respectively. These amounts are only paid by the Plan if claims are submitted and approved for payment.

POSTRETIREMENT BENEFITS - The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred premiums per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, 6.50% and 6.75% annual rates of increase in the per capita cost of covered health care benefits were assumed for 2023 and 2022, decreasing .25% until reaching 4.50% in 2032, and to remain at that level thereafter.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2023 and 2022, by \$97,956 and \$75,457, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the benefit obligations.

NOTE 3 - ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statements of changes in net assets available for benefits - modified cash basis as benefit contract administrator fees. All other administrative expenses of the Plan are paid by the Sponsor. In addition, the Sponsor performs certain administrative functions at no cost to the Plan.

NOTE 4 - TAX STATUS

The Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain the tax-exempt status. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified as of December 31, 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 5 - BENEFIT OBLIGATIONS

It is expected that the Plan deficiency of benefit obligations over net assets will be funded through future contributions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the Plan assets will be used to pay all proper pending claims for benefits outstanding as of the date of termination and claims incurred up to the date of termination, subject to ERISA, and no assets may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 7 - RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, healthcare inflation rates, and applicable participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.


NOTE 8 - SUBSEQUENT EVENTS
