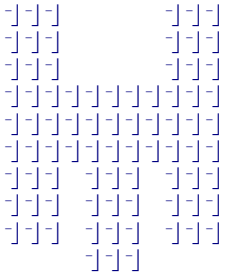

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of  
St. Andrews Country Club 401(k) Plan  
Boca Raton, Florida

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of St. Andrews Country Club 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of St. Andrews Country Club 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of St. Andrews Country Club 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about St. Andrews Country Club 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Description of Plan

The following description of St. Andrews Country Club 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan covering all employees of St. Andrews Country Club, Inc. (the "Club"), except employees covered under a collective bargaining agreement and non-resident aliens, who have attained 21 years of age and provided at least 60 days service to the Club. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 2017, and restated in its entirety on January 1, 2022, as required by Internal Revenue Service's (IRS) restatement cycle.
- b) *Plan Administration* – The Plan is administered by Definiti, LLC and The Fiduciary Studio, LLC, third-party administrators (TPA's). The Plan's trustees are members and/or employees of the Club. As of December 31, 2023 and 2022, the custodian and party which directs the custody and management of the Plan's assets is Transamerica Financial Life Insurance Company (Transamerica).
- c) *Contributions* – Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and as subject to limitations defined by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Club, at its discretion, may make matching contributions. The Club currently matches 100% of the first 4% of the employee compensation deferrals.
- d) *Participant Accounts* – Each participant's account is credited with participant's contribution, the employer's matching contribution and Plan earnings.
- e) *Vesting* – Participants are immediately vested in their salary deferral contributions and rollovers, plus actual earnings thereon. Vesting in the Club's contributions is based on years of credited service. A participant becomes 100% vested in such contributions after 6 years of credited service or immediately upon death or disability.
- f) *Administrative Expenses* – The Plan Sponsor has elected to pay the administrative costs associated with Plan operations and compliance. Individual participants pay for loan fees, investment fees, assets charges, and associated expenses.
- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered in the Transamerica program and determined by the Plan Administrator. Participants may change their investment options via phone or internet access to Transamerica at any time.

1. **Description of Plan, continued**

- h) *Participant Notes Receivable* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. No loan made be made from Roth deferral contributions. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loan terms range from 1-5 years. Loans made for the purchase of a primary residence may extend beyond 5 years. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the loan administrator at the time the loan is taken (currently Prime Rate plus 2%). The interest rate on participant loans receivable as of December 31, 2023 and 2022 range from 5.25% to 10.50%. Principal and interest is paid ratably through bi-weekly payroll deductions. Participant loans are reported at their unpaid principal balances plus any accrued interest. The loan balances are secured by the participants' investment accounts, therefore, no allowance for uncollectible loans was deemed necessary. For purposes of presentation on the schedule of assets held for investment purposes, the participant notes receivable are presented as part of the investments in the Form 5500, and are referred to as participant loans.
- i) *Payments of Benefits* – Upon retirement, disability, death, termination of employment, or attainment of age 65, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. In-service distributions are permitted for employees attaining age 59 ½. Hardship distributions are also permitted from all accounts that are fully vested.
- j) *Forfeited Accounts* – Forfeitures on non-vested accounts may be used to pay plan expenses or to reduce future employer contributions. During the year ended December 31, 2023, \$21,024 was forfeited by employees and \$24,498 was applied to administrative fees. There was \$28,520 and \$36,457 of forfeited non-vested accounts as of December 31, 2023 and 2022, respectively.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. **Summary of Significant Accounting Policies, continued**

- c) *Valuation of Investments and Income Recognition* – Investments in registered investment companies (i.e., mutual funds) are valued at quoted market price of a national security exchange on the last business day of the year, of units held by the Plan at year end. Investment options that do not have readily available market quotations are valued according to quotations from the custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.
- d) *Payment of Benefits* – Benefits are recorded when paid.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rate, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Additionally, the financial position of the Plan Sponsor, St. Andrews Country Club, Inc., may have a significant impact on the Plan. Specifically, these include the ability of the Plan Sponsor to continue to make contributions to the Plan and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan and the Plan assets include legislation or regulations established by the Internal Revenue Service, ERISA, and/or Department of Labor (DOL).

3. **Fair Value Measurements**

Financial Accounting Standard Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**3. Fair Value Measurements, continued**

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions provide the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023:

- a) *Mutual funds* – Valued at quoted market price of a national security exchange on the last business day of the year, of units held by the Plan at year end.

**4. Information Certified by the Plan’s Custodian**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica, the custodian, has certified as of December 31, 2023 and 2022, that the data included in the accompanying financial statements and supplemental schedule is complete and accurate. The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**5. Plan Termination**

Although the Club intends the Plan to be permanent and continuing, the Club has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and accrued benefits, to the extent funded or required to be funded, must be distributed to the participants.

**6. Tax Status**

The Plan is utilizing a Non-Standardized Pre-Approved Profit-Sharing Plan document (Profit-Sharing Plan) provided by its TPA, Definiti, LLC. The Profit-Sharing Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS's Cycle 3 restatement. The restated Profit-Sharing Plan received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Subsequent Events**

The Plan's management has evaluated subsequent events through October 8, 2024, the date on which the financial statements were available to be issued, and determined no additional disclosures were required to be presented in these financial statements.
