## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Virginia Mason Medical Center 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## Notes to Financial Statements

December 31, 2023

### **1. Plan Description**

The following description of the Virginia Mason Medical Center 403(b) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

#### **General**

The Plan is a defined contribution plan established by Virginia Mason Medical Center (the Employer or Plan Sponsor) under the provisions of Section 403(b) of the Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement, for the benefit of eligible employees of the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

All employees are eligible to participate in the Plan upon date of hire.

#### **Plan Administration**

The Plan was administered by the Benefits Administrative Committee of the Plan Sponsor until April 28, 2022, when the administration of the Plan was moved to the CommonSpirit Health Retirement Plans Sub-committee (the Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to CommonSpirit Health's Human Resources and Compensation Committee of the Board of Stewardship Trustees. Fidelity Management Trust Company (Fidelity) is trustee, and Fidelity Investments is record-keeper for the Plan. Principal Life Insurance Company (Principal) serves as custodian.

#### **Contributions**

Participants may elect to contribute up to 80% of pretax eligible compensation, as defined in the Plan, subject to certain limitations under the IRC. Eligible participants who have attained age 50 may elect an additional catch-up contribution up to \$7,500, subject to certain limitations under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

#### **1. Plan Description (continued)**

##### **Vesting and Forfeitures**

Participants are fully vested in their account balance.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the allocations of plan earnings and losses and is charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined in the plan agreement, and investment elections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### **Benefits**

A participant or beneficiary is eligible to receive benefits as follows:

- Upon separation of service
- On reaching age 59 1/2
- Upon being determined to be disabled
- Upon the death of the participant

The Plan provides for either lump-sum distributions equal to the participant's vested account balance or annuity options for the distribution of benefits. For termination of service with vested benefits of \$1,000 or less, a participant or beneficiary will automatically receive the value of the account as a lump-sum distribution.

##### **Hardship Withdrawals**

Under certain conditions, participants, while still employed by the Employer, are permitted to withdraw, in a single sum, a portion of their account balance. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster cleanup on the participant's principal residence, or to prevent eviction or foreclosure from the participant's principal residence.

### **1. Plan Description (continued)**

#### **Participant Loans**

A participant may borrow 50% of his or her account balance up to a maximum of \$50,000. The minimum loan amount is \$1,000. Loans are repayable through automated clearinghouse electronic loan repayment service over periods ranging up to five years, unless the loans are used to acquire a principal residence, in which case the loan may not exceed 15 years. Loans are secured by the balance of the participant's account. The interest rate is determined by the plan administrator based on the prime rate plus 1.00% and is fixed over the life of the note.

#### **Administrative Expenses**

Administrative expenses include participant loan fees, short-term trading fees generated by participant requested transactions, and fees for overnight mailing requested by participants. These fees are paid by the participants who incur them. The Plan Sponsor pays expenses that are not paid by the Plan.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct contributions to any of the registered investment company funds offered by the Plan, guaranteed investment contracts issued by Principal and Variable Annuity Life Insurance Company, and investments through the Fidelity BrokerageLink accounts. Participants may change their investment options and transfer amounts between funds at any time.

Fidelity BrokerageLink is a service allowing participants to invest in securities other than their standard plan options. Through Fidelity BrokerageLink, participants may hold a wide variety of registered investment company funds.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 7 for further discussion and disclosures related to fair value measurements.

Shares of registered investment company funds are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end. BrokerageLink securities include common stocks and are valued at quoted market prices. Cash equivalents consist of money market funds securities that are valued at fair value based on the reported closing price.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable From Participants**

Participant loans are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Risks and Uncertainties**

The plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported on the statements of net assets available for benefits.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Other Revenue**

Other revenue represents revenue received by the trustee in connection with plan services that exceeds the agreed-upon compensation. The Plan's trustee has a revenue sharing agreement with the Plan wherein the excess of revenues over the agreed-upon compensation will be allocated to the accounts of eligible participants. In years where there is no revenue sharing, the ERISA expenses will result in a reduction of the Plan's net assets. In years where there is revenue sharing, the ERISA expenses will be allocated to participant accounts as negative expenses.

#### **3. Information Certified by Custodians**

The following information included in the financial statements and supplemental schedule was provided and certified by Fidelity and Principal, the trustee and custodian of the Plan, respectively, as complete and accurate:

- Investments at fair value
- Investments at contract value
- Notes receivable from participants
- Interest income and dividend income
- Interest on notes receivable from participants

#### **4. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, or contributions are completely discontinued, participants become fully vested with respect to benefits accrued to the date of such termination or discontinuance.

#### **5. Party-in-Interest and Related-Party Transactions**

Certain plan investments are managed by Fidelity and Principal. Fidelity and Principal are the custodians as defined in the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### **6. Tax Status**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service dated August 7, 2017, stating that the written form of the underlying pre-approved plan document is qualified under Section 403(b) of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 403(b) of the IRC, and, therefore, the related custodial accounts and tax-deferred annuities are tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related custodial accounts and tax-deferred annuities are tax-exempt.

#### **6. Tax Status (continued)**

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Fair Value Measurements**

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date. Registered investment company funds, money market funds, and common stocks are included in this category.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability used when little or no market data is available. The Plan has no investments included in this category.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The financial statements as of and for the years ended December 31, 2023 and 2022, do not include any nonrecurring fair value measurements relating to assets or liabilities.

#### 8. Annuity Contracts

The Plan provides participants with two fixed annuity contract investment options that are fully benefit responsive – one through the Principal Life Insurance Company and one through the Variable Annuity Life Insurance Company. These contracts meet the fully benefit-responsive investment contract criteria and are, therefore, reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

#### **8. Annuity Contracts (continued)**

Contract value represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses, if any.

The funds are supported by the Principal Life Insurance Company general account and the Variable Annuity Life Insurance Company general account, and have no maturity date. If all participants were eligible for a distribution of their full accounts from the Plan on the reporting date, the amount payable on demand on the reporting date would be the contract value. There were no reserves against contract value for credit risk on the contract issuers or otherwise.

The crediting interest rate is based on a formula established by the contract issuer and is reviewed on an annual basis for resetting. The crediting interest rate contractually guaranteed is credited to participant account balances. There are no unfunded commitments from the Plan. For the years ended December 31, 2023 and 2022, the minimum interest rate for Principal Life Insurance Company contract was 1.00% and the crediting interest rate was 2.83% and 2.20%, respectively. For the year ended December 31, 2023, the minimum interest rate for the Variable Annuity Life Insurance Company contract was 1.25%.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Principal Life Insurance Company and the Variable Annuity Life Insurance Company do not specify any events that would limit the ability of the Plan to transact at contract value with the issuer or any events that would allow the issuer to terminate the contracts and settle for an amount different from contract value.
