Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Virginia Mason Medical Center Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2023 (referred to as the “supplemental schedule”), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

December 31, 2023

1. Description of the Plan

The following description of the Virginia Mason Medical Center Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Virginia Mason Medical Center (the Employer or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

For plan years prior to 2017, employees who were at least 21 years of age, except those in an excludable group as defined by the Plan, were eligible on the first day of the month after completing one year of service, as defined in the Plan. For the 2017 plan year and subsequent plan years, employees who are at least 21 years of age and not in an excluded group are eligible on the first day of the month after completing 1,000 hours during their first 12 months of employment or a subsequent calendar year. Participants must be employed by the Employer on the last day of the year and complete 1,000 hours of service in the year to receive the employer contributions for that year, except in the case of termination of employment during the year due to disability, death, or retirement on or after age 65.

Plan Administration

The Plan was administered by the Benefits Administrative Committee, which is a committee of the Board of Directors of the Plan Sponsor until April 28, 2022, when the administration of the Plan was moved to the CommonSpirit Health Retirement Plans Sub-committee (the Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to CommonSpirit Health's Human Resources and Compensation Committee of the Board of Stewardship Trustees. Fidelity Management Trust Company (Fidelity) is trustee, and Fidelity Investments is record-keeper for the Plan. Principal Life Insurance Company (Principal) serves as custodian.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Contributions

The Employer contributes an amount for each participant based on the Plan's contribution formula, as follows:

- 3.5% of the participant's eligible compensation up to the Social Security taxable wage base through the fifth year of service. Beginning with the sixth year of service, the contribution percentage for this portion is increased to 6.3%.
- 9.2% of the participant's eligible compensation in excess of the Social Security taxable wage base, up to \$180,000, through the fifth year of service. Beginning with the sixth year of service, the contribution percentage for this portion is increased to 12.0%.

The Employer funds the contributions annually subsequent to year-end.

Eligible compensation includes all payments before payroll deductions made as remuneration for services during the plan year, as defined in the Plan. Excluded are contributions by the Employer for social security, group insurance, medical and pension benefits, disability, severance pay, and pay in lieu of benefits. Total annual additions to the Plan, as defined in the Plan, for a participant are subject to certain limitations under the Internal Revenue Code (IRC).

Effective January 1, 2004, voluntary participant contributions are not allowed under the Plan.

Participant Accounts

Each participant's account is credited with the allocations of (a) the Employer's contribution and (b) plan earnings and losses and is charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined in the plan agreement, and investment elections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

For the 2017 plan year and subsequent plan years, a participant has a forfeitable interest in employer contributions and earnings thereon until completing three years of service, at which time the participant vests 100%.

1. Description of the Plan (continued)

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to numerous Fidelity and other registered investment company funds and collective investment trusts offered by the Plan, guaranteed investment contracts issued by Principal and Variable Annuity Life Insurance Company, and investments through the Fidelity BrokerageLink accounts. Through Fidelity BrokerageLink, participants may hold a wide variety of securities such as stocks, corporate bonds, zero-coupon bonds, U.S. treasury securities, mortgage securities, U.S. government agency bonds, certificates of deposit, taxable unit investment trusts, foreign securities, and registered investment company funds. Participants may change their investment options and transfer amounts between funds at any time.

Participant Loans

A participant may borrow 50% of his or her account balance up to a maximum of \$50,000. The minimum loan amount is \$1,000. Loans are repayable through automated clearinghouse electronic loan repayment service over periods ranging up to five years, unless the loans are used to acquire a principal residence, in which case the loan may not exceed 15 years. Loans are secured by the balance of the participant's account. Under the terms of the plan agreement, loans bear a reasonable rate of interest determined by the local prevailing rate. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

A participant or beneficiary is eligible to receive benefits as follows:

- On reaching age 65
- On reaching age 55 and having elected early retirement
- Upon being determined to be disabled
- Upon death of the participant

A participant is also allowed to make withdrawals of voluntary employee contributions prior to retirement.

1. Description of the Plan (continued)

In the event a participant's employment is terminated, the participant will receive benefits in an amount equal to the nonforfeitable interest in employer and voluntary employee contributions, plus net accumulated earnings.

The Plan provides for either lump-sum distributions equal to the participant's vested account balance or annuity purchase options for the distribution of benefits. For termination of service with vested benefits of \$1,000 or less, a participant or beneficiary will automatically receive the value of the vested account as a lump-sum distribution.

Forfeitures

At December 31, 2023 and 2022, unallocated forfeitures totaled approximately \$7,500 and \$43,000, respectively. Forfeitures totaling \$20,006 and \$72,278 were used to pay for administrative expenses at December 31, 2023 and 2022, respectively. Forfeitures totaling \$74,996 and \$0 were used to reduce employer contributions funded in 2023 and 2022, respectively.

Administrative Expenses

Administrative expenses include participant loan fees, short-term trading fees generated by participant requested transactions, and fees for overnight mailing requested by participants. These fees are paid by the participants who incur them. The Plan Sponsor pays expenses that are not paid by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 7 for further discussion and disclosures related to fair value measurements.

Shares of registered investment company funds and collective investment trusts are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end. BrokerageLink securities include U.S. government securities, common stocks, preferred stock, and corporate bonds and notes, and are valued at quoted market prices. Life insurance policies are valued based on the cash surrender value as reported by the insurance companies. Cash equivalents consist of money market funds, which are valued at fair value based on the reported closing price.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Participant loans are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

Risks and Uncertainties

The plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported on the statements of net assets available for benefits.

2. Summary of Significant Accounting Policies (continued)

Payment of Benefits

Benefits are recorded when paid.

Other Revenue

Other revenue represents revenue received by the trustee in connection with plan services that exceeds the agreed-upon compensation. The Plan's trustee has a revenue sharing agreement with the Plan wherein the excess of revenues over the agreed-upon compensation will be allocated to the accounts of eligible participants. In years where there is no revenue sharing, the ERISA expenses will result in a reduction of the Plan's net assets. In years where there is revenue sharing, the ERISA expenses will be allocated to participant accounts as negative expenses.

3. Information Certified by Custodians

The following information included in the financial statements and supplemental schedule was provided and certified by Fidelity and Principal, the trustee and custodian of the Plan, respectively, as complete and accurate:

- Investments at fair value
- Investments at contract value
- Notes receivable from participants
- Interest and dividend income
- Interest on notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Investment information included in Note 7, excluding level designations
- Schedule of assets (held at end of year)

4. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, or contributions are completely discontinued, participants become fully vested with respect to benefits accrued to the date of such termination or discontinuance.

5. Party-in-Interest and Related-Party Transactions

Certain plan investments are managed by Fidelity and Principal. Fidelity and Principal are the trustee/custodians as defined in the Plan and, therefore, these transactions qualify as party-in-interest transactions.

6. Tax Status

The Internal Revenue Service has determined and informed the Employer by a letter dated June 3, 2015, that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended and restated since receiving the determination letter. However, plan management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements (continued)

7. Fair Value of Financial Instruments

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date. Registered investment company funds, money market funds, U.S. government securities, common stocks, preferred stock, and corporate bonds and notes are included in this category.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability used when little or no market data is available. The Plan has no investments included in this category.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Annuity Contracts

The Plan provides participants with two fixed annuity contract investment options that are fully benefit responsive – one through the Principal Life Insurance Company and one through the Variable Annuity Life Insurance Company. These contracts meet the fully benefit-responsive investment contract criteria and are, therefore, reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses, if any.

The funds are supported by the Principal Life Insurance Company general account and the Variable Annuity Life Insurance Company general account, and have no maturity date. If all participants were eligible for a distribution of their full accounts from the Plan on the reporting date, the amount payable on demand on the reporting date would be the contract value. There were no reserves against contract value for credit risk on the contract issuers or otherwise.

8. Annuity Contracts (continued)

The crediting interest rate is based on a formula established by the contract issuer and is reviewed on an annual basis for resetting. The crediting interest rate contractually guaranteed is credited to participant account balances. There are no unfunded commitments from the Plan. For the years ended December 31, 2023 and 2022, the minimum interest rate for Principal Life Insurance Company contract was 1.00% and the crediting interest rate was 2.83% and 2.20%, respectively. For the year ended December 31, 2023, the minimum interest rate for the Variable Annuity Life Insurance Company contract was 1.25%.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Principal Life Insurance Company and the Variable Annuity Life Insurance Company do not specify any events that would limit the ability of the Plan to transact at contract value with the issuer or any events that would allow the issuer to terminate the contracts and settle for an amount different from contract value.
