Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

(1) Description of Plan

The following description of the Conner Strong & Buckelew Companies, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

In May 2023, the plan was amended and changed its name to Conner Strong & Buckelew Companies, LLC 401(k) Plan. Prior to the name change, the plan name was Conner Strong & Buckelew Companies, Inc. 401(k) Plan.

In November 2023, the BroadStreet 401(k) Plan, sponsored by BroadStreet Partners, Inc., was amended effective January 1, 2024 to merge the Plan into BroadStreet 401(k) Plan. As part of the merger process, Empower Trust Company, LLC (Empower) initiated a blackout period on December 21, 2023 and liquidated the assets of the Plan effective December 29, 2023 (the Empower Liquidation) in order to facilitate the merger in a timely manner. As such, as of December 31, 2023, the only assets remaining in the Plan's assets relate to the investments that are held in self-directed brokerage accounts by Charles Schwab. Such asset transfers are recorded in the statement of changes in net assets as transfers of net assets to affiliated plan.

General

The Plan is a defined contribution plan covering all employees of Conner Strong & Buckelew Companies, LLC and its affiliates (the Company), who have attained age of 21 and have completed one month of service, except employees whose employment is covered by a collective bargaining agreement, non-resident aliens, and temporary or seasonal employees who are regularly scheduled for less than 1,000 hours of service during the eligibility computation period. In the event a temporary or seasonal worker completes 1,000 hours of service during an eligible computation period, he or she becomes eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute any amount of pretax annual compensation or after-tax compensation, as defined in the Plan, up to the annual limit established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Newly eligible employees are automatically enrolled with a 6% deferral unless they elect a different percentage or elect not to participate. If automatically enrolled, the deferral percentage will increase 1% every April 1, not to exceed 10% of compensation. Participants direct the investment of their contributions into various investment options offered by the plan. Employee contributions are recorded in the period during which the Company makes payroll deductions from the participants' earnings.

Contributions, Continued

The Company, at its sole discretion, may make discretionary matching contributions and discretionary non-elective contributions as determined by the Company's board of directors. Participants must be employed on the last day of the year and must have completed 1,000 hours of service during the plan year to be eligible for employer contributions. For the year ended December 31, 2023, the Company authorized a discretionary matching contribution in an amount equal to that contributed by a participant up to three percent of the participant's eligible compensation. During 2023, the Company's matching contribution amounted to \$1,739,233, which due the merger will be funded to the BroadStreet 401(k) Plan, and as such, has been reflected as part of transfers of net assets to affiliated plan. Company matching contributions of \$1,498,807 are recorded as employer contribution receivable at December 31 2022. There were no discretionary non-elective contributions made in 2023. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Additionally, participants will become fully vested upon death, disability or attainment of normal retirement age, as defined by the plan document. Vesting in the Company's discretionary matching and discretionary non-elective contribution portion of their account plus earnings thereon is determined as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are secured by the balance in the participants' accounts and bear interest at the prime rate plus 1%. The interest rate for loans outstanding at December 31, 2023 ranged from 4.25% to 9.50%. Loan terms may be 1 to 5 years; loans for the purchase of a principal residence may be repaid over 15 years. Principal and interest are paid ratably through regular payroll deductions. As a result of the Empower Liquidation, then outstanding notes receivable from participants of \$690,158 were included within transfer of net assets to affiliated plan.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum equal to the value of the participant's vested interest in his or her account. Employees may elect withdrawals during employment subject to the terms described in the plan document.

Forfeited Accounts

At December 31, 2023 there were no forfeited nonvested accounts. At December 31, 2022, forfeited nonvested accounts totaled \$4,223. These accounts may be used to reduce future Company contributions and/or pay plan expenses. In 2023, Company contributions were reduced by \$6,328 through the use of forfeitures and plan expenses of \$18,086 were paid through the use of forfeitures. As a result of the Empower Liquidation, then outstanding notes receivable from participants of \$4,368 were included within transfer of net assets to affiliated plan.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies, Continued

Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. The Company's retirement plan committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 11, 2024, the date the financial statements were available to be issued.

(3) Investments Certified by Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ending December 31, 2023, was obtained by management and agreed to or derived from the information certified as complete and accurate by Empower, a qualified institution. Investments that are held in self-directed brokerage accounts by Charles Schwab are excluded from the certifications.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end registered investment companies that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Participant-directed brokerage accounts allow participants to invest in securities that are traded on active exchanges. Such securities include interest bearing cash, common stock, registered investment companies, and exchange traded funds (ETFs). These investments are valued using quoted market prices available in an active market for identical instruments for which the individual securities are traded.

Common collective trust: The Putnam Stable Value Fund ("PSVF"), a common collective trust, invests directly or indirectly in fully benefit-responsive investment contracts. The PSVF is valued at the NAV as provided by the trustee, which is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

(5) Related Party Transactions and Party-In-Interest Transactions

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments.

Administrative expenses paid by the Plan for recordkeeping, investment advisory, loans, and distributions amounted to \$187,436 in 2023. The Company paid directly any other fees related to the Plan's operations.

Under an agreement negotiated with Empower Trust Company, LLC, the Plan is a beneficiary of a reduction of a portion of the Plan's fund management fees, which are rebated to the Plan. The rebates are deposited in a Plan expense account (the ERISA Account) maintained by the Plan and can be used to pay plan expenses or allocated to participants as permitted by the plan document. At December 31, 2023 there were no balances in the ERISA account. At December 31, 2022, the ERISA Account totaled \$4,249. The Plan records rebate income in net appreciation in fair value of investments. There was no rebate income received by the Plan for the year ended December 31, 2023. The ERISA account was used to pay \$263 of plan expenses for the year ended December 31, 2023.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balances.

(7) Tax Status

The Plan uses a non-standardized pre-approved plan document sponsored by Empower Trust Company, LLC. The IRS has determined and informed Empower by a letter dated June 30, 2020, that the prototype plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
