INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
Quadrant, Inc. 401(k) Plan and its Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Quadrant, Inc. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 8, 2024 (in liquidation) and December 31, 2023 (ongoing), the related statement of changes in net assets available for benefits for the period from January 1, 2024 through April 8, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Quadrant, Inc. 401(k) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 8, 2024 and December 31, 2023, and for the period from January 1, 2024 through April 8, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Other Matter – Basis of Accounting

As described in Notes 1 and 6 to the financial statements, effective January 29, 2024, the Plan Sponsor made the decision to terminate the Plan. All assets were distributed out of the Plan by April 8, 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the financial statements as of April 8, 2024 and for the period from January 1, 2024 through April 8, 2024. Our opinion is not modified with respect to this matter.

Notes to the Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the Quadrint, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established by Quadrint, Inc. (the Company) effective January 1, 2014. The Plan covered substantially all employees of the Company with the exception of employees covered under a collective bargaining agreement, leased employees, and non-resident alien employees who received no earned income in the United States, as defined by the Plan. Participants could enter the Plan on the first pay period following the completion of three months of qualified service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). During the year ended December 31, 2020, the Company acquired certain contracts and employees from R.L.M Consulting, LLC. Effective January 1, 2021, the Plan was restated to credit these employees for their service with their previous employer for eligibility and vesting purposes. The Plan was most recently amended January 29, 2024 to terminate the Plan (Note 6).

Plan Termination

Effective January 31, 2024, the Plan Sponsor was acquired by CACI International Inc. In relation to the acquisition, the Plan Sponsor made the decision to terminate the Plan and began the process to distribute all assets to the respective participants (Note 6). All remaining assets were distributed from the Plan subsequent to the decision to terminate the Plan and through April 8, 2024.

Participant Contributions

Prior to the Plan termination, participants could elect to defer up to 100% of eligible compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 for calendar year 2024. Participants could also make Roth elective contributions. Participants who attained age 50 before the end of the Plan year could make additional catch-up contributions, subject to limitations imposed by the Code which totaled \$7,500 for calendar year 2024. Participants were permitted to make rollover contributions to the Plan.

Company Contributions

Prior to the Plan termination, the Company made safe harbor non-elective contributions to eligible participants on a quarterly basis. Safe harbor non-elective contributions were equal to 100% of salary deferrals not to exceed 3% of compensation. The Company's safe harbor non-elective contributions totaled \$142,965 for the period from January 1, 2024 through April 8, 2024.

Company Contributions – cont'd.

The Company could also make additional discretionary profit sharing and/or discretionary matching contributions to the Plan. Discretionary profit sharing contributions were allocated to all eligible participants as a percentage of their eligible compensation for the year. A participant must have completed at least one hour of service during the Plan year to be eligible for discretionary profit sharing contributions. Discretionary profit sharing contributions, if made, were allocated quarterly. Participants were eligible for discretionary matching contributions if making elective deferrals to the Plan. If elected by the Company, the Company made discretionary matching contributions to eligible participants on a per-payroll basis. During the period from January 1, 2024 through April 8, 2024, the Company made discretionary profit sharing contributions of \$70,282 and discretionary matching contributions of \$158,238.

Participant Accounts

Each participant's account was participant-directed and was credited with participant contributions and Company contributions, in accordance with the investment options selected by the participant. Any earnings, losses, and administrative expenses were allocated to participant accounts based upon the balance in each account. The benefit to which a participant was entitled was the benefit that can be provided from the vested portion of the participant's account balance.

Notes Receivable from Participants

Prior to the Plan termination, participants could borrow up to 50% of the value of their vested account balances within the Plan, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount was \$1,000 and a participant could not have more than one note outstanding at any time. Notes were collateralized by the participant's vested account balance. Note repayments were made through payroll deductions and bore interest at the Prime rate plus 1% at the time of loan issuance. Notes for reasons other than the purchase of a primary residence were to be repaid within five years. Notes for the purchase of a primary residence were to be repaid within fifteen years.

Payment of Benefits

Prior to the Plan termination, upon termination of service, death, disability, retirement (age 65), or attainment of age 59 ½, a participant or his or her beneficiary, in the event of death, was entitled to a distribution of his or her vested account balance. Distributions from the Plan were payable in the form of a lump sum payment or installment payments; however, distribution of accounts with less than \$1,000 must have been in the form of a lump-sum payment. Upon termination of service, participants with vested account balances of less than \$5,000 received a lump-sum distribution without participant consent. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by a participant could be withdrawn for a hardship purpose. In-service withdrawals could be taken by a participant upon attainment of age 59 ½. Certain income tax penalties applied to withdrawals or distributions prior to age 59 ½. Distributions were subject to the applicable provisions of the Plan agreement. As of April 8, 2024 and December 31, 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received the funds as of year-end.

Payment of Benefits – cont'd.

As a result of the Plan termination effective January 29, 2024, participants were provided with the option to have their account balance rolled into another retirement plan or IRA or receive a lump sum distribution. All assets were distributed out of the Plan by April 8, 2024.

Vesting

Participants were immediately vested in their contributions and safe harbor non-elective contributions plus earnings thereon. Participants hired on or before May 1, 2014 were fully vested in employer discretionary profit sharing contributions and discretionary matching contributions. Participants hired after May 1, 2014 became fully vested in employer discretionary profit sharing contributions and discretionary matching contributions after 6 months of service. Upon retirement, death, or disability, a participant becomes 100% invested in his or her Company contributions. As a result of the Plan termination (Note 6), all affected participants, as defined by IRS regulations, became 100% vested in his or her Company contributions.

Forfeitures

Prior to the Plan termination, forfeitures of non-vested Company discretionary matching and profit sharing contributions were applied to reduce future Company matching and discretionary profit sharing contributions, allocated to participant accounts as a discretionary Company contribution, or applied to Plan expenses. Forfeitures became available to the Plan as of the earlier of the last day of the Plan year in which a former employee incurs five consecutive one-year breaks in service or a distribution of the participant's entire vested account balance occurs. The Plan did not have a forfeiture balance as of April 8, 2024. Forfeitures available to the Plan totaled \$6,673 as of December 31, 2023. During the period from January 1, 2024 through April 8, 2024, forfeitures applied to reduce Company contributions totaled \$2,312 and forfeitures applied to plan expenses totaled \$13,554.

Plan Expenses

Expenses incurred in the administration of the Plan were paid with the net assets of the Plan, unless paid by the Company, at its discretion. Plan expenses totaling \$33,035 were paid directly by the Plan during the period from January 1, 2024 through April 8, 2024. Loan and distributions fees were paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As described in Notes 1 and 6, the Plan terminated effective January 29, 2024. The Plan's financial statements are presented using the liquidation basis of accounting as of April 8, 2024 and for the period from January 1, 2024 through April 8, 2024. The Plan's financial statements as of December 31, 2023 are presented using the ongoing basis of accounting. The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provided for investments in assets that were exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the value of investment securities could have occurred that materially affected participant account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Fair Value Measurement – cont’d.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interest-bearing cash: Valued at amortized cost, which approximates fair value.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds were traded.

Interests in self-directed brokerage accounts: Valued at the closing price of the individual securities held by the Plan at year-end. Securities were traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of April 8, 2024 and December 31, 2023.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Notes become due immediately upon termination of a participant’s employment. Delinquent notes were treated as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 7, 2024, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment information contained in the accompanying financial statements, including investments held as of April 8, 2024 and December 31, 2023 and interest and dividend income and net appreciation in fair value of investments for the period from January 1, 2024 through April 8, 2024, was obtained or derived from information supplied to the Plan administrator and was certified as complete and accurate by Ascensus, LLC on behalf of Ascensus Trust Company, the Custodian of the Plan.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invested in investments that were managed by Vanguard Investment Company, the Recordkeeper for the Plan. The Plan loaned funds to its participants according to the applicable provisions of the Plan agreement. The Company provided the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualified as party-in-interest transactions which are exempt from the prohibited transaction rules.

5. INCOME TAX STATUS

The Plan adopted a non-standardized prototype plan with a deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan was qualified under Section 401(a) of the Code and therefore, was exempt from taxation. Once qualified, the Plan was required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes* (ASC 740), prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan was tax exempt and had no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognized interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of April 8, 2024 and December 31, 2023.

The Plan was subject to routine audits by the IRS and the Department of Labor; however, there are currently no audits in progress for any open periods in progress.

6. PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective January 29, 2024, the Company terminated the Plan in relation to the acquisition of the Plan Sponsor. Plan assets were fully liquidated on April 8, 2024. Upon Plan termination, affected participants became 100% vested in all Company contribution
