## Independent Auditors' Report

### Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedules of Assets Held for Investment Purposes at End of Year as of December 29, 2023 and Delinquent Participant Contributions, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 – Description of the Plan**

The following description of the TeleNetwork, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering substantially all eligible employees of TeleNetwork Inc. (the “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and qualified under Section 401(a) of the Internal Revenue Code (the “IRC”).

In April 2022, the Plan document was amended to bring the Plan into compliance with legislative and regulatory changes.

**Plan Termination**

In December 2023, the Plan Sponsor terminated the Plan and joined a pooled employer plan in January 2024. As of December 29, 2023, all assets of the Plan have been transferred out and the asset balance is zero.

**Administration**

The Plan is administered by the Plan Sponsor (the “Plan Administrator”). Plan assets are held by Ascensus Trust Company (the “Trustee”).

**Eligibility**

Employees older than 18 years are eligible to participate in the Plan after completing one year of service. The employee is credited with one year of service if they complete 1,000 hours within the initial eligibility period. Leased employees, agency workers, certain nonresident aliens and employees covered by a collective bargaining agreement are not eligible to participate in the Plan.

**Participant Contributions**

Contributions are made to the Plan by the Plan Sponsor on behalf of each eligible participant based upon the participant’s elected compensation deferral through payroll deductions. The Plan Sponsor funds the contributions at the end of each payroll period.

Eligible employees have the option to contribute pre-tax and Roth 401(k) contributions. A participant may authorize the Plan Sponsor to withhold his or her eligible compensation, not to exceed the annual limit established by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

**Employer Contributions**

The Plan Sponsor makes a safe harbor employer matching contribution equal to 100% of the first 4% of contributed compensation. The Plan Sponsor did not elect to make a discretionary employer contribution for the period from January 1, 2023 through December 29, 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, Plan Sponsor contributions and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Rollovers and Transfers**

Participants, who have a balance in another qualified employee benefit plan, as described in Section 401(a) of the IRC, may transfer or rollover the lump sum values of their account directly into the Plan, provided it meets the requirements of the IRC.

**Forfeited Accounts**

Forfeitures by participants of unvested Plan Sponsor contributions are used to reduce Plan administrative expenses and future employer contributions. The forfeited unvested account balance was \$0 and \$78, as of December 29, 2023 and December 31, 2022, respectively. The Plan utilized \$291 in forfeitures during the period from January 1, 2023 through December 29, 2023.

**Notes Receivable from Participants**

The Plan does not allow for participants to borrow from their fund accounts.

**Vesting**

Participants are immediately vested in their contributions and safe harbor employer matching contributions plus actual earnings. Vesting in the Plan Sponsor's employer discretionary contributions plus actual earnings is based on years of credited service, as defined by the schedule below:

**Payment of Benefits**

Benefits become available to participants on the earliest of four events: (1) termination of employment, (2) death of the participant (benefits are payable to the participants spouse or beneficiary), (3) disability of the participant, or (4) the participant's retirement.

If the vested account balance is \$5,000 or less the Plan Administrator may direct the Trustee to automatically distribute the vested account balance to the terminating participant regardless of whether participant consent is received.

On termination of service due to death prior to retirement, the account balance is paid to the participant's spouse or beneficiary in a lump sum. Active participants can withdraw benefits once they reach 59 ½ years of age.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Risks and Uncertainties**

Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 3 – Information Certified by the Trustee**

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits, as of December 29, 2023 and December 31, 2022.
- Net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits, for the period from January 1, 2023 through December 29, 2023.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

**Note 4 – Tax Status**

The Plan Sponsor has not applied for a determination letter from the Internal Revenue Service ("IRS") to determine if the Plan is designed in accordance with applicable sections of the IRC. The Plan document is based upon a non-standardized pre-approved profit sharing plan with CODA plan instrument from Ascensus LLC, which received an IRS advisory letter dated June 30, 2020. The plan instrument has been updated for legislative and regulatory changes. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan Administrator believes it is subject to income tax examinations for three years.

**Note 5 – Fair Value Measurements**

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

- Level one — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level two — Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level three — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 29, 2023 and December 31, 2022.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market:* Fair value is estimated to be carrying value.

**Note 6 – Related-party and Party in Interest Transactions**

Certain Plan investments are shares of mutual funds managed by the Trustee or its affiliates. Fees incurred by the Plan for related investment management services are included in administrative expenses and net depreciation in fair value of investments. Certain fees incurred by the Plan for recordkeeping and audit fees are included in administrative expenses. Transactions such as these qualify as party-in-interest transactions. The Plan Sponsor pays directly certain other fees related to the Plan’s operations.

**Note 7 – Prohibited Transactions**

During 2022, the Plan Sponsor failed to remit certain participant contributions in a timely manner. The Plan Sponsor identified three instances totaling \$377 in participant contributions that were remitted to the Plan in violation of DOL regulations. For three of the late remittances totaling \$377 of participant and \$277 of employer contributions, the Plan Sponsor did not remit the participant and related employer contributions to the Plan until October 2023, these are recorded as receivables due to the Plan as of December 31, 2022. The missed earnings and interest related to \$377 of the late participant contributions were remitted to the Plan in October 2023. The Plan Sponsor made the corrections using a self-correction method outside of the DOL’s Voluntary Fiduciary Correction Program (“VFCP”).

During 2023, the Plan Sponsor failed to remit certain participant contributions in a timely manner. The Plan Sponsor identified seven instances totaling \$24,369 in participant contributions that were remitted to the Plan in violation of DOL regulations. The missed earnings and interest related to \$22,662 of late participant contributions were remitted to the Plan in March 2023. The Plan Sponsor made the corrections using a self-correction method outside of the DOL’s VFCP. For five of the late remittances totaling \$1,707, the missed earnings and interest are in the process of being calculated and the Plan intends to use a self-correction method outside of the DOL’s VFCP.

A summary of nonexempt prohibited transactions related to the delinquent remittances is shown in the attached supplemental schedule of delinquent participant contributions.

During 2022, the Plan Sponsor failed to remit certain participant contributions in a timely manner. The Plan Sponsor identified three instances totaling \$377 in participant contributions that were remitted to the Plan in violation of Department of Labor ("DOL") regulations. For three of the late remittances totaling \$377 of participant and \$277 of employer contributions, the Plan Sponsor did not remit the participant and related employer contributions to the Plan until October 2023, these are recorded as receivables due to the Plan as of December 31, 2022. The missed earnings and interest related to \$377 of the late participant contributions were remitted to the Plan in October 2023. The Plan Sponsor made the corrections using a self-correction method outside of the DOL's Voluntary Fiduciary Correction Program ("VFCP").

During 2023, the Plan Sponsor failed to remit certain participant contributions in a timely manner. The Plan Sponsor identified seven instances totaling \$24,369 in participant contributions that were remitted to the Plan in violation of DOL regulations. The missed earnings and interest related to \$22,662 of late participant contributions were remitted to the Plan in March 2023. The Plan Sponsor made the corrections using a self-correction method outside of the DOL's VFCP. For five of the late remittances totaling \$1,707, the missed earnings and interest are in the process of being calculated and the Plan intends to use a self-correction method outside of the DOL's VFCP.
