Our retirement account was terminated on 7/31/2019. Please note that the company administrator in 2019, Dennis Lane, has deceased. And we have learned that Form 5500 and late notices were being sent to Dennis Lane. After being informed by the IRS on 9/10/2024 that our Form 5500s were late I have aggressively pursued completion and resolution of this issue with help from ADP.

Please note, as shown in the email thread attached below, that even in 2019 we attempted to address this issue with ADP to ensure we were in compliance. After several correspondences, we sent this final comment to ADP, "Unless notified to the contrary, we will presume that this final 5500 was filed as agreed upon and no further action is required by Accelerated PM LLC."

Obviously, ADP was sending replies to the deceased Dennis Lane. AcceleratedPM and I were never receiving these notices. I was unaware of the problem and unaware that it was my responsibility to file with DOL and IRS. For this reason, I would like to request an abatement of the fines for Year 2019 Form 5500 and for Year 2020 Form 5500.
