### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of B & P Enterprises 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023, and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### Note 1 - Description of Plan

The following description of B & P Enterprises 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan is a defined contribution 401(k) retirement plan available to substantially all employees of Prewett Enterprises, Inc. d/b/a B & P Enterprises (the "Company"). Employees are eligible to participate after attaining age twenty-one (21) and completing ninety (90) days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may elect to defer any percentage of their eligible compensation subject to Internal Revenue Service (IRS) limitations. Participants are automatically enrolled to defer six percent (6%) of eligible compensation. The Plan also provides for a contribution accelerator which automatically increases participant contributions one percent (1%) each year on January 1, until the participant's contribution rate reaches sixteen percent (16%). Participants who have reached the age of fifty (50) before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified retirement plans. The Company also makes discretionary matching contributions. For the years ended December 31, 2023 and 2022, the Company matched ten percent (10%) of eligible compensation that a participant contributed to the Plan.

#### Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among the different investment options offered by Principal Trust Company and Principal Life Insurance Company (Principal) which include a guaranteed investment contract, mutual funds, and pooled separate accounts.

#### Participant accounts

Each participant's account is credited with the participant's deferral contributions, the Company's discretionary matching contributions, if any, and a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested and an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1 - Description of Plan (continued)

#### Vesting

Participants are immediately vested in their deferral and rollover contributions plus earnings thereon. Participants become fully vested in Company discretionary matching contributions and related earnings after six (6) years of credited service. In the event of death, disability, normal retirement age (59 1/2), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### Payment of benefits

Upon termination of service, death, disability or retirement, a participant may elect to receive account distributions in the form of a lump sum payment or installments over a period of time as defined in the plan document. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 59 1/2.

#### Forfeited accounts

If an employee terminates before his or her Company discretionary matching contribution account has become fully vested, such portion of the account is forfeited. Forfeitures may be used to pay plan expenses or used to offset employer contributions. Participant forfeitures totaled \$17,525 and \$5,146 during 2023 and 2022, respectively. Participant forfeitures in the amount of \$4,386 and \$2,061 were used to reduce employer contributions during 2023 and 2022, respectively. Participant forfeitures in the amount of \$312 and \$994 were used to pay plan expenses during 2023 and 2022, respectively.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Certain investment related expenses are included in the net appreciation (depreciation) in fair value of investments.

### Note 3 - Information prepared and certified by the custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and the supplemental schedule of assets is complete and accurate.

- Investments at fair value
- Fully benefit-responsive contract at contract value
- Net appreciation (depreciation) in fair value of investments
- Dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule of assets (held at end of year).

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Invested in single domestic stocks and mutual funds. Valued using observable level 1 quoted pricing inputs in determining the NAV of the pooled separate accounts. The NAV is the basis for current transactions and the pooled separate accounts can be redeemed at NAV as of the measurement date. The NAV is calculated in a manner consistent with GAAP for investment companies. Most of the security prices were obtained from a pricing service, Interactive Data Corporation.

### Note 5 - Fully benefit-responsive investment contract

The Plan has a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value as reported to the Plan by Principal was \$19,499 and \$26,537 as of December 31, 2023 and 2022, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

### Note 6 - Related party transactions and party-in-interest transactions

Plan investments include interests in certain mutual funds, pooled separate accounts and a guaranteed investment account held by Principal. Principal is the custodian as defined by the Plan and, therefore, these investments and related investment transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in the net appreciation (depreciation) in fair value of the investments as they are paid through revenue sharing, rather than a direct payment. Fees paid directly by the Plan for administrative services totaled \$33,659 and \$26,377 in 2023 and 2022, respectively. The Company pays directly any other fees related to the Plan's operations.

### Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### Note 8 - Tax status

The IRS has determined that the Non-Standardized Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed Principal of such in a letter dated June 30, 2020. The plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

### Note 8 - Tax status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risks, uncertainties, and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2023, approximately 35% of the Plan's investments were invested in the Principal LifeTime 2040 Separate Account and the T. Rowe Price Blue Chip Growth Fund. At December 31, 2022, approximately 19% of the Plan's investments were invested in the Principal LifeTime 2040 Separate Account.

### Note 10 - Delinquent participant contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. Contributions of \$359,429 were not remitted within the required time period between 2016 and 2021. The Company remitted these delinquent employee contributions in 2016 through 2021, but has not yet remitted any lost earnings associated with the delinquent contributions. While the Company remitted all employee contributions to the Plan, contributions of \$12,957 and \$18,159 were not remitted within the required time period for the years ended December 31, 2023 and 2022, respectively. The Company has remitted these delinquent employee contributions, but has not yet remitted any lost earnings associated with the delinquent contributions.

### Note 11 - Subsequent events

Plan management has evaluated subsequent events through \_\_\_\_\_, 2024, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
