Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wieland North America, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities Of Management For The Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTES TO FINANCIAL STATEMENTS
December 31, 2023 And 2022**

1. Description Of The Plan

The following description of the Wieland North America, Inc. Retirement Savings Plan (the Plan), provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan including a qualified deferred arrangement as described in the Internal Revenue Code (the IRC). The Plan covers substantially all employees of Wieland North America, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan's recordkeeper and trustee is Principal Life Insurance Company and Principal Trust Company (collectively Principal), respectively.

Contributions

Eligible employees in the Plan may contribute an amount up to the annual permissible dollar limit under the IRC but not greater than 80%, of their annual compensation. The Plan provides an automatic enrollment feature whereby 6% of eligible compensation is contributed to the Plan. Participants of the Plan can affirmatively choose not to contribute or choose a different percentage to be contributed to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for discretionary matching contributions under certain circumstances, for certain participants based on location, pay status and membership in a collective bargaining unit. Discretionary matching contributions amounted to \$6,507,101 and \$6,061,905 for the years ended December 31, 2023 and 2022, respectively.

In addition to matching contributions, the Company provides for a retirement contribution for certain participants based on location, pay status and membership in a collective bargaining unit. The first 3% of the retirement contribution for nonunion participants and bargaining unit employees at WRA Waterbury is a safe harbor contribution. An additional retirement contribution is made to nonunion participants and employees at WRA Waterbury of 2% to 4.5% depending on the participant's age. A retirement contribution of 5% is made to bargaining unit employees at the Company's Wieland Chase, LLC operations. Total retirement contributions for all participants amounted to \$11,345,289 and \$9,249,825 for the years ended December 31, 2023 and 2022, respectively.

Vesting

Participants in the Plan are immediately vested in their deferral contributions, safe harbor contributions, rollover contributions and the earnings thereon. Vesting in the remainder of their account is based on years of service, in accordance with the following schedules:

- For bargaining unit participants employed at the Company's Wieland Chase, LLC operations in Montpelier, Ohio:

Forfeitures

Forfeitures of nonvested accounts may be used to pay administrative expenses or to reduce Company contributions. Forfeitures available for future use amounted to \$107,180 and \$121,650 as of December 31, 2023 and 2022, respectively. The Company used \$213,233 and \$157,636 to pay administrative expenses during the years ended December 31, 2023 and 2022, respectively. The Company used \$17,229 and \$20,524 to reduce Company contributions during the years ended December 31, 2023 and 2022, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, the Company's contributions, and an allocation of Plan's earnings (losses) and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options

Upon enrollment in the Plan, participants may direct the investment of contributions into various investment options, including a self-directed brokerage account. Participants may change their investment elections daily.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$500 up to the lesser of \$50,000 less the participant's largest outstanding loan balances during the preceding 12 months or 50% of their vested account balance. Participants can have no more than two loans outstanding at a time. Loans are for a period not to exceed five years, unless used to acquire a principal residence, then the period may exceed five years, but may not extend beyond fifteen years. Loans bear interest at a reasonable fixed rate of interest based on prevailing market rates. Participant loans are secured by participants' vested account balances. The loans are repaid through payroll withholdings, including principal and interest.

Payment Of Benefits

Upon termination of employment, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in the form of a lump sum payment, installment payments, or an in-kind distribution for the portion of a participant's account that is held in the self-directed brokerage account.

In-Service Withdrawals

After five years of participation, active participants may make a withdrawal of all or part of their vested Company contributions. Active participants may also make a withdrawal of all or a part of their rollover contributions, elective deferral contributions, and earnings at any time. Upon attainment of age 59-1/2, a participant may also withdraw all or a part of their elective deferral contributions and safe harbor contributions.

A participant may also make withdrawals in the event of an undue financial hardship, as defined by the Plan Document.

Administrative Expenses

Salaries and related benefits of employees who administer the Plan are provided by the Company. All other administrative expenses are paid by the Plan. These expenses include investment management, trustee fees and transaction fees for distributions and notes receivable.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Principal Fixed Income Guaranteed Option is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan Document.

Contributions Receivable And Credit Loss Policy

As of January 1, 2023, the Plan adopted Accounting Standards Codification Topic 326, *Financial Instruments - Credit Losses*, using a modified-retrospective approach. The standard replaces the previous incurred loss model and requires entities to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. This estimate must include consideration of historical experience, current conditions and reasonable and supportable forecasts. The standard applies to the Plan's Company contributions receivable. The adoption did not have a material impact on these financial statements.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2023 and no allowance for doubtful accounts was necessary at December 31, 2022.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Effective January 1, 2024, two plans were merged into the Plan resulting in assets totaling approximately \$9,865,000 being transferred into the Plan.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Pooled Separate Accounts

Valued at the NAV of units held by the Plan at year end. The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Self-Directed Brokerage Accounts

Self-directed brokerage accounts are comprised of stocks, mutual funds, and a money market fund. Stocks are valued at the daily closing price as reported on the active market on which the individual securities are traded. Mutual funds and money market funds held by the Plan are open-end investment funds that are registered with the Securities and Exchange Commission. These investment funds are required to publish their daily NAV and transact at that price. The investment funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

The Plan invests in a benefit-responsive annuity contract (the Contract) with Principal, which maintains the contributions in a guaranteed interest account.

As described in Note 2, because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Interest income on the Contract is calculated and credited daily based on fixed interest rates. Interest rates are reset on a semiannual basis.

The Contract permits the Company or Principal to terminate the Contract within 12 months of receiving notification. Principal may make the termination payment immediately in lieu of a 5% surrender charge.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) the decision by the Plan Sponsor to withdraw all assets from the fund and reinvest in another investment vehicle, (3) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (4) the delivery of any communication to Plan participants designed to influence the participant not to invest in the fund, (5) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement applicable to the Plan. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Party In Interest Transactions

Certain investments held by the Plan are pooled separate accounts and an investment contract managed by affiliates of Principal. Fees paid to Principal are based on customary and reasonable fees and are paid by the Plan. In addition, certain participants had outstanding notes receivables as of December 31, 2023 and 2022. These transactions qualify as exempt parties in interest transactions allowable under ERISA.

8. Risks And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Income Tax Status

The Plan uses a pre-approved profit sharing plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 in which the IRS states that the pre-approved plan is in compliance with the applicable requirements of the Code. The Plan has been amended since the date of the opinion letter. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan's counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal tax returns for tax years 2020 and later remain subject to examination by taxing authorities.
