## Independent Auditors' Report

To the Participants and Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements

We have performed an audit of the financial statements of the Deva Concepts, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Responsibilities of Management for the 2023 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### 1. Description of Plan

The following description of the Deva Concepts, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for amore complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established effective January 1, 2008, as restated January 1, 2022. The Plan covers all employees of Deva Concepts, LLC (the Company, the Employer, the Sponsor) who have reached the age of 21. There is no minimum service requirement to participate under the Plan. Eligible employees may participate in the Plan on the first day of the month following their hire date or the date they satisfy the minimum age requirement. Assets of the Plan are held by a trust established under the Plan with Massachusetts Mutual Life Insurance Company by Great-West Life & Annuity Insurance Company, which was acquired by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (the Trustee). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may contribute to the Plan up to 100% of compensation on a pre-tax basis or Roth basis, subject to dollar limits established by the Internal Revenue Code (IRC). Such contributions are excluded from the participant's Federal taxable income until received as a withdrawal or distribution from the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan provides for a discretionary employer matching contribution based on a percentage of a participant's compensation. There were no such employer matching contributions made for the period from January 1, 2023 to December 29, 2023. The Plan provides for safe harbor contributions based on a percentage of a participant's compensation. For the period from January 1, 2023 to December 29, 2023, the Company made safe harbor contributions in amounts equal to 100% of the first 3% of participants' eligible compensation, and 50% of the next 2% of participants' eligible compensation totaling \$134,597. The total contributions for the Company and participants in any plan year cannot exceed the lesser of (1) 100% of the participants' compensation or (2) maximum allowable by the IRC.

#### Participant Accounts

Each participant's account is credited or charged with the participant's contribution and allocations of (i) employer contributions and (ii) the participant's share of earnings or losses on both company and employee contributions and administrative expenses. Each participant directs all amounts credited into their account into one or more of the investment options available under the Plan. Accordingly, as a participant-directed plan, each participant's investments determine their share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions, rollovers and safe harbor contributions, plus actual earnings thereon. Vesting in employer discretionary matching contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in employer discretionary matching contributions and earnings thereon after six years of credited service.

#### Investment Options

Upon enrollment in the Plan, participants may direct the Trustee to invest contributions in various investment options offered by the Plan. Participants may change their contribution investment options daily, transfer part or all past investments to other funds daily; and may change their deferral percentage quarterly.

#### Notes Receivable From Participants

Participants may borrow from their vested fund account balance a minimum of \$1,000 and up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding plan loan balance during the one-year period ending on the day before the loan is made or (b) one-half of the value of their vested account balance. A participant may have no more than one loan outstanding at any time. The maximum payment term allowed for any loan will be five years (unless the loan is for the purchase of a principal residence in which case the term may not exceed 30 years). The loans bear interest at a fixed rate using the prevailing prime rate plus 2% that is set at the date of the loan. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### Forfeited Accounts

When certain terminations of participants in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Any matching contributions made on excess 401(k) elective deferral contributions will be forfeited. Forfeitures may be first used to pay any Plan expenses and any remaining amounts may be used to reduce future employer matching contribution. There were no forfeiture balances as of December 29, 2023 or December 31, 2022 and no forfeitures were used during the period from January 1, 2023 to December 29, 2023.

#### Hardship and In-Service Withdrawals

The Plan Administrator may authorize a lump-sum distribution of up to 100% of the participant's vested interest (excluding any investment earnings) but not to exceed the amount necessary to meet the financial need created by the hardship provided the participant submits positive evidence of an immediate and heavy financial need as defined in the Plan. In-service distributions of the participant's vested interest are available for any reason upon attaining age 59½.

#### **Deemed Distributions**

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Deemed distributions on defaulted loans are recorded immediately upon default. For the period from January 1, 2023 to December 29, 2023, there were no deemed distributions recorded.

#### **Benefit Payments**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to his or her account balance, or annual installments. Upon termination of service, and provided that the participant has a minimum of \$5,000 in the Plan, the participant may elect to receive a lump-sum amount equal to the value of his/her vested account or defer distributions to normal retirement age. Those participants with less than \$5,000 must receive a lump-sum distribution of their vested accounts.

#### **Expenses of the Plan**

Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Certain Plan expenses are deducted from participant accounts, and the remainder of the Plan expenses are generally paid by the Employer.

#### **Transfers**

On December 29, 2023, all assets (totaling \$3,949,202) of the Plan transferred into the Henkel 401(k) and Defined Contribution Plan. Effective January 1, 2024, participants of the Plan became participants of the Henkel 401(k) and Defined Contribution Plan.

## **2. Summary of Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

All Plan investments are held by the Trustee. The Plan's investments, except as noted below, are stated at fair value. Pooled separate accounts are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end. See Note 3 for a discussion of fair value measurements. The assets of the Plan are subject to market fluctuations which could affect balances available for benefits.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Fixed annuities are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as components of net appreciation or decline in fair market value of investments for such investments.

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 29, 2023, and December 31, 2022.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Subsequent events were evaluated through October 11, 2024, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Pooled separate accounts (PSAs) are valued at fair value based on the NAV of the pooled separate accounts. The pooled separate accounts invest in domestic and foreign stocks, bonds and mutual funds. The fair value of these stocks, bonds and mutual funds are publicly quoted and are used in determining the NAV of the pooled separate accounts, which are not publicly quoted.

Fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **4. Information Certified by Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 29, 2023 and December 31, 2022, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2023 to December 29, 2023.

#### **5. Related-Party and Party in Interest Transactions**

During 2023, certain Plan investments were managed by Empower, the Trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA.

As disclosed in Notes 1 and 2, the Plan merged into the Henkel 401(k) and Defined Contribution Plan. Effective January 1, 2024, participants of the Plan became participants of the Henkel 401(k) and Defined Contribution Plan.

#### **7. Tax Status**

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with Cash or Deferred Arrangement (CODA) sponsored by ERP Actuaries & Consultants which received an opinion letter from the Internal Revenue Service, dated June 30, 2020, as to the Plan's qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and accordingly no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL. The Plan Administrator does not believe that there are uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2022, the Plan had investments of \$2,946,842 concentrated in four funds.

### **9. Delinquent Participant Contributions**

The Plan's management determined that during the period from January 1, 2023 to December 29, 2023, the plan sponsor failed to remit certain employee deferrals and loan repayments in the amount of \$32,671 to the Plan in a timely manner according to DOL regulations. The Employer has undertaken the necessary procedures to calculate and reimburse the affected participants for lost earnings due to these late contributions outside of the DOL's Voluntary Fiduciary Correction Program (VFCP). As of December 29, 2023, corrections for lost earnings and interest thereon, have been fully restored to the participants' accounts for the late contributions.
