Retirement Savings Plan effective December 31, 2023. All plan assets were transferred to the AAR CORP. Retirement Savings Plan on December 29, 2023. Our opinion has not been modified with respect to this matter.

Notes to Financial Statements

Note 1. Plan Description

The following description of AAR Aircraft Services Miami Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan, as amended and restated, provides for employee contributions under the provisions of Section 401(k) of the Internal Revenue Code (“Code”) and covers employees of AAR Aircraft Services, Inc., Miami location (the “Company”), a subsidiary of AAR CORP. (the “Parent Company”). Under the Plan’s provisions, employees are eligible, as determined under the plan document, to participate in the Plan as of the first day of employment. Participation in the Plan is voluntary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions: Each year, participants may contribute a specific percentage of pre-tax or Roth (after-tax) annual compensation, as defined by the Plan, subject to annual limits as permitted under the Code. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions (limited to \$7,500 in 2023).

The Plan includes an automatic enrollment feature. Participants may still elect to either defer or not defer compensation by making an election with the Plan Administrator to take effect as of the participant’s date of initial participation in the Plan, provided that the notice has been given and the election is received prior to the date of initial participation. Effective January 1, 2020, if an employee fails to make an election prior to the initial participation date, they will be deemed to have elected to defer 6% of their pre-tax annual compensation into a default fund selected by the Benefits Committee until such election is modified or revoked. The Plan also provides for automatic escalation of 1% each year on June 1, up to 20%, unless the participant elects a different percentage or not to contribute to the Plan.

Effective January 1, 2020, the Company matches 50% of the employees’ elected deferrals up to 6% of compensation, not to exceed the maximum allowable as a deduction under the provisions of Section 404 of the Code of 1965, as amended. For the year ended December 31, 2023, Company matching contributions amounted to \$935,651.

Investment options: The participants elect to have contributions invested in one or more of the following investment options:

Common/collective trust:

Vanguard Retirement Savings Trust III: Seeks stable returns comparable to those of short-term to intermediate-term fixed income securities by investing in a combination of synthetic contracts (backed primarily by Vanguard fixed income funds), traditional investment contracts, and cash (money market fund). The average maturity range of the trust is 2–4 years.

Vanguard Target Retirement Trusts II: Seeks to provide growth of capital and current income consistent with its target allocation by investing in a gradually more conservative mix as the retirement date approaches of some or all of five Vanguard funds and trusts – domestic stock market index funds, international stock market index trust, a bond index fund, and inflation-protected securities fund.

Registered investment company securities

American Century Small Cap Value Fund: Seeks to provide long-term capital growth and income by investing in stocks of small-sized companies that are believed to be undervalued.

Note 1. Plan Description (Continued)

Blackrock Total Return Fund: Seeks to provide total return that exceeds that of the Barclays U.S. Aggregate Bond Index by investing in investment grade fixed income securities of any maturity.

Janus Triton Fund: Seeks to provide consistent relative returns with lower volatility by investing in small-cap companies with differentiated business models and sustainable competitive advantages that are positioned to grow market share regardless of economic conditions.

MFS International Diversification Fund: Seeks to provide growth in capital by investing using a strategic risk-based approach to portfolio construction which efficiently diversifies across international equity markets.

Principal Equity Income Fund: Seeks to provide relatively high level of current income along with long-term growth of income and growth of capital by investing primarily in dividend paying stocks of U.S. large-cap companies.

Vanguard Federal Money Market Funds: Seeks to provide current income while maintaining liquidity and a stable share price of \$1 by investing at least 99.5% of its total assets in cash, U.S. government securities, and/or repurchase agreements that are collateralized solely by the U.S. government.

Vanguard Institutional Index Fund: Seeks to track the performance of a benchmark index that measures the investment return of large capitalization stocks by holding all of the stocks in the unmanaged benchmark Standard & Poor's 500 Index in approximately the same proportions as those stocks are represented in the index.

Vanguard International Growth Fund Admiral Shares: Seeks to provide long-term growth of capital through broadly diversified exposure to major equity markets outside the United States by investing in stocks of high-quality companies with above-average growth potential based outside the United States.

Vanguard Long-Term Investment-Grade Fund Admiral Shares: Seeks to provide a high and sustainable level of current income by investing primarily in a diversified group of long-term bonds issued by corporations with strong credit ratings.

Vanguard Mid-Cap Index Fund Institutional Shares: Seeks to track the performance of a benchmark index that measures the investment return of mid-capitalization stocks by holding all of the stocks in the unmanaged benchmark Center for Research In Securities Prices ("CRSP") U.S. Mid Cap Index representing medium-size U.S. firms in approximately the same proportions as those stocks are represented in the index.

Vanguard Small-Cap Index Fund Institutional Shares: Seeks to track the performance a benchmark index that measures the investment return of small-capitalization stocks by holding all of the stocks in the unmanaged benchmark CRSP U.S. Small Cap Index representing small U.S. companies in approximately the same proportions as those stocks represented in the index.

Vanguard Total Bond Market Index Fund Admiral Shares: Seeks to track the performance of a broad, market-weighted bond index, the unmanaged benchmark Bloomberg U.S. Aggregate Float Adjusted Index, by investing in a broad-range of taxable investment-grade corporate, U.S. Treasury, mortgage-backed, and asset-backed securities with short, intermediate, and long maturities in excess of one year.

Vanguard Total International Stock Index Fund Admiral Shares: Seeks to track the performance of a benchmark that measures the investment return of stocks issued by companies located in developed and emerging markets, excluding the United States, by holding substantially all of the common stocks in the Financial Times and Stock Exchange Global All Cap ex U.S. Index in approximately the same proportions as each region's stocks represented in the index.

Note 1. Plan Description (Continued)

Vanguard U.S. Growth Fund Admiral Shares: Seeks to provide long-term growth of capital by investing in large, high-quality, seasoned U.S. companies with records of exceptional growth and above-average prospects for future growth.

Vanguard Wellington Fund Admiral Shares: Seeks to provide long-term growth of capital and reasonable current income with moderate risk by investing about 60-70% of its assets in stocks and the remaining 30-40% in bonds.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance in the previous 12 months or 50% of their non-forfeitable account balance, whichever is less. Interest is charged at an annual rate of 1% above the federal prime rate in effect on the first business day of the month of loan issuance. The loan period can be a maximum of 5 years (10 years for purchase of a home). Principal and interest are paid ratably through bi-weekly payroll deductions. During 2020, the Plan adopted certain Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") provisions to allow for an increase in Plan loan amounts to a maximum equal to the lesser of \$100,000 or 100% of their non-forfeitable account balance, whichever is less, and deferral of loan payments up to one year.

Participants' accounts: Each participant's account is credited with the participant's contributions, Company matching contribution and Plan earnings, offset by an investment administrative charge and an allocation of admin expense that are paid by the Plan. Allocations are based on participant earnings or account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administration: Day-to-day administration of the Plan, investment policy and investment activities are the responsibility of the Benefits Committee composed of at least three senior officers of the Parent Company. The Benefits Committee members are appointed by the Board of Directors.

Vanguard Fiduciary Trust Company ("Vanguard") provides assistance in plan administration. Vanguard, as trustee and investment manager, performs administrative and recordkeeping services for the Plan in addition to coordinating the activities of the mutual funds.

Vesting and benefits: Upon becoming eligible to participate in the Plan, employees have a non-forfeitable right to the portion of their account balance attributable to participant contributions, asset transfers/rollovers plus the related earnings or losses. The portion of the participant's account balance attributable to Company contributions plus related earnings or losses is subject to the following vesting schedule:

In-service distributions, such as loans and hardships, are permitted within certain restrictions. During 2020, the Plan implemented a CARES Act provision to allow for special coronavirus-related distributions that allowed qualified individuals impacted by the coronavirus to take distributions up to \$100,000 with no mandatory tax withholding or ten percent early penalty tax.

At retirement, participants with a vested account balance are paid their entire account balance in a lump sum or in equal installments over a period of not more than 15 years.

Forfeited accounts: At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$6,637, respectively. The plan document provides for these accounts to be used to pay plan expenses or reduce future Company contributions. During the year ended December 31, 2023, Company contributions were reduced by forfeited non-vested accounts by \$3,835. During the year ended December 31, 2023, the Company transferred the remaining forfeited non-vested account balance of \$13,859 to the AAR CORP. Retirement Savings Plan, see Note 7.

Note 2. Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Use of estimates: These financial statements are prepared in accordance with accounting principles generally accepted in the United States of America that require management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could be materially different from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain administrative expenses are paid by the Company and, accordingly, are not reflected in the accompanying financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through October 10, 2024, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by Vanguard Fiduciary Trust Company, the trustee

The following is a summary of the Plan’s asset and income information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan’s financial statements, that was prepared by or derived from information provided by Vanguard Fiduciary Trust Company (“Vanguard”), the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Vanguard that information provided to the Plan Administrator by Vanguard related to the following assets as of December 29, 2023, and income for the period from January 1, 2023 through December 29, 2023 is complete and accurate. Management has determined there is no material difference between balances as of December 29, 2023 and December 31, 2023 and the year ended December 31, 2023 is period from January 1, 2023 through December 29, 2023. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Registered investment company securities: Valued at the daily closing price as reported by the fund. Registered investment company securities held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The registered investment company securities held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the NAV of units held, as provided by the trustee. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The common/collective trust is valued daily based on other observable inputs. Participant transactions (purchases and sales) may occur daily.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2023, there were no transfers in or out of Level 3.

Note 5. Related-Party Transactions

Certain Plan investments are held in shares of registered investment companies and units of a common/collective trust managed by an affiliate of Vanguard. Any purchases and sales of these funds are open market transactions at fair market value or NAV. Vanguard is the trustee as defined by the Plan and, therefore, these qualify as party-in-interest transactions. Fees paid by the Plan to Vanguard amounted to \$37,214 for the year ended December 31, 2023. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. In addition, certain administrative functions are performed by employees of the Company for which no compensation is received from the Plan.

Note 6. Tax Status of the Plan

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated July 7, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Code. The Plan has been amended since the Plan received the IRS letter and the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of Section 401(a) of the Code. Therefore, the Plan is exempt from federal income taxes under Section 501(a) of the Code and no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Merger and Transfers Out, Net

If a participant of the Plan becomes eligible for the AAR CORP. Retirement Savings Plan, a separate plan sponsored by the Parent Company, they will cease participation in the Plan and become eligible to participate in the AAR CORP. Retirement Savings Plan. When they become eligible to participate in the AAR CORP. Retirement Savings Plan, their account balance in the Plan is automatically transferred into the AAR CORP. Retirement Savings Plan. A similar transfer occurs when a participant of the AAR CORP. Retirement Savings Plan becomes eligible for this Plan. During the year ended December 31, 2023, the gross amount of transfers into and out of the Plan were \$353,354 and \$28,297,787, respectively, resulting in a net transfer out of \$27,944,433.

On August 31, 2023, the Board of Directors of the Company voted to merge the Plan into AAR CORP. Retirement Saving Plan effective December 31, 2023. All plan assets were transferred to AAR Corp. Retirement Savings Plan on December 29, 2023.

Note 8. Plan Termination

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. Termination must have the approval of the Company's Board of Directors. In the event of termination of the Plan, the trust fund assets are appraised and each participant would become 100% vested in their Company contribution portion of their account as of the termination date.

Note 9. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in these risks in the near term could materially affect investment account balances and the amounts reported in the statements of net assets available for benefits.
