## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of MME Group, Inc. 401(k) & Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 14, 2023, and the related statement of changes in net assets available for benefits for the short plan year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 14, 2023 and December 31, 2022, and for the short plan year ended June 14, 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of MME Group, Inc. 401(k) & Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Prior Period Financial Statements**

The financial statements as of and for the year ended December 31, 2022, were audited by Rogers & King, CPA, LLC, who merged with Abdo as of December 20, 2023, and whose report dated September 27, 2023, expressed an unmodified ERISA Section 103(a)(3)(C) opinion on those statements.

## **Emphasis of Matter – Plan Merger**

As discussed in Note 1 to the financial statements, the governing body of MME Group, Inc. 401(k) & Profit Sharing Plan approved a plan merger with the Seaway Plastics Engineering, LLC Profit Sharing Plan (Seaway Plan), with an effective date of June 14, 2023. As a result of the merger, all of the Plan's assets were transferred to the Seaway Plan as of June 14, 2023. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

**Note 1: Description of Plan**

The description of the MME Group 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan original Plan document as amended for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established by MME Group, Inc. (the Plan Sponsor and Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

To be eligible to participate in the Plan, an employee of the Company must be 18 years old and entry to the Plan is on the first day of the Plan quarter upon reaching eligibility. Employees covered by a collective bargaining unit, leased employees, and non-resident aliens are excluded from eligibility.

**Plan Merger**

On May 12, 2023, the Plan Sponsor approved the merger of this Plan into the Seaway Plastics Engineering, LLC Profit Sharing Plan (“Seaway Plan”), effective June 14, 2023. As a result, all plan assets were transferred from the Plan into the Seaway Plan on the effective date.

**Contributions**

Each year, eligible participants may contribute up to 100% of pretax annual compensation, subject to IRS limits, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan allows participants age 50 and older to make catch-up contributions.

The Company made safe harbor matching contributions equal to 100% of eligible participants’ salary deferrals that did not exceed 3% of compensation plus 50% of eligible participants’ salary deferrals between 3% and 5% of compensation. Additional matching contributions may be contributed at the discretion of the Company’s Board of Directors, but they will not exceed 4% of compensation. No additional discretionary matching or nonelective contributions were made to the Plan during the short plan year ended June 14, 2023.

**Participant’s Accounts**

Each participant’s account is credited with the participant’s salary reduction contributions, employer matching contributions, rollover contributions and an allocation of the Company’s profit-sharing contributions and Plan earnings (net of administrative expenses). Allocations are based on the participant’s eligible compensation or account balances, as defined in the Plan. A participant’s investment allocation for current and future contributions can be changed on any business day at the discretion of the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their salary deferrals, and any rollover contributions and safe harbor employer matching contributions, plus earnings thereon. Participants, who leave the Plan because of death, early or normal retirement, or disability retirement, as defined in the Plan, are considered 100% vested. The Company's additional discretionary matching and nonelective employer contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

For purposes of determining the extent to which a participant is vested, a year of service is a consecutive twelve-month period in which the participant is credited with 1,000 hours of service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are determined by the Plan administrator but may not exceed five years. These loans are secured by the balance in the participant's account. The loans bore interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest was paid ratably through payroll deductions. As of June 14, 2023 all loan balances were transferred into the Seaway Plastics Engineering, LLC Profit Sharing Plan as a result of the Plan merger previously described.

**Payment of Benefits**

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or installments. Participants may withdraw a portion of this account balance as an in-service distribution and for hardship, as defined in the Plan.

If a participant terminates employment and their vested balance is \$5,000 or less, the Plan Administrator will direct the Custodian that any amount exceeding \$1,000 be distributed to an IRA. Account balances less than or equal to \$1,000 will be distributed to the participant in a lump sum as soon as administratively feasible after termination of employment. The distribution may be made directly to the participant or rolled over either to another qualified retirement plan or to an individual retirement account (IRA) at the participant's election.

**Forfeited Accounts**

Forfeitures (non-vested benefits) from terminated participants' accounts are used to fund safe harbor employer contributions and for the payment of Plan expenses. No forfeitures were used during the short plan year ended June 14, 2023 and there were no remaining unused forfeitures as of June 14, 2023 and December 31, 2022.

## **Note 2: Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for the fully responsive investment contract, which is measured at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All Plan assets were transferred to the Seaway Plastics Engineering, LLC Profit Sharing Plan on June 14, 2023, as described in Note 1.

### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were recorded as distributions based upon terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the administration of participant withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses may be included in net appreciation in fair value of investments.

### **Subsequent Events**

The Plan's management has evaluated subsequent events through, October 11, 2024, the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data, by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 14, 2023 and December 31, 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds previously held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds that were held by the Plan were deemed to be actively traded.

*Cash and cash equivalents:* Cash and cash equivalents are either cash or assets that are readily convertible into cash.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As a result of the Plan merger described in Note 1, all of the Plan's assets were transferred to the Seaway Plan, effective June 14, 2023, therefore the Plan did not hold any investments measured at fair value as of June 14, 2023.

**Note 4: Fully Benefit-Responsive Investment Contracts**

The Plan invested in the Met Life Stable Value Fund, which was a traditional fully benefit-responsive guaranteed investment contract (GIC) which totaled \$0 and \$27,795 as of June 14, 2023 and December 31, 2022, respectively. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan was a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established in a contract between the Plan and the contract issuer, which would not fall below 0%. The crediting rate was reviewed annually for resetting. The contract could not be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan)
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

**Note 5: Income Tax Status**

The Plan Sponsor has adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Plan management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status. The Plan has been amended since receiving the opinion letter.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the appropriate regulatory authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a Plan expires three years from the due date of the return or the date on which it is filed, whichever is later.

**Note 6: Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits, and accordingly, account balances of participants in the Plan.

**Note 7: Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at June 14, 2023 and December 31, 2022, and net appreciation in fair value of investments, and interest and dividends for the short plan year ended June 14, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand Benefits & Trust Company, the Plan's Custodian.

**Note 8: Related Party and Party-in-Interest Transactions**

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Hand Benefits & Trust Company, the Trustee of the Plan, manages certain Plan investments; therefore, these transactions qualify as party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.
