#### **Other Matter - Basis of Accounting**

As described in Note 2 to the financial statements, effective November 17, 2022, the Plan Sponsor made the decision to terminate the Plan. All assets were distributed out of the Plan by December 26, 2023. The Plan presented the financial statements as of December 26, 2023 and December 31, 2022 and for the period from January 1, 2023 through December 26, 2023 on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### 1. DESCRIPTION OF THE PLAN

The following description of the Communications Electronics, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the summary plan description and plan document for a complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, which was established effective August 1, 1985 by Communications Electronics, Inc. (the Company or Plan Sponsor). The Plan was terminated effective November 17, 2022 (Plan Termination Date). Prior to the Plan Termination Date, the Plan covered all eligible employees of the Company who had attained 21 years of age and completed 30 days of service. The Plan was most recently amended effective June 2, 2022 to adhere to the most recent tax law changes, amend eligibility requirements to exclude temporary, seasonal, interns, and various contract employees from participation in the Plan, and increase employee contribution change frequency. Prior to the Plan Termination Date, eligible employees could begin to participate on the first day of the month upon reaching the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan Termination

During the year ended December 31, 2022, the Plan Sponsor was acquired by Mobile Communications America, Inc. Pursuant to the acquisition, the Plan was effectively terminated on November 17, 2022 by the Plan Sponsor and began the process to distribute all assets to respective participants. As of the Plan Termination Date, no additional employees were eligible to enter the Plan and no contributions for periods attributable to compensation earned after the Plan Termination Date were made. As of the Plan Termination Date, participants became 100% vested in all contributions. Participants were provided with the option to elect a direct rollover of their account balance into an eligible retirement plan of another employer or to an individual retirement account (IRA) or receive a single lump-sum cash distribution of their account balance. All remaining assets were distributed from the Plan during the period from January 1, 2023 through December 26, 2023.

#### Participant Contributions

Prior to the Plan Termination Date, participants could contribute up to 100% of their compensation, as defined by the Plan, not to exceed the maximum allowable contributions under the Internal Revenue Code (the Code). Participants who attained age 50 before the end of the Plan year could make additional catch-up contributions, subject to limitations imposed by the Code. Participants could also contribute Roth 401(k) contributions to the Plan, which were maintained separately from pre-tax contributions. Participants were permitted to make rollover contributions to the Plan.

As the Plan terminated effective November 17, 2022, there were no participant contributions to the Plan during the period from January 1, 2023 through December 26, 2023.

#### Company Matching Contributions

Prior to the Plan Termination Date, the Company made safe harbor matching contributions to eligible participants on a per payroll basis. Employees who made deferrals during a payroll period and who had completed a year of service in which they worked at least 1,000 hours were eligible for Company safe harbor matching contributions. The Company used a plan year determination basis for purposes of calculating the safe harbor matching contributions. Therefore, eligible participants were entitled to a “true-up” contribution to the extent that the participant did not receive a safe harbor matching contribution based on their deferrals and plan compensation for the entire plan year, prior to the Plan Termination Date.

For the year ended December 31, 2022, the Plan Sponsor failed to calculate the required safe harbor matching “true-up” contribution in accordance with the Plan’s provisions. The Plan Sponsor funded the true-up contribution, including associated lost earnings, totaling \$29,967 during the period from January 1, 2023 through December 26, 2023. The Company did not make additional safe harbor matching contributions during the period from January 1, 2023 through December 26, 2023 as there were no participant contributions subsequent to the Plan Termination Date.

#### Company Profit-Sharing Contributions

Prior to the Plan Termination Date, the Company could also make discretionary profit-sharing contributions to the Plan on an annual basis. Participants that completed a year of service in which they worked at least 1,000 hours of service during the prior Plan year and were employed by the Company as of the last day of the Plan year were eligible to receive discretionary profit-sharing contributions. The Company did not make any discretionary profit-sharing contributions during the period January 1, 2023 through December 26, 2023.

#### Participant Accounts

Each participant's account was participant-directed and credited with the participant’s contributions, withdrawals and allocations of Company contributions, Plan earnings or losses, and administrative expenses in accordance with the investment options selected by each participant plus earnings thereon. Any earnings, losses and administrative expenses were allocated to participant accounts based upon the balance in each account. The benefit to which a participant is entitled was the benefit that could be provided from the participant’s vested account.

#### Notes Receivable from Participants

Prior to the Plan Termination Date, participants could borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount was \$1,000 and each participant could not have more than one note outstanding at any given time. The notes were collateralized by a participant's vested account balance. Note repayments were to be made at least quarterly with interest based on the prime rate plus 1%. Notes for reasons other than the purchase of a primary residence were to be repaid within five years. Notes for the purchase of a primary residence were to be repaid within ten years.

Subsequent to the Plan Termination Date, participants with outstanding notes had the option to continue to repay the note through April 17, 2023. Outstanding notes after that date were deemed as taxable distributions from the Plan as of December 26, 2023.

#### Payment of Benefits

Prior to the Plan Termination Date, upon termination of service, death, disability, retirement (age 65), or attainment of age 59 ½, a participant, or the participant's beneficiary in the event of death, was entitled to a distribution of the participant's vested account balance. Distributions from the Plan were payable in the form of a lump sum payment or partial withdrawals; however, distributions of accounts with balances less than \$1,000 must be in the form of cash. Distributions of accounts that are greater than \$1,000 but less than \$5,000 would be distributed from the Plan in the form of a rollover to another qualified plan or to an IRA established in the participant's name. Distributions of accounts that are greater than \$5,000 could only occur at the consent of the participant. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant could be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½. There were no net assets of the Plan allocated to the accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 26, 2023 and December 31, 2022.

Upon the Plan Termination Date, participants were provided with the option to elect a direct rollover of their account balance into an eligible retirement plan of another employer or to an IRA or receive a single lump-sum cash distribution of their account balance. All assets were distributed out of the Plan by December 26, 2023.

#### Vesting

Prior to the Plan Termination Date, participants were immediately vested in their contributions and in all Company safe harbor matching contributions, plus earnings thereon.

For Company discretionary profit-sharing contributions, vesting was based on years of continuous service, as defined by the Plan, according to the following graduated vesting schedule:

In the event of death, disability, or attainment of retirement a participant became 100% vested in Company discretionary profit-sharing contributions, regardless of years of service. As of the Plan Termination Date, participants became 100% vested in all contributions.

#### Forfeitures

Forfeitures of Company contributions are applied to pay administrative expenses or to reduce future Company contributions. Forfeitures available to the Plan totaled \$0 and \$1,253 as of December 26, 2023 and December 31, 2022. During the period from January 1, 2023 through December 26, 2023, no forfeitures were used to reduce Company contributions. Forfeitures totaling \$2,932 were used to pay Plan expenses during the period from January 1, 2023 through December 26, 2023.

#### Plan Expenses

All administrative expenses are paid with the assets of the Plan, unless paid by the Company, at its discretion. During the period from January 1, 2023 through December 26, 2023, the Company elected to pay a portion of the Plan's administrative expenses. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

As described in Note 1, the Plan terminated effective November 17, 2022. The Plan's financial statements are presented using the liquidation basis of accounting as of December 26, 2023 and December 31, 2022 and for the period from January 1, 2023 through December 26, 2023 and in accordance with accounting principles generally accepted in the United States of America.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits in liquidation during the reporting period. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan provides for investments in financial instruments that are exposed to risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur in the near term and materially affect the amounts reported in the statements of net assets available for benefits in liquidation.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2023 through December 26, 2023.

#### **Fair Value Measurement**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement levels within the fair value hierarchy are based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interest in common/collective trust:* Valued at the NAV practical expedient, as determined by the issuer.

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the shares are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 26, 2023 and December 31, 2022.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – cont'd.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 9, 2024, the date the financial statements were available to be issued and determined there were no material events that warrant disclosure.

### 3. INVESTMENTS

All investment data contained in the accompanying financial statements, including assets held at December 26, 2023 and December 31, 2022, interest and dividend income and net appreciation in fair value of investments for the period from January 1, 2023 through December 26, 2023 were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Trust Company LLC, the Custodian of the Plan.

### 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by John Hancock Retirement Plan Services, LLC., an affiliate of the Custodian. Prior to the Plan Termination Date, the Plan loaned funds to its participants according to the applicable provisions of the Plan agreement. The Company provided the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualified as party-in-interest transactions, which were exempt from the prohibited transaction rules.

### 5. INCOME TAX STATUS

The volume submitter document, upon which the Plan was designed, received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan was qualified under Section 401(a) of the Code and therefore was exempt from taxation. Once qualified, the Plan was required to operate in conformity with the Code to maintain its qualification. The Plan was amended and restated subsequent to receiving the opinion letter; however, the Plan administrator believes the Plan was being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes have been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan was tax exempt and had no unrelated business income, the provisions of ASC 740 did not have an impact on the Plan's financial statements. The Plan recognized interest and penalties on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 26, 2023 and December 31, 2022.
