## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Escambia Community Clinics, Inc. dba  
Community Health Northwest Florida Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Escambia Community Clinics, Inc. dba Community Health Northwest Florida Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ## **1. DESCRIPTION OF THE PLAN**

The following description of the Escambia Community Clinics, Inc. dba Community Health Northwest Florida Retirement Plan, formerly Escambia Community Clinics, Inc. 403(b) Plan, (the Plan) provides only general information. Participants should refer to the summary plan description of the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all full-time employees of Escambia Community Clinics, Inc. d/b/a Community Health Northwest Florida (the Plan Sponsor or Employer). The Plan, adopted in 1992, was amended and restated in 2018 to permit employer discretionary matching contributions. Effective with this amendment, the Plan name was changed from Escambia Community Clinics, Inc. 403(b) Plan to Escambia Community Clinics, Inc. dba Community Health Northwest Florida Retirement Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

### **Contributions**

The Plan permits elective deferrals and Roth contributions by all employees. There is no age or service requirement to contribute elective deferrals to the Plan. There is no minimum age or service requirement to receive an employer discretionary matching contribution. However, to receive an employer nonelective contribution, a participant must have one year of service (defined as 1,000 hours of service) and be age 21 or older. Each year, participants may contribute up to the maximum percentage allowable not to exceed the limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and Roth contributions. The Plan Sponsor may make a nonelective contribution of 3.5% of eligible compensation to eligible participants. Additional amounts may be contributed at the option of the Plan Sponsor. The Plan Sponsor makes discretionary matching contributions up to 3% of the participant's elective deferral. Contributions are subject to certain limitations.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor contribution, (b) Plan earnings or losses and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

### **Investment Options**

Upon enrollment in the Plan, a participant directs the investment of amounts credited to his or her account in mutual funds and pooled separate accounts. Participants may change their investment options daily.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant will receive either a lump-sum amount or an annuity equal to the entire value of the participant's account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Administrative Costs**

Substantially all administrative expenses of the Plan are paid by the Plan Sponsor.

**Hardship Withdrawals**

Participants may make hardship withdrawals if they have an immediate and heavy financial need and other resources are not available to meet the need. Hardship withdrawals may be withdrawn from the salary deferral portion of a participant's account.

**Notes Receivable from Participants**

Participants may borrow from their vested account balance in accordance with IRC requirements. The loan amount is allowed at a minimum of \$1,000 and a maximum of 50% of the participant's vested balance up to \$50,000. The loans are secured by the vested balance in the participant's account and bear interest which is commensurate with local prevailing rates as determined at the time of the loan issuance. Principal and interest are payable ratably through payroll deductions over terms ranging up to five years, except for home loans, which may range up to ten years.

**Plan Termination**

Although it has not expressed an intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**3. CERTIFIED INFORMATION**

All investment information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included in the Plan's financial statements and supplementary schedule, was prepared by or derived from information certified as complete and accurate by Hancock Whitney Bank, the trustee of the Plan, and The Variable Annuity Life Insurance Company (VALIC), the custodian of the Plan, and furnished to the Plan administrator.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Based upon net asset value (NAV) as a practical expedient. The NAV of a pooled separate account is based on the market value of its underlying investments. The pooled separate account's NAV is not a publicly quoted price in an active market.

**5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan invests in the Fixed Income Account, a group annuity contract offered by VALIC that is fully benefit responsive. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the group annuity contract meets the criteria to be considered fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. At December 31, 2023 and 2022, the fair value of the investment contract was \$295,874 and \$299,958, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

**6. TAX STATUS**

The Plan has adopted a volume submitter plan sponsored by EPIC Advisors, Inc. The IRS has determined and informed EPIC Advisors, Inc. by an advisory letter dated March 31, 2017, that the volume submitter plan is designed in accordance with applicable sections of the IRC. The volume submitter plan has been amended since receiving the advisory letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were managed by Hancock Whitney Bank, the trustee of the Plan, and VALIC, the custodian of the Plan. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

**8. FORFEITURES**

Forfeited balances of terminated participants' non-vested accounts may be used to pay reasonable expenses of the Plan, and then may reduce future Plan Sponsor contributions. At December 31, 2023 and 2022, forfeited non-vested accounts totaled approximately \$40,269 and \$32,070, respectively.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. SUBSEQUENT EVENT**

The Company has evaluated events and transactions that occurred between December 31, 2023 and September 23, 2024, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

In March 2024, the Plan Sponsor suspended the nonelective employer contribution.
