#### **(1) Description of Plan**

The following description of the Bake Crafters Food Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### ***General***

Effective January 1, 2019, Bake Crafters Food Company and other related participating entities (the Company) established Bake Crafters Food Company 401(k) Plan.

The Plan is a defined contribution plan covering all employees of the Company who are at least 21 years of age and have either achieved six consecutive months of employment or have been credited with a year of service. A year of service will be credited if, at the end of the twelve month period beginning on date of hire, 1,000 hours of service have been completed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The plan administrator is responsible for oversight of the Plan. The trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

##### ***Plan Merger***

The Plan was amended and restated effective January 1, 2024 to reflect the merger of the Plan into the Murry's, Inc. 401(k) Retirement Plan (subsequently referred to as the Plan Merger). Each participant in the Plan on December 31, 2023, became a participant in the Murry's, Inc. 401(k) Retirement Plan effective January 1, 2024. Net assets of the Plan amounting to \$2,018,742 were transferred to the Murry's, Inc. 401(k) Retirement Plan and are included in transfers in the statement of changes in net assets available for benefits for the year ended December 31, 2023. On January 1, 2024, the Murry's, Inc. 401(k) Retirement Plan was renamed the MBC Companies 401(k) Retirement Plan.

##### ***Contributions***

Each year, participants may contribute pretax annual compensation up to the limits determined by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover contributions). Participants may also make Roth contributions.

The Company makes safe harbor matching contributions equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. The Company may also make discretionary profit-sharing contributions to the plan.

Participants may direct (a) their contributions and (b) safe harbor matching and discretionary employer profit-sharing contributions into various investment options. Participants may change their investment options at any time.

#### (1) Description of Plan, Continued

##### *Participant Accounts*

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contributions and allocations of (a) the Company's discretionary contribution, if any, and (b) Plan earnings or losses, net of expenses. Allocations are based on participant earnings or losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Participants are also immediately vested in Company safe harbor matching contributions. Vesting in the Company's discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of continuous service as follows:

2	20%
3	40%
4	60%

##### *Payment of Benefits*

Payments of benefits are generally in the form of lump-sum distributions. Upon attaining the normal retirement age (age 59 ½), death, or permanent disability, a participant is entitled to 100% of his or her account balance. If employment is terminated for reasons other than normal retirement, death, or permanent disability, a participant is entitled to his or her vested account balance. The Plan allows for distributions in the event of financial hardship, subject to certain restrictions of the Plan.

##### *Forfeited Amounts*

The forfeited, nonvested portion of the participants' account balances are generally used to reduce future Company contributions or administrative fees. There are no forfeited nonvested accounts as of December 31, 2023 as a result of the Plan Merger described above. At December 31, 2022, forfeited non-vested accounts totaled \$472. During 2023, \$449 of forfeitures were used to reduce employer contributions.

#### **(2) Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting.

##### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Contributions***

Contributions from plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### ***Payment of Benefits***

Benefits are recorded when paid.

##### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the processing of distributions are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### ***Subsequent Events***

The Plan has evaluated subsequent events through September 30, 2024, the date the financial statements were available to be issued.

#### (3) Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2023 and 2022, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (Voya), a qualified institution.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### (4) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. These investments held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

There were no significant transfers among investment levels during the years ended December 31, 2023 and 2022.

#### (5) Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Voya totaling \$160,730 at December 31, 2022. As a result of the Plan Merger, the Plan has no funds held or allocated to this investment contract as of December 31, 2023.

Voya maintains the amounts allocated to the contract in a separate investment account. The account is credited with contributions and earnings in the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based upon a formula agreed upon with the issuer. The interest rate is reviewed on an annual basis for resetting. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the Plan contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

#### **(5) Investment Contract with Insurance Company, Continued**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk or the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs as a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA. The Plan Merger did not limit the Plan's ability to transact at contract value with participants.

#### **(6) Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are managed by Voya. Voya is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments.

#### **(7) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

#### **(8) Tax Status**

The Plan uses a prototype document sponsored by ERISA Services Inc. ERISA Services Inc. received an opinion letter from the IRS specifying that the prototype document and related trust are designed in accordance with applicable provisions of the Internal Revenue Code (IRC) and, is therefore, exempt from federal income taxes. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

#### **(8) Tax Status, Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **(10) Non-exempt Transactions**

During 2022 and 2021, the Company failed to remit to the Plan's custodian certain participant contributions within the period prescribed by the Department of Labor regulations. Late contributions for 2022 and 2021 totaled \$588 and \$144, respectively. The Company intends to compensate the affected participants for any lost earnings resulting from the delay in contributions in 2024.


