As a result of the sale, substantially all of the assets of the Company were transferred to Star Safety Technologies, LLC. The Plan was terminated upon sale of the Company and all Plan assets were transferred or distributed to the individual participants.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Star Headlight & Lantern Co., Inc. Employee Profit Sharing and 401(k) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Star Headlight & Lantern Co., Inc. Employee Profit Sharing and 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of Plan - The following description of the Star Headlight and Lantern Co., Inc., (“Company”) Employee Profit Sharing and 401(k) Savings Plan (“Plan”) provides only general information. The Plan was established to provide tax-deferred retirement savings to eligible employees. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan available to employees of the Company who meet the eligible requirements to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On April 17, 2023, the Company completed an asset sale with Star Safety Technologies, LLC. As a result of the sale, substantially all of the assets of the Company were transferred to Star Safety Technologies, LLC. The Plan was terminated upon sale of the Company and all Plan assets were transferred or distributed to the individual participants through July 2023.

Contributions - Each year, participants may make pre-tax contributions from their annual compensation, up to amounts permissible under ERISA and the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company has the option of making annual discretionary contributions to the Plan that are invested in a portfolio of investments as directed by the Company.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as the Company’s profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Employees are vested according to the following schedule:

Notes Receivable from Participants - Participants may borrow from their fund accounts the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are limited to one in a twelve-month period. The loans are secured by the balance in the participant’s account. The loan interest rate is set at 1% over prime at time of loan issuance. As of December 31, 2022, all outstanding loans have an interest rate between 4.25% and 8.00%. Principal and interest is paid ratably through monthly payroll deductions. There were no notes receivable outstanding as of December 31, 2023 after termination of Plan in 2023 (See Note 1).

Payment of Benefits - On termination of service due to death, disability, or retirement, benefits may be paid in a lump sum amount or installment payments over a period not to exceed the joint life expectancy of the participant and spouse. Participants may withdraw any part of their vested account which does not result from discretionary contributions after reaching the age of 65.

Forfeited Accounts - At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$- and \$5,426, respectively. These accounts will be used to reduce future employer contributions and administrative expenses. In 2023, \$5,426 of forfeitures were used to offset employer contributions or administrative expenses

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Shares of registered investment companies are valued at quoted prices in an active market which represent the net asset value of shares held by the Plan at year end. Common collective funds are not traded on an active market, but instead are valued using the net asset value (NAV) provided by the administrator of the fund. The unit price is based on underlying investments which are traded on an active market. The Plan's Investment Committee determines the Plan's valuation policies, utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2022. There were no notes receivable outstanding as of December 31, 2023.

Payment of Benefits - Benefit payments to participants are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan evaluated subsequent events through the date of the report, which is the date these financial statements were available to be issued.

Note 3. Information Prepared and Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company (the trustee of the Plan).

Note 4. Fair Value Measurements

ASC 820 establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Common / Collective Funds - A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Party-in-Interest Transactions

During 2023 and 2022, Plan investments were managed by Burke Group. The Plan's trustee was Newport Trust Company, therefore, these advisory and administrative fees qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions.

Note 7. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On April 17, 2023 the Company completed an asset sale with Star Safety Technologies, LLC. As a result of the sale, substantially all of the assets of the Company were transferred to Star Safety Technologies, LLC. The Plan was terminated upon sale of the Company and all assets were transferred out in July 2023. Upon Plan termination, participants would become fully vested in their employer contributions.

Note 8. Tax Status

The Plan uses a prototype plan document sponsored by Newport Group Inc. The Internal Revenue Service ("IRS") has determined and informed Newport Group Inc, in a letter dated June 30, 2020, that the prototype document satisfied the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the Newport Group Inc received the determination letter, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
