**Independent Auditors' Report**

To the Board of Trustees  
Greiner Industries, Inc. Profit Sharing and 401(K) Savings Plan

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Greiner Industries, Inc. Profit Sharing and 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2023, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Greiner Industries, Inc. Profit Sharing and 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Greiner Industries, Inc. (the Sponsor) who satisfy various stated requirements for eligibility. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was last restated effective January 1, 2021, to maintain compliance with the Internal Revenue Code.

**Custodian and Investments**

All invested funds are considered participant - directed. During the year presented, these funds were held by Voya Retirement Insurance and Annuity Company (Voya) (custodian) and invested in a selection of pooled separate accounts.

Participants direct the investment of monies deferred from their eligible compensation, as well as allocated sponsor contributions, into various investment options as offered by the Plan.

**Contributions**

Participants may contribute up to the maximum percentage allowable, not to exceed the limits of Code Sections 401(k), 404 and 415 of their compensation. For 2023 the Sponsor matched 50% of the participant's contribution to the Plan on salary deferrals up to 5% of the eligible participant's compensation, excluding bonuses. The Sponsor may make discretionary contributions to the Plan which are not limited to its current or accumulated net profit. No such discretionary contributions were made by the Sponsor to the Plan for 2023.

The Plan provides for rollover contributions and Roth elective deferrals.

The Plan does not provide for automatic enrollment.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of the Sponsor's contribution and Plan earnings, and also charged with an allocation of expenses paid by the Plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested 100% in both voluntary and all Sponsor contributions upon entering the Plan.

**Payment of Benefits**

Upon termination due to death, payment shall be made pursuant to the election of the participant or designated beneficiary.

Upon termination for other reasons, participants may receive payment immediately in lump-sum or in installments. Participants may also roll over their account to another qualified plan.

For participant accounts less than \$5,000 which remain upon termination for which no distribution elections have been made, the Plan provides for forced cash-outs.

The Plan also allows for hardship and in-service distributions if certain criteria are met.

**Administrative Expenses**

During 2023 the Plan paid all costs, as billed, associated with third-party investment advisory and management fees as well as other related administrative expenses. The Sponsor did pay the cost of the Plan's 2022 audit in the amount of \$7,900.

Fees incurred by the Plan for the respective custodian's investment management services are included in net appreciation (depreciation) in fair value of pooled separate accounts, as they are paid through revenue sharing rather than a direct payment.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting**

The financial statements of the Plan are prepared using the modified cash basis of accounting. This method of accounting is a comprehensive basis of accounting other than generally accepted accounting principles. Under the modified cash basis of accounting, the securities and investments are adjusted to fair value, Plan Sponsor related receivables are recorded, other receivables and certain liabilities (investment and administrative expenses) are not recorded. The Plan does not disclose or record a liability for amounts allocated to accounts of persons who have elected to withdraw from the Plan by year end but have not been paid. Benefits are recorded when paid.

The Plan presents its financial statements using guidance found in FASB ASU 2015-12 and 2015-07. Specific investment disclosures described in the above noted FASB pronouncements applicable to these financial statements are as follows:

- 1) No disclosure is required for individual investments greater than 5% of net assets available for benefits.
- 2) Net appreciation/depreciation must be disclosed only in the aggregate, not by investment type.
- 3) Investments required to be disclosed by fair value hierarchy and disaggregated based on only general types of investment (ie. bonds, mutual funds, collective funds, etc.), eliminating the further disaggregation by their nature, risks and characteristics.
- 4) Investments that report fair value using net asset value as a practical expedient to estimate fair value are no longer required to be reported in the fair value hierarchy.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments in pooled separate account are valued at net assets value (NAV) of shares held by the Plan at year-end. NAV is used as a practical expedient to estimate the fair value. Shares may be redeemed on a daily basis. There is no significant notice period associated with this category.

Interest and dividend income are recorded on the cash basis of accounting.

Net appreciation/(depreciation) in fair value of pooled separate accounts includes gains (losses) on investments traded, as well as held during the year. Related investment fees are netted into the amount reflected in the financial statements.

**Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the applicable valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Pooled Separate Accounts:* Valued at net asset value, which is based on the latest quoted market price of the investments held within the fund.

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)**

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 5 – RELATED-PARTY TRANSACTIONS**

The following transactions for the year ended December 31, 2023, qualify as material exempt party-in-interest transactions and are disclosed as follows:

Voya Retirement Insurance and Annuity Company (Voya), as the custodian of Plan assets during 2023, is considered a party-in-interest that received indirect compensation from the Plan during 2023. The amount of this compensation amounted to \$92,031 for 2023, on a modified cash basis. This amount, along with the above, are shown as administrative expenses, other in the aggregate amount of \$102,623 on page 6 of the financial statements as presented.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their total account balances.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service has determined and informed the Sponsor by letter dated June 19, 1991, that the original Plan and related trust were then designed in accordance with applicable sections of the Internal Revenue Code (IRC). Several subsequent amendments to the prototype plan document have been approved by the Internal Revenue Service. The most recent determination letter from the Internal Revenue Service dated March 31, 2014, was favorable. The Plan was restated effective January 1, 2021, to maintain compliance with IRC, provide for in-service withdrawals and participant Roth deferrals. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

As such, the Plan Administrator instructed White, Rudy LLC not to perform any auditing procedures with respect to investment-related information. The Plan's sponsor Greiner Industries, Inc.'s sole stockholder sold all company stock as held to IES Infrastructure Solutions, LLC effective April 1, 2024. The effect of the sale on the Plan is unknown as of the date of this report.

During August 2024 the Plan's third-party administrator, Valley Forge Pension Management, Inc., was acquired by Prime Pensions, Inc. The effect of this acquisition on the Plan's administrative operations is unknown as of the date of this report.
