Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of The Profit Sharing Plus Plan (the plan) of Advantage Management Corporation, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE TO FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF PLAN

The following description of The Profit Sharing Plus Plan (the plan) of Advantage Management Corporation (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan. Advantage Management Corporation is the administrator and sponsor of the Plan. The participating employers also include Dart Transit Company, Highway Sales, Inc., Safety Lane, Inc., 41-1827482 d/b/a Dart Advantage Logistics, Dartco, Inc., Dart Intermodal, Inc., Dart X, Inc. d/b/a Dart Express, Fleetline, Inc., Pro Stop Service Centers, Inc., Dart Advantage Warehousing, Inc., Atlas Real Estate Management Company, 41-1957158 d/b/a Dedicated Services, and DACA Management, Inc (the Company) (the Employer). The Plan was established in 1968 and uses Fidelity Management Trust Company as the plan trustee (custodian). The participants are responsible for the direction of their account balances into specific investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility:

Employees of the Company who are not covered by collective bargaining agreements under which they have specifically negotiated coverage by the Plan, who are not residents of Puerto Rico, who are not leased employees, who are not interns, who have attained the age of nineteen years of age and have completed one month of service are eligible to participate in the Plan. The service requirement is six months of service for employer matching and employer non-elective contributions. Plan entry dates are the first day of each month.

Contributions:

Each year, participants may contribute up to 60% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The employer elected to match an amount up to 50% of the first 5% of the participant's compensation. The Plan also provides for discretionary non-elective profit-sharing contributions, under which the Company may contribute additional funds which will be allocated (as a percentage of each individual's compensation) to each participant in active service on December 31 of the plan year. No non-elective contributions were made for the years ended December 31, 2023 and 2022. Contributions are subject to certain limitations.

NOTE 1. (CONTINUED)

Participant accounts:

Each participant's account is credited with participant pre-tax deferrals, participant post-tax Roth contributions, Company matching contributions, any other discretionary contributions made by the Company and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are valued at the end of each business day. The benefit the participant is entitled to is the benefit that can be provided from the participant's vested account.

Notes receivable from participants:

Participants may borrow against their vested account balances, subject to a minimum loan of \$1,000 up to a maximum of 50% of their vested account balances or \$50,000. The participant's balance in the Plan is security for the note and prevailing interest rates are charged. Interest rates for the outstanding notes at December 31, 2023 range from 5.25% to 10.50%. The term of the note will be described in the promissory note evidencing the loan. Repayment can be made by payroll deductions or payment to the employer.

Vesting:

Participant elective 401(k) contributions and earnings on such contributions are always fully vested. Employer matching contributions and additional employer contributions are subject to a vesting percentage, which increases for each year of service (beginning with the second year of service) at 20% per year. Upon completion of six years of vesting service, the participant is 100% vested.

Payment of benefits:

Distributions from the Plan are made in installments or a lump sum payment, upon death, disability, retirement, or termination. Amounts contributed through salary reductions may be distributed only upon termination of employment or attaining the age of 59-1/2. If terminated/retired participants do not voluntarily elect to move their funds out of the Plan, vested account balances between \$1,000 and \$4,999 are rolled into an IRA on the participant's behalf. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator can authorize the benefit payment without the Participant's consent.

Active (not terminated/retired) participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan and withdrawals are limited pursuant to the Plan's provisions.

Forfeitures:

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$100,675 and \$31,031, respectively. These accounts will be used to reduce future employer contributions or pay plan administrative expenses. During the years ended December 31, 2023 and 2022, \$39,059 and \$98,962, respectively, were used to reduce employer contributions. During the years ended December 31, 2023 and 2022, \$5,308 and \$1,939, respectively, were used to reduce administrative expenses.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are maintained on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies when utilizing information provided by the investment advisors, custodians, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan agreement.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

Subsequent events:

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 10, 2024, the date the financial statements were available to be issued.

NOTE 3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Fidelity Management Trust Company (FMTC), the trustee (custodian) of the Plan, has certified as to the completeness and accuracy of all investment information reflected in the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, the statements of changes in net assets available for benefits for the years ending December 31, 2023 and 2022, and the supplemental schedule of assets (held at end of year) as of December 31, 2023.

NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets and liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4. (CONTINUED)

Self-directed brokerage accounts: Consists of Fidelity BrokerageLink Accounts, containing mutual funds and cash. Mutual funds are valued at the NAV of shares held by the Plan at year end. Cash is valued at face value.

Collective trust fund: Valued at the daily net asset value (NAV) of units. The NAV, as provided by the trustee, is a readily determinable fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by FMTC. These transactions qualify as exempt party-in-interest transactions.

Pursuant to a service agreement between the Company and FMTC, FMTC receives revenue from certain plan investments managed by FMTC. This revenue is used to offset certain amounts owed to FMTC for administrative services to the Plan. Approximately \$15,000 of revenue received by FMTC was credited back to participants for the years ended December 31, 2023 and 2022. Net administrative expenses (refunds) were \$1,182 and (\$3,828) for the years ended December 31, 2023 and 2022, respectively.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. PLAN TAX STATUS

The Plan is currently evidenced by a prototype document sponsored by Fidelity. Fidelity has received an Internal Revenue Service (IRS) opinion letter dated June 30, 2020, stating that the prototype document complies with Section 401 of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter, however, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 9. CONCENTRATIONS AND CONTINGENCIES

One fund accounted for approximately 34% of the net assets available for benefits for the year ended December 31, 2023. Two funds accounted for approximately 42% of the net assets available for benefits for the year ended December 31, 2022.
