### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Colorado Physician Partners 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 29, 2023 (in liquidation) and December 31, 2022 (ongoing), the related statement of changes in net assets available for plan benefits in liquidation for the period from January 1, 2023 to December 29, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 29, 2023 and December 31, 2022, and for the period from January 1, 2023 to December 29, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination and Liquidation Basis**

As discussed in Note 1 to the financial statements, the Board of Managers of Colorado Physician Partners, PLLC, the Plan's sponsor, voted on August 1, 2023 to terminate the Plan effective July 28, 2023. All assets of the Plan were liquidated by December 29, 2023. As a result, the Plan changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the financial statements for the period ended December 29, 2023. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Colorado Physician Partners 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a safe harbor defined-contribution plan established January 1, 2019 for the benefit of employees of Colorado Physician Partners PLLC (the “Plan Sponsor” or “Employer”).

The Plan is a defined contribution plan established by the Plan Sponsor under the provisions of Section 401(k) of the Internal Revenue Code (IRC). The Plan is administered by Legacy Benefits Services, LLC, who performs the function of the third-party administrator, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company has appointed an administrative committee (the “Plan Committee”) as administrator of the Plan, which carries out the duties imposed under ERISA. Transamerica Life Insurance Company (the “Trustee”), is responsible for the custody and management of the Plan’s assets.

The Plan Sponsor’s Board of Managers adopted a resolution to terminate the Plan effective July 28, 2023. All assets were distributed to participants by December 29, 2023.

#### Eligibility

Employees are eligible to participate in the Plan once they attain age 21 after six months of employment. They may enter the Plan on the first day of any quarter following the satisfaction of eligibility requirements.

#### Participants’ Contributions

Participation in the Plan is voluntary. A participant’s deferral percentage is subject to the maximum annual limit determined by the Internal Revenue Service (“IRS”). Individuals who reach the age 50 by the end of the Plan year are allowed to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Contributions are deposited in the appropriate investment fund as directed by the participants.

#### Employer’s Contributions

The Plan allows for safe harbor matching contributions and discretionary profit-sharing contributions (which are allocated to eligible Plan participants based on compensation). The Company makes safe harbor matching contributions equal to 100% of employee contributions that do not exceed 3% of eligible compensation plus 50% of employee contributions in excess of 3% up to 5% of eligible compensation. The Plan terminated effective July 28, 2023 and all contributions ceased at that time.

All employer contributions are invested in the same manner that the participant directs his or her participant deferral contribution. There were no discretionary profit-sharing contributions for the period from January 1, 2023 to December 29, 2023. All contributions are subject to certain IRS limitations.

### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and allocations of Plan earnings or losses. Allocation of Plan earnings or losses is based on participant account balances, as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator and Plan Committee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions and safe harbor Employer contributions plus actual earnings thereon. Participants vest in any discretionary Employer profit sharing contributions based on their years of service according to the following vesting schedule:

<u>Completed Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years	0%
2 but less than 3 years	20%
3 but less than 4 years	40%
4 but less than 5 years	60%
5 but less than 6 years	80%
6 or more	100%

As a result of the Plan termination effective July 31, 2023, all participants became 100% fully vested in their accounts under the Plan.

#### Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their account, a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance, whichever is less. Participants can have one loan outstanding at a time and participants are charged a set-up fee of \$100 for all new loans. Loans must be repaid to the Plan through salary deductions over a period not to exceed five years. Interest is charged at the prime rate plus 1%. Principal and interest is paid ratably through biweekly deductions. Upon termination of employment, any outstanding balance is due. At December 29, 2023, there were no outstanding loans. At December 31, 2022, outstanding loans bore interest ranging from 4.25% to 6.50%.

#### Payment of Benefits

Participant contributions are available for withdrawal at the participant's death, retirement, disability, or termination of employment with the Company. Accounts with balances under \$5,000 are subject to mandatory cash out distributions. Additionally, after age 59 1/2 or under certain circumstances of financial hardship, the participant is allowed to make in-service withdrawals.

### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

#### Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with Internal Revenue Service (IRS) regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

#### Forfeited Accounts

Forfeited non-vested accounts attributable to discretionary Employer profit sharing contributions may be used to offset Employer contributions, reduce administrative expenses, and/or restore forfeited account balances of rehired employees. Any balance in the forfeiture account at December 31 is carried over to the next year. At December 29, 2023 and December 31, 2022, the Plan had \$0 in forfeited non-vested accounts. During the period ended December 29, 2023, \$6,926 of forfeitures were used to offset Employer contributions and pay Plan expenses.

### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The Plan presents its financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### Basis of Presentation

Due to the decision to terminate the Plan during 2023, management determined that liquidation of the Plan was imminent and the financial statements for 2023 have been prepared using the liquidation basis of accounting. The 2022 financial statements were prepared as a going concern on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value, except for the Stable Value Fund, which is stated at contract value (See Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments purchased or sold, as well as held during the year.

#### Investment Valuation and Income Recognition (Continued)

Management fees and operating expenses charged to the Plan for its investments are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for applicable investments.

#### Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 29, 2023 and December 31, 2022. Interest income is recorded on the accrual basis. If a participant fails to make loan payments, under the terms of the loan document, the participant's loan balance is reduced, and a benefit payment is recorded as a deemed distribution. There were no outstanding notes receivable from participants as of December 29, 2023.

#### Benefit Payments

Benefit payments are recorded when paid.

#### Administrative Expenses

The Plan Sponsor currently pays for most of the Plan's expenses. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Administrative expenses are charged on a pro-rata basis to the value of the participants account balances. Loan fees are paid directly by the Participant.

#### Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 29, 2023 and December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

#### Subsequent Events

The Plan has evaluated subsequent events through October 7, 2024, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure.

### **NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 29, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 to December 29, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Life Insurance Company (the trustee of the Plan).

### **NOTE 4 – FAIR VALUE MEASUREMENT**

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable, are supported by little to no market activity, and are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Registered investment companies (mutual funds)*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 – STABLE VALUE FUND**

The Plan has entered into a fully benefit-responsive investment contract with Transamerica Life Insurance Company. Transamerica Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than the contract's minimum guaranteed interest rate. The effective credited interest rate is set semi-annually and effective on the first day of the semiannual period. The interest rate was 1.10% from January 1, 2023 through June 30, 2023 and 1.25% from July 1, 2023 through December 29, 2023. The interest rate at December 31, 2022 was 0.90%.

This contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the permitted measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

Upon full or partial contract or plan termination and certain other sponsor-initiated events, distributions from the GIA may be subject to a liquidation value (market value) adjustment pursuant to a formula specified in the contract. The market value formula may produce a value that is more or less than the book value of the Plan's investment in the GIA.

### **NOTE 6 – RELATED PARTY TRANSACTIONS**

Notes receivable from participants qualify as party-in-interest transactions. Additionally, certain fees paid by the Plan for investment services performed by the Plan's trustee are included as a reduction of the return earned on each investment fund. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### **NOTE 7 – TAX STATUS**

The Plan has adopted a non-standardized form of a pre-approved defined contribution plan, sponsored by Dataair Employee Benefit Systems Inc. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan administrator believes the Plan is designed, and is being operated, in compliance with the applicable provisions of the IRS.
