Note 1 – Description of Plan

The following description of the Sacramento Independent Hotel, Restaurant and Tavern Employees Welfare Trust (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan was organized on June 21, 1966, as provided by the collective bargaining agreement between UNITE H.E.R.E. Local 49 A.F.L. – C.I.O. and certain employers in the hotel, restaurant and tavern industry. The Plan provides medical, vision, life, and accidental death and dismemberment insurance benefits to participants on whose behalf employers contribute to the Plan in accordance with their collective bargaining agreements. It is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Plan provides medical, vision, life, and accidental death and dismemberment insurance benefits to participants on whose behalf employers contribute to the Plan in accordance with their collective bargaining agreements. Dental and prescription drug benefits are provided on a self-insured basis. Medical benefits are provided on either an insured or self-insured basis.

Contributions

The collective bargaining agreement provides that participating employers make monthly contributions to the Plan to provide benefits for members. The employers' contribution rates are established by the collective bargaining agreements.

The Plan receives contributions from participants under the provisions of COBRA (Consolidated Omnibus Budget Reconciliation Act) which provides that participants can elect to continue, for specified periods of time, their health care benefits which otherwise would have been lost due to certain events by making the required contribution.

Note 2 – Summary of Significant Accounting Policies

Date of Management's Review

Subsequent events were evaluated through October 11, 2024, which is the date the financial statements were issued. All subsequent events requiring recognition as of October 11, 2024, have been incorporated into these financial statements herein.

Basis of Presentation

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. The fair value of the Plan's money market accounts are valued at cost which approximates market value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Employer Contributions Receivable

Employer contributions receivable represents amounts due as of December 31, 2023 and June 30, 2023 under terms of the collective bargaining agreements. Employer records are subject to audit and additional revenue, if any, which may arise as a result of these audits, is recognized when final amounts are determined and remitted by the employer.

Plan Benefits

Plan obligations for health claims incurred by active participants but not reported and accumulated eligibility are estimated by the Plan based on certain estimates and assumptions which are subject to change. Due to uncertainties inherent in these estimates and assumptions, it is at least reasonably possible that changes in estimates and assumptions in the near term would be material to the financial statements. Due to merger with UNITE HERE HEALTH there was no calculation at December 31, 2023.

Note 3 – Stop-Loss Reimbursement

The Plan has stop-loss insurance on behalf of the participants covered under the self-insured health plan in order to limit its exposure, which will reimburse the Plan for total individual claims and total aggregate claims exceeding certain limits. For the six months ended December 31, 2023 and the year ended June 30, 2023, the Plan recognized stop-loss reimbursements of \$172,055 and \$287,529, respectively, which are netted against claims in benefits paid.

Note 4 – Related Party Transactions

Common administrative expenses incurred is shared with the Sacramento Independent Hotel, Restaurant and Tavern Employees Pension Trust Fund (the Pension Fund). The amount due to the Pension Fund at December 31, 2023 of \$67,575 was transferred in merger. The amount due to the Pension Fund was \$7 at June 30, 2023.

Note 5 – Investments

The Plan's investments are held by bank administered trust.

During the six months ended December 31, 2023 and the year ended June 30, 2023, the Plan's investments (including investments bought, sold, and held during the year) appreciated (depreciated) in value by \$85,508 and \$(85,770), respectively.

Note 6 – Fair Value Measurements

The Plan's investments are reported at fair value in accordance with the provisions of the accounting standard in effect, "Fair Value Measurements" with respect to fair value measurements of financial assets and liabilities. The Standard establishes a framework for measuring fair value by creating a hierarchy for observable independent market inputs and unobservable market assumptions and expands disclosures about fair value measurements. Considerable judgment may be required in interpreting market data used to develop the estimates of fair value. Accordingly, the estimates presented herein are not necessarily indicative of the amounts that could be realized in a current market exchange. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value.

The three levels of fair value hierarchy under the Standard, and its applicability to the Plan's portfolio investments, are described below:

Level 1 – Unadjusted quoted market prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 – Quoted prices for similar assets or liabilities, or inputs that are observable, either directly or indirectly, for substantially the full term through corroboration with observable market data. Level 2 includes investments valued at quoted prices adjusted for legal or contractual restrictions to the security.

Level 3 – Pricing inputs are unobservable for the asset or liability, that is, inputs that reflect the reporting entity's own assumption about the assumptions market participants would use in pricing the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and June 30, 2023.

Mutual Fund: The fund is a money sweep fund that is valued at cost and classified as Level 1.

Corporate Obligations: These securities generally do not trade on a daily basis and the pricing services prepare estimates of fair value measurements for these securities based on yields currently available on comparable securities of issuers with similar credit ratings. These investments are classified as Level 1.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Management has evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the six months ended December 31, 2023 and year ended June 30, 2023, there were no transfers in or out of levels 1 or 2.

Note 7 – Tax Status and Uncertain Tax Positions

The Internal Revenue Service has ruled that the Plan qualifies under Section 501(c)(9) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Trustees of the Plan are not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan's management has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

Note 8 – Risks and Uncertainties

The present value of benefit obligations is reported based on certain assumptions which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 9 – Concentrations

Cash

The Plan maintains cash balances at one financial institution. The Federal Deposit Insurance Corporation insures accounts up to \$250,000. Cash balances have been transferred with the merger.

COVID-19

In early 2020, an outbreak of the novel strain of coronavirus (COVID-19) emerged globally. As a result, there have been mandates from federal, state and local authorities resulting in an overall decline in economic activity. The ultimate impact of COVID-19 on the financial performance of the Plan is not reasonably estimable at this time.

Note 10 – Plan Amendments

During the six months ended December 31, 2023 and year ended June 30, 2023, there were amendments to the Plan in regards to benefits and eligibility. Participants should refer to the Plan document or Summary of Material Modifications for a more complete description of the Plan's amendments.

Note 11 – Merger Detail

The Trustees of the Plan have approved a merger of the Plan with UNITE HERE HEALTH as of December 31, 2023 after determining that a merger would be in the best interest of the Plan's participants and beneficiaries for reasons including, but not limited to, economies of scale in the administration and operation of the merged Plan, the creation of a larger and more stable participant base with improved funding overall and reduced funding volatility, improved prospects for future growth, greater market power in negotiating favorable arrangements with service providers, and improved portability of benefits for its participants.
