We are bankruptcy counsel to ODI Oldco, Inc. f/k/a/ Oberweis Dairy, Inc., the plan administrator (the “**Plan Administrator**”) of the above-referenced employee benefit plan (the “**Benefit Plan**”). On April 12, 2024, the Plan Administrator and several of its affiliates filed Chapter 11 bankruptcy cases which remain pending in the Northern District of Illinois, jointly administered under lead Case No. 24-05385 (the “**Bankruptcy Cases**”).

We are in the process of retaining an auditor to audit the Oberweis Dairy, Inc. 401(k) Profit Sharing Plan. However, due to delays imposed by the pendency of the Bankruptcy Cases, including challenges in retaining and obtaining Bankruptcy Court approval of a qualified auditor in accordance with the dictates of the U.S. Bankruptcy Code, the Plan Administrator has been unable to complete an audit at this time.
