Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Reif Oil Co., Inc. 401(K) Profit Sharing Plan and Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the year then ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter-Basis of Accounting

As discussed in Note 6 to the financial statements, the governing body of Reif Oil Co., Inc., the Plan's sponsor, approved a plan of liquidation on October 12, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2023 and 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Note 1. Description of Plan

The following description of the Reif Oil Co., Inc. 401(K) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Reif Oil Co., Inc. (Company). Employees are eligible to contribute and receive Company matching contributions when they have completed one year of service with 1,000 hours and are age twenty and a half or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum percentage allowable under the Internal Revenue Code not to exceed 15% of their total plan year compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company will make a matching contribution equal to 50% of participants' deferrals up to 6%, for a maximum matching contribution equal to 3% of participants' wages. The Company may also make discretionary profit sharing contributions, as determined by its Board of Directors, to all participants who have satisfied the eligibility requirements. Discretionary contributions are subject to certain limitations. During the year ended December 31, 2023, no discretionary contributions were made. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows each participant to choose his or her own investment mix for Company and participant contributions. Participants can change their investment elections at any time.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant can elect when to receive a lump-sum distribution amount equal to the value of the participant's vested interest in his/her account. However, if the value of the participant's vested benefit is less than \$1,000, a lump-sum distribution will be made within a reasonable time after a participant terminates employment regardless of whether or not he or she elects to receive it.

Note 1. Description of Plan (continued)

Forfeited Accounts

As of December 31, 2023 and 2022, forfeited nonvested accounts were zero and \$1,773, respectively. These accounts may allocated as an additional discretionary matching contribution. During the year ended December 31, 2023 and 2022, forfeitures of \$458 and zero, respectively, were reallocated to participants as an additional discretionary matching contribution.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the Empower Annuity Insurance Company Guarantee Portfolio Fund which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction. See Note 5 for discussion on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable for contributions in excess of amounts allowed by the IRS are reported as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant recordkeeping and investment advisory are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan Administrator performed an evaluation of subsequent events through October 11, 2024, which is the date the financial statements were available to be issued. There are no subsequent events that would require disclosure or recognition in the financial statements as of December 31, 2023.

Note 3. Information Prepared and Certified by Insurance Company

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, as follows, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower.

Note 4. Investment Contract with Insurance Company

The Plan maintains an investment contract with Empower. The Empower Annuity Contract has the two components: (1) a segregated investment account maintained by Empower with respect to a portion of its assets in connection with this contract and certain other group annuity contracts, and (2) a traditional fully benefit-responsive guaranteed investment contract with Empower where Empower maintains the contributions in its general account.

Assets of this variable account equivalent to the reserve for this contract will be invested in shares of the specific funds elected in the contract application. The assets of the variable account will be held for the sole benefit of all contracts. All income, gains, losses, and expenses, whether or not realized from assets held in the variable account for each series, shall be credited to or charged against the variable account series without regard to the other income, gains, or losses of Empower. Assets of the variable account may not be used by Empower to satisfy the liabilities of its general account.

The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligation under the contract, (2) a material misrepresentation, (3) a material amendment to the agreement without the consent of the issuer.

Note 5. Fair Value Measurements

Financial Accounting Standards Board's Accounting Standards Codification (Professional Standards) establishes a framework for measuring fair value.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: The values are based on the net asset value (NAV) of the fund, where the unit value is the result of the accumulated fair values of the underlying investments. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the NAV. Participant transactions (purchases and sales) may occur daily.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2023 and 2022, the Plan did not have any unfunded commitments with any of the pooled separate accounts. The pooled separate accounts' redemption frequency is daily without any redemption notice period.

Note 6. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

Management of Reif Oil Co., Inc., the Plan sponsor, elected to terminate the Plan and liquidate all funds effective by December 31, 2022. Final distributions will be determined based on all participants being 100% vested, and will be made as soon as possible after the October 12, 2022 termination date. In accordance with generally accepted accounting principles, the Plan has changed its basis of accounting used to value Plan assets from the ongoing basis to the liquidation basis for periods after December 31, 2021.

As of December 31, 2023, the plan sponsor had not made all of the required corrective contributions to the plan. Those amounts are shown in the financial statements as a receivable to the plan and a payable to plan participants. The Plan can file the final form 5500 once the corrective contributions are contributed to the Plan and funds are distributed to participants.

Note 7. Tax Status and Plan Amendments

The Plan had a nonstandardized defined contribution prototype plan sponsored by Empower Trust Company, LLC. The prototype plan has received a letter from the Internal Revenue Service as to its qualified status. The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Professional Standards require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan has open tax years for the three years prior to December 31, 2023.

Note 8. Risks and Uncertainties

The Plan invests in various pooled separate accounts, which are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain pooled separate accounts, it is at least reasonably possible that changes in the values of the pooled separate accounts will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 9. Related Party Transactions and Parties-In-Interest

For the years ended December 31, 2023 and 2022, the Plan investments include units in pooled separate accounts managed by Empower and guaranteed portfolio fund of Empower. Empower is the custodian as defined by the plan as of December 31, 2023 and 2022, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for participant recordkeeping services qualify as party-in-interest transactions and amounted to \$7,814 and \$100 for the years ended December 31, 2023 and 2022, respectively.

Fees totaling \$1,881 and \$2,312 were expensed by the Plan during the years ended December 31, 2023 and 2022, respectively, to Advised Assets Group, LLC (an affiliate of Empower) for investment advisory services.
