### (1) Description of the Plan

The following brief description of the *Republic Services, Inc. Comprehensive Plan* (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

The Plan, a defined contribution plan, became effective September 1, 1989. The Plan covered certain union employees of Allied Waste Industries, Inc. (the “Company”), a wholly-owned subsidiary of Republic Services, Inc. (“Republic”). Overall responsibility for administering the Plan rested with the Company, which was responsible for the general administration of the Plan including compliance with reporting and disclosure requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan agreement was amended and restated effective January 1, 2015, and had been amended since that date.

On August 22, 2023, the Employee Benefits Committee authorized the Merger of the Plan into the Republic Services, Inc. 401(k) Plan (the “401(k) Plan”), a retirement plan sponsored by the Company, effective December 31, 2023. Plan assets totaling approximately \$4,551,000 were transferred to the 401(k) Plan on December 28, 2023. The 401(k) Plan was amended effective January 1, 2024 to incorporate the Plan’s existing vesting and participation provisions as a result of the merger.

- A. **Eligibility** - Full-time employees covered by a collective bargaining agreement with the Company were eligible to participate as provided in that agreement.
- B. **Contributions** - This Plan was funded solely from employer contributions with the exception of participants’ rollover contributions from other plans. The employer contribution was a percentage of a participant’s compensation that the Company had agreed to contribute under the collective bargaining agreement. Employer contributions were funded subsequent to year end for all eligible participants employed on the last day of the plan year. The prior contribution percentage was six percent according to the union contract. As of January 1, 2017, there were no employer contributions required for this Plan under collective bargaining agreements.
- C. **Participant accounts** - Each participant’s account was credited with (a) the Company’s contributions, if any, and (b) an allocation of plan earnings. Allocations of plan earnings were based on participant account balances. The benefit to which a participant is entitled was the participant’s vested account balance.
- D. **Vesting** - Participants were immediately vested in their rollover contributions plus actual earnings thereon. Vesting under the Plan was based on whole years of employment service with the Company. In the event of termination of employment for reasons other than death, retirement, or disability, a participant became vested in the Company contributions portion of their account plus earnings based on the following schedule:

**(1) Description of the Plan (continued)**

- E. Forfeitures** - In the event employees terminated their employment with the Company before becoming 100 percent vested, their participant account would be forfeited. At the election of the Employee Benefits Committee, forfeitures were available to reduce Plan expenses or the amount of future employer contributions to the Plan. At December 28, 2023 and December 31, 2022, there were \$0 and \$2 of forfeited non-vested accounts, respectively. \$8,930 of forfeited non-vested accounts were used to reduce Plan expenses during the 2023 Plan year.
- F. Investment options** - Participants could direct their rollover contributions and the Company's contributions into various investment choices provided by the Plan. Additionally, participants could transfer funds between investments.
- G. Benefits** - The Plan provided for the payment of benefits equal to the vested balance in a participant's account upon one of the following:
- a. Normal retirement at age 65 or older
  - b. Retirement due to permanent disability
  - c. Death of participant
  - d. Termination of employment

Participants entitled to a benefit payment for any of the reasons above with a balance less than \$5,000 were distributed as soon as administratively feasible without election or consent. Benefits were payable in a lump-sum distribution as soon as administratively feasible.

- H. Administrative expenses** - Certain administrative and transactional fees were deducted from participants' accounts, and the Company paid any fees that were not deducted from participants.

**(2) Significant accounting policies**

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual method of accounting. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

**Management's use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures of contingent items in these financial statements. Actual results could have differed from those estimates.

**Payments of benefits** - Benefits were recorded when paid.

**Risks and uncertainties** - The Plan's exposure to loss in the event of nonperformance of investments was limited to the carrying value of such instruments. The Plan's provisions as well as those of ERISA dictated the Plan's concentrations of credit risk and market risk. Due to the level of credit risk, interest rate risk and market risk associated with certain investment securities and the level of uncertainty related to changes in the value of these investments, it was at least reasonably possible that changes in risks in the near term could have materially affected participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### (2) Significant accounting policies (continued)

**Investment valuation and income recognition** - The investments of the Plan were reported at fair value. Following is a description of the valuation methodologies used for the investments held by the Plan at December 31, 2022. There were no fair value measurements as of December 28, 2023 and there were no changes in the methodologies used at December 31, 2022.

- Mutual funds - Stated at net asset values, which were readily determinable fair values of those shares as they were published daily and are the basis for current transactions.
- Common collective trusts ("CCTs") - CCTs were valued based upon the quoted redemption value of units, or the equivalent of net asset value, which was a practical expedient for estimating fair value. These investments had no unfunded commitments as of December 31, 2022 and could be redeemed daily with no redemption notice period or other redemption restrictions.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2023 through December 28, 2023.

**Fair value measurement** - The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. If a Level 1 input is available, it must be used.
- Level 2: Inputs other than quoted prices that are observable for securities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means.
- Level 3: Unobservable inputs, which contain assumptions by the party valuing those assets. For Level 3 inputs, there is no market data or correlations with market assumptions. Examples would include limited partnership interests, closely held stock, etc.

The asset's or liability's fair value measurement level within the fair value hierarchy were based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used needed to maximize the use of observable inputs and minimized the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

**Subsequent events** - The Plan's management has evaluated subsequent events through October 9, 2024, which is the date the financial statements were available to be issued.

**(3) Investments**

**(4) Tax status**

The Plan received a favorable determination letter from the Internal Revenue Service ("IRS") dated August 21, 2015, covering all amendments through January 30, 2015, stating that the Plan was qualified under applicable sections of the Internal Revenue Code ("IRC") and therefore, the related trust was exempt from taxation. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statements date. Accordingly, no provision for income taxes has been included in the financial statements.

**(5) Information certified by the Plan Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, the trustee of the Plan's assets, has certified that the following information included in the accompanying financial statements is complete and accurate:

- Investments, as of December 31, 2022
- Interest and dividend income
- Net appreciation in fair value of investments
- Other income

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**(6) Party-in-interest transactions**

Certain Plan investments were managed by Vanguard Fiduciary Trust Company, the Plan's trustee, as defined by the Plan. Therefore, transactions with the trustee qualified as party-in-interest transactions. Total administrative fees and expenses paid by the Plan to parties-in-interest for the 2023 Plan year totaled \$16,237 related to investment management and record keeping services. A portion of the administration fees and expenses were absorbed by the Plan sponsor.
