### (1) Description of the Plan

The following brief description of the *Republic Services, Inc. Employee Savings Plan* (the "Plan"), formerly the Republic Services, Inc. Union 401(k) Plan, is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

The Plan was originally established effective January 1, 1999. The Plan is a defined contribution plan covering eligible employees of Republic Services, Inc. ("Republic") and its subsidiaries (collectively, the "Company"). Overall responsibility for administering the Plan rested with the Company, which was responsible for the general administration of the Plan including compliance with reporting and disclosure requirements of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan agreement was amended and restated effective January 1, 2015, and has been amended since that date.

On August 22, 2023, the Employee Benefits Committee authorized the Merger of the Plan into the Republic Services, Inc. 401(k) Plan (the "401(k) Plan"), a retirement plan sponsored by the Company. Plan assets totaling approximately \$18,552,000 were transferred to the 401(k) Plan on December 28, 2023. The 401(k) Plan was amended effective January 1, 2024 to incorporate the Plan's existing vesting and participation provisions as a result of the merger.

- A. Eligibility** - The Plan covered all active and future eligible employees represented by a collective bargaining agreement providing for their participation in the Plan that had attained the age of 18. Employees excluded from the Plan were those employees not represented by a collective bargaining agreement that required participation in the Plan, those employees residing in Puerto Rico, those employees performing services as an independent contractor or consultant, and leased employees.
- B. Contributions** - On a pre-tax basis only, participants could contribute a percentage or dollar amount of their annual compensation to the Plan, subject to certain limitations as prescribed by the Plan and the Internal Revenue Code ("IRC"). Participants could also roll over amounts representing distributions from other qualified plans. Although the Plan did not require an employer matching contribution, certain collective bargaining agreements required the Company to make matching contributions, quarterly contributions, or an annual contribution to the Plan, which are reflected as an employer contribution in the statement of changes in net assets available for benefits.
- C. Participant accounts** - Each participant's account was credited with (a) the participant's contributions, (b) the Company's contributions, and (c) allocations of plan earnings. Allocations of net Plan earnings were based on participant's account balances. The benefit to which a participant was entitled was the participant's vested account balance.

Prior to the merger, during the period from January 1, 2023 through December 28, 2023, certain employees represented by a collective bargaining agreement that were previously participating in the Republic Services, Inc. 401(k) Plan became eligible to participate in the Republic Services, Inc. Employee Savings Plan. As a result, assets totaling approximately \$93,000 were transferred from the Republic Services, Inc. 401(k) Plan to the Republic Services, Inc. Employee Savings Plan.

- D. Vesting** - Participants were immediately vested in their (a) voluntary and rollover contributions plus actual earnings thereon and (b) in the Company's contributions upon attaining normal retirement age or becoming disabled or dying.

### (1) Description of the Plan (continued)

Effective April 21, 2011, participants that were eligible prior to April 12, 2010 became fully vested in the Company's contributions as of that date. Participants that became eligible after April 12, 2010 became fully vested in the Company's contributions on the following schedule of years of service:

<u>Years of Service for Vesting</u>	<u>Percentage</u>
Less than 1 year	0%
Less than 2 years	20%
Less than 3 years	40%
Less than 4 years	60%
Less than 5 years	80%
5 or more years	100%

However, if the collective bargaining agreement provided for a different vesting schedule, the vesting schedule in the collective bargaining agreement applied.

- E. Forfeitures** - In the event employees terminated their employment with the Company before becoming 100 percent vested, their non-vested employer contribution account was forfeited. Generally, forfeitures were available to pay Plan expenses or reduce future employer matching contributions. At December 28, 2023 and December 31, 2022, forfeited non-vested accounts totaled approximately \$0 and \$90,000, respectively. Forfeited non-vested accounts totaling approximately \$38,000 were used to pay Plan expenses during the 2023 Plan year.
- F. Investment options** - Participants could direct their rollover contributions and the Company's contributions into various investment choices provided by the Plan. Additionally, participants could transfer funds between investments.
- G. Notes receivable from participants** - Participants could borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, subject to certain restrictions as defined in the Plan document. Loan distributions were not subject to tax provided they were repaid as agreed. The terms of the loans were comparable to those the participants could receive at an unaffiliated lending institution. All loan maturities were five years or less unless specifically permitted as described in the Plan document.
- H. Benefits** - The Plan provided for the payment of benefits as soon as administratively feasible in amounts up to the entire vested balance in a participant's account upon one of the following:
- Termination of employment
  - Death or disability of participant
  - Attainment of age 59½
  - Demonstrated hardship
  - Qualified domestic relations order

Participants entitled to a benefit payment for any of the reasons above with a balance less than \$5,000 were distributed as soon as administratively feasible without election or consent. Benefits were payable in a lump-sum distribution as soon as administratively feasible.

- I. Administrative expenses** - Certain administrative and transactional fees were deducted from participants' accounts, and the Company paid any fees that were not deducted from participants.

### (2) Summary of significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual basis of accounting. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

**Management's use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets and the reported amounts of additions to and deductions from net assets. Actual results could differ from those estimates.

**Payments of benefits** - Benefits are recorded in the period in which they are paid.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest.

**Risks and uncertainties** - The Plan's exposure to loss in the event of nonperformance of investments was limited to the carrying value of such instruments. The Plan's provisions as well as those of ERISA dictated the Plan's concentrations of credit risk and market risk. Due to the level of credit risk, interest rate risk and market risk associated with certain investment securities and the level of uncertainty related to changes in the value of these investments, it was at least reasonably possible that changes in risks in the near term could have materially affected participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Investment valuation and income recognition** - The investments of the Plan were reported at fair value. Following is a description of the valuation methodologies used for the investments held by the Plan at December 31, 2022. There were no fair value measurements as of December 28, 2023 and there have been no changes in the methodologies used at December 31, 2022.

- Mutual funds - Stated at net asset values, which were readily determinable fair values of those shares as they were published daily and are the basis for current transactions.
- Common collective trusts ("CCTs") - CCTs were valued based upon the quoted redemption value of units, or the equivalent of net asset value, which was a practical expedient for estimating fair value. These investments had no unfunded commitments as of December 31, 2022 and could be redeemed daily with no redemption notice period or other redemption restrictions.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2023 through December 28, 2023.

**Fair value measurement** - The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. If a Level 1 input is available, it must be used.
- Level 2: Inputs other than quoted prices that are observable for securities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means.
- Level 3: Unobservable inputs, which contain assumptions by the party valuing those assets. For Level 3 inputs, there is no market data or correlations with market assumptions. Examples would include limited partnership interests, closely held stock, etc.

The asset's or liability's fair value measurement level within the fair value hierarchy were based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used needed to maximize the use of observable inputs and minimized the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

**Subsequent events** - Plan management has evaluated subsequent events through October 9, 2024, which is the date the financial statements were available to be issued.

### (3) Investments

There were no investments held by the Plan as of December 28, 2023. The following summarizes by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022:

### (4) Income tax status

The Plan received a favorable determination letter from the Internal Revenue Service ("IRS") dated November 17, 2015, covering all amendments through January 30, 2015, stating that the Plan was qualified under applicable sections of the IRC and therefore, the related trust was exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

### (5) Information certified by the Plan trustee

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, the trustee of the Plan's assets, has certified that the following information included in the accompanying financial statements is complete and accurate:

- Investments, as of December 31, 2022
- Notes receivable from participants, as of December 31, 2022
- Other income
- Interest and dividends
- Interest income on notes receivable from participants
- Net appreciation in fair value of investments

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

### (6) Party-in-interest transactions

Certain Plan investments are managed by Vanguard Fiduciary Trust Company, the Plan's trustee, as defined by the Plan. Therefore, transactions with the trustee qualify as party-in-interest transactions. Fees paid to parties-in-interest were approximately \$48,000 for the 2023 Plan year.
